1. DESCRIPTION OF PLAN

The following description of the Taylor Made 401(K) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Taylor Made Sales Agency, Inc. (the Company) for the benefit of substantially all employees of the Company and a related entity, Taylor Made Stallions, Inc., excluding union employees, nonresident aliens, leased employees, and any part-time, temporary, or seasonal employee who works less than 1,000 hours within a year. The Plan was established July 1, 1981 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Eligible employees, as defined in the Plan document, who have reached the age of 18 are able to make elective deferrals or receive safe harbor matching and non-elective contributions after completing one year of eligible service. Employees can elect to defer earnings on the first day of the pay period coinciding with, or following, the attainment of the eligibility requirements of the Plan.

Contributions

Employees may make annual Roth and pre-tax deferral contributions up to the maximum annual deferral amount defined by the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan provides for contributions to be invested at the participant's direction in various investment options offered by the Plan.

The Company will contribute safe harbor matching contributions for eligible employees each pay period in an amount not to exceed 4% of participant compensation. In addition, the Company may make non-elective contributions, however, no such contributions were made for the year ended December 31, 2024.

During 2024, there were two pay dates for which the deferrals of one participant were not remitted within the timeframe required by the Department of Labor. Subsequent to year end, the Company remitted the contributions and related lost earnings to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's contributions, as well as allocations of plan earnings or losses. Allocations are based on participant earnings or account balances, as defined. Administrative expenses are charged to each participant's account when a benefit distribution is provided. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and the Company's safe harbor matching contributions, plus actual earnings thereon. Vesting in the Company's non-elective contributions is based on years of continuous service. Using a graduated scale, a participant begins vesting at year two, and is 100% vested after six years of credited service. Participants are 100% vested in their entire account balances upon attainment of normal retirement age (as defined), disability, or death.

Notes Receivable from Participants

The Plan does not allow participants to borrow from their fund accounts.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested account, or, if permitted under the Plan at the time of distribution, an alternative form of payment. Upon termination of service for other reasons, a participant may elect to receive a lump-sum amount equal to the value of participant's vested account. In-service distributions are allowed for vested employer contributions for participants who are at least 55 years of age or have 20 years of service, and are allowed for all contributions once a participant reaches age 59-1/2. As defined in the Plan documents, certain participants are also eligible for hardship distributions, consistent with the provisions of the Internal Revenue Code.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$0 and \$4,583, respectively. The accounts may be used to reduce future Company contributions or pay administrative expenses. In 2024, \$11,915 of forfeited non-vested accounts were used to pay plan expenses.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Changes in fair value of investments are reflected in the statement of changes in net assets available for benefits in the year in which such changes occur. Changes in fair value of investments include the Plan's gains and losses on investments bought and sold as well as held during the year. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments.

Subsequent Events

Plan management has evaluated events or transactions occurring subsequent to the statement of net assets available for benefits date for recognition and disclosure in the accompanying financial statements through the date the financial statements were available to be issued, which is October 13, 2025.

3. INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya Retirement Insurance and Annuity Company (VRIAC), the custodian of the Plan, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and investment-related activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Group annuity contract: The fair value of the insurance contract is determined by the insurance company, which is a third party, using proprietary pricing models for which the underlying inputs are not provided to the Plan administrator. The Plan administrator does not make any adjustments to the value. The insurance company has determined the fair value of the insurance contract approximates the contract value of such contract.
