Statement of Reasonable Cause for Omission of Independent Auditor's Opinion

The purpose of this document is to explain why no Auditor's Opinion (as described in Part III of Schedule H) is attached to this Form 5500 Return. The experience of my ERISA counsel has been that the Office of the Chief Accountant does not take enforcement action for the absence of an attached Auditor's Opinion under certain limited circumstances which he believes are present here. Immediately below are our facts.

1. The bankruptcy application of the employer sponsoring this plan was accepted by the United States Bankruptcy Court Southern District of Texas (Case No. 25-90456-CML) and I, Steve Narsutis am the appointed plan administrator. The effect is that the employer has dissolved and I am the responsible party to the plan.
2. The plan assets are held by Reliance Trust Company. My ERISA counsel has reviewed the transaction histories and other financial information and represents to me they appear to be in good order. That said, neither of us have personal knowledge of any plan related transactions.
3. I do not have reasonable access to the data that the independent auditor would require in order to do their work.
4. The process of terminating this plan and distributing the assets to participants will commence as soon as administratively practical.

For these reasons, I respectfully submit that reasonable cause exists for a determination that no independent auditor's opinion need be attached to the Form 5500 filed in connection with this plan.
