### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of MOCAP LLC Retirement Savings Plan, (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

**Note 1. Description of the Plan**

***General***

The following description of the MOCAP LLC Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

The Plan is a defined contribution plan sponsored by MOCAP LLC (the “Employer”) for the benefit of its employees who have at least 90 days of service. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (“ERISA”). Charles Schwab Trust Bank serves as Plan custodian (the “Custodian”).

***Contributions***

The Plan permits eligible employees through a salary deferral election to have the Employer make annual contributions of up to 100% of their eligible compensation. Employee rollover and Roth contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Employer may make discretionary matching contributions for participants, as determined by the Board of Directors. During 2024 and 2023, the employer matched 100% of the first 3%, and 50% of the next 3%, of employees’ salary deferrals. Contributions are subject to certain limitations.

The Plan Document also includes an automatic deferral feature whereby a participant is treated as electing to defer 6% of eligible compensation unless the participant made an affirmative election otherwise.

***Participant Investment Account Options***

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

***Participant Accounts***

Each participant’s account is credited with the participant’s contribution, the Employer’s contribution and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Employer’s contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested after five years of continuous service. The non-vested balance is forfeited upon distribution of the participant’s account subsequent to termination of service. Forfeitures are used to reduce administrative expenses or Employer contributions, at the discretion of the Employer.

***Payment of Benefits***

Upon termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the vested interest in their account.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$5,935 and \$0, respectively. Forfeited accounts are used to reduce future employer contributions or fees, at the discretion of the Plan Administrator. In 2024 and 2023, employer fees were reduced by \$12,587 and \$0, respectively, from forfeited nonvested accounts.

***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at 1% above the prime rate, as defined. Principal and interest is paid ratably through monthly payroll deductions.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end. The Plan's interests in the common collective trust funds are valued daily utilizing the values of the underlying assets.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded as declared by each fund. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

***Contributions***

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Employer or the Plan, at the Employer's discretion.

**Note 3. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is hierarchy of three levels of inputs that may be used to measure fair value:

**Level 1** Quoted prices in active markets for identical assets

**Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets

If quoted market prices are not available, then fair values are estimated by using quoted prices of investments with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market – based or independently sourced market parameters, including, but not limited to yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such investments are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, investments are classified within Level 3 of the hierarchy. The Plan has no Level 3 investments.

**Note 4. Certification of Plan Custodian**

The Plan incurs expenses related to general administration and record keeping. The Employer pays certain of these expenses and accounting and auditing fees relating to the Plan.

**Note 6. Plan Termination**

Although it has not expressed an intention to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Note 7. Tax Status**

The Plan operates under a standardized adoption agreement in connection with a prototype 401(k) profit-sharing plan and trust/custodial document sponsored by Retirement Plan Services, L.L.C. This prototype Plan Document has been filed with the appropriate agency and has obtained a determination letter from the Internal Revenue Service on June 30, 2020, stating that the prototype constitutes a qualified plan under Section 401 of the Internal Revenue Code. The Plan has been amended since the prototype received the determination letter. However, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 9. Subsequent Events**

Subsequent events have been evaluated through September 30, 2025, which is the date the financial statements were available to be issued.
