## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Cairn University 403(b) Plan an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ### (1) DESCRIPTION OF PLAN

The following description of the Cairn University 403(b) Plan (the “*Plan*”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### A. General

The Plan is a defined contribution plan covering employees of Cairn University (the “*University*”). The Plan was adopted October 19, 1987. The effective date of the most recent amendment or restatement is April 1, 2016. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (*ERISA*). All regular employees working at least 20 hours per week are eligible to participate, and must elect participation in the plan.

#### B. Contributions

Each year, participants may contribute up to \$23,000 of pretax annual compensation, as defined in the plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions, up to \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the plan. Upon completion of three months of employment, the University provided a contribution match of up to 3% for all employees over 21 years of age and who have elected to participate in the plan. Effective February 1, 2022, the Plan was amended to remove the requirement to complete three months of employment to be eligible for the University contribution match.

#### C. Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the company’s contribution and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### D. Vesting

Participants are vested immediately in their voluntary contributions; the University’s matching contributions, and actual earnings thereon.

#### E. Participant Loans

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or up to ten years for the purchase of a primary residence. Loans are secured by the vested balance in the participant’s account and accrue interest at a rate equivalent to interest rates charged on similar commercial loans by persons or institutions in the business of lending money in the same geographic area of the University. During the year ended December 31, 2024, interest rates ranged from 3.25% to 8.50% and interest is paid ratably through payroll deductions. In the event of retirement, death, disability or termination of employment, the loan becomes payable in full. The amount outstanding as of December 31, 2024 and 2023, was \$25,791 and \$17,899, respectively.

#### F. Investment Options

Upon enrollment in the Plan, a participant may direct all future employee and employer contributions into any of the investment options available under the Plan.

### **G. Payment of Benefits**

A participant's vested benefits will normally be distributed to the participant or the participant's beneficiary upon termination of service, retirement, disability or death of the participant, by transfer to another qualified plan or individual retirement account, through a lump-sum distribution or installment payments.

In-service withdrawals of all or a portion of a participant's vested account balance may be made by participants who have attained the age of 59-1/2. Hardship withdrawals from a participant's deferral contribution accounts are not permitted. In-service withdrawals of all or a portion of a participant's rollover account balance may be withdrawn at any time.

### **H. Administration**

The University is the administrator of the Plan. TIAA-CREF and The Standard have been designated as the record keepers for the Plan. For investment recordkeeping maintained by TIAA-CREF, they act as a directed trustee and custodian. For investment recordkeeping maintained by The Standard, Charles Schwab Bank, acts as the directed trustee and custodian. TIAA-CREF and The Standard maintain individual participant account records and advise the Plan on other matters related to the operation of the Plan. Administrative expenses of the Plan are primarily paid by the Plan sponsor.

## **(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### ***BASIS OF ACCOUNTING***

The financial statements of the Plan are prepared under the accrual basis of accounting.

Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. The Standard Stable Asset Fund and TIAA Traditional Benefit Responsive Contract are considered fully benefit responsive, and are presented at contract value as of December 31, 2024 and 2023.

### ***INVESTMENT VALUATION AND INCOME RECOGNITION***

The Plan's investments other than fully benefit-responsive investment contracts are stated at fair value. Fully benefit-responsive investment contracts are stated at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***PAYMENT OF BENEFITS***

Benefits are recorded when paid.

### **USE OF ESTIMATES**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

### **OPERATING EXPENSES**

All expenses of maintaining the plan are paid using funds invested in the plan.

### **(3) INVESTMENTS**

The Plan's investments are held in a directed trust. There are several investment options available to the participants at the time of this report. Participant accounts are allocated based on the decisions of the individual participants. The following tables present the fair value and contract value of these investments which have been certified by the Plan's custodian and trustee.

The Plan utilized various methods to measure the fair value of its investments on a recurring basis. Generally accepted accounting principles establish a hierarchy that prioritizes inputs to valuation methods. The three levels of inputs are described below:

- Level 1 – Unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access, including securities actively-traded on a securities exchange.
- Level 2 – Observable inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly or indirectly. These inputs may include quoted prices for the identical instrument on an inactive market, prices for similar instruments, interest rates, prepayment speeds, credit risk, yield curves, default rates and similar data.
- Level 3 – Unobservable inputs for the asset or liability, to the extent relevant observable inputs are not available, representing the Plan's own assumptions about the assumptions a market participant would use in valuing the asset or liability, and would be based on the best information available.

The inputs methodology used for valuing securities are not necessarily an indication of the risk associated with investing in those securities.

### (4) TIAA TRADITIONAL ANNUITY

The plan offers guaranteed annuity contracts with Teachers Insurance Annuity Association (“TIAA”), an insurance company. TIAA maintains the contributions in a general account. The Traditional Annuity is offered through two contract types; Retirement Annuities (“RA”) and Supplemental Retirement Annuities (“SRA”). The type of contract through which a participant invests in the TIAA Traditional Annuity determines the applicability of certain account features, such as the guaranteed minimum interest rate, additional interest declarations, the degree of liquidity of the participant’s account, and the options for receiving income upon retirement. The RA contract does not allow lump-sum cash withdrawals, and transfers must be spread over 10 annual installments. The SRA contracts provide for full participant-directed liquidity and are considered fully benefit-responsive. The contracts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed annuity contract issuer is obligated to repay the principal and a specified interest rate that is guaranteed to the plan. When a participant’s accumulation in an annuity contract is converted to a lifetime payment annuity, the present value of the stream of payments is equal to the accumulated balance, and the entire amount is recorded as a distribution in the statement of changes in net assets available for benefits.

The RA contracts are presented on the face of the statement of net assets available for benefits at contract value, which approximates fair value. The SRA Contracts are presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the plan by TIAA, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contracts at December 31, 2024 and 2023 was approximately \$73,000 and \$89,000, respectively, for the SRA contract. The fair value of the investment contracts at December 31, 2024 and 2023 was approximately \$3,238,000 and \$3,446,000, respectively, for the RA contract. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 3% percent. Such interest rates are reviewed periodically for resetting.

Certain events limit the ability of the plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the plan’s prohibition on competing investment options of deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the plan’s ability to transact at contract value with participants are probable of occurring.

The guaranteed investment contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

### (5) THE STANDARD'S STABLE ASSET FUND A

The plan offers guaranteed fixed annuity contracts with The Standard Insurance Company (*"The Standard"*), an insurance company. The Standard Fixed Accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses as allowed by the Plan. Plan management has determined that contract value approximates fair value. Contract value, as determined by The Standard, represents contributions made under the agreement, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment contract value. The Stable Asset Fund A is presented on the face of the statement of net assets available for benefits at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contracts at December 31, 2024 and 2023 was approximately \$1,169,000 and \$1,103,000, respectively, for the Stable Asset Fund A. The minimum guaranteed interest rate varies by participant and depends on the date the participant established their account. Such interest rates are reviewed periodically for resetting.

### (6) PLAN TERMINATION

Although it has not expressed any intent to do so, the University has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### (7) TAX STATUS

The trust, established under a prototype plan to hold the Plan's assets, is qualified pursuant to the appropriate section of the Internal Revenue Code, and, accordingly, the trust's net investment income is exempt from income taxes. Although the Plan has been amended, the Plan sponsor believes that the Plan continues to qualify and to operate as designed.

Management has reviewed the tax positions for each of its open tax years (2021 – 2023) or expected to be taken in the Plan's 2024 tax return and has concluded that there are no uncertain tax positions that would require recognition in the financial statements.

### (8) RISKS AND UNCERTAINTIES

The Plan invests in shares of registered investment companies which employ various investment strategies. The investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.


