NOTES TO FINANCIAL STATEMENTS

1. Plan Description

The following description of Walsh Trucking Co., Ltd. 401(k) Retirement Salary Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions. The Plan's most recent restatement was effective January 1, 2024.

General

The Plan is a defined-contribution plan formed on June 1, 1992, covering all full-time employees not represented by collective bargaining who are 18 years of age or older and have six months of service as defined in the Plan articles. Employees who qualify to become participants may enter the Plan at the beginning of each month after becoming eligible. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA) and all requirements of Sections 401(a) and 401(k) of the Internal Revenue Code (IRC). The Plan's Trustees oversee the governance of the Plan.

The Plan is a single-employer plan that includes a controlled group of corporations including Walsh Trucking, Co., Ltd.; Northwest Bark Supply Co., Ltd.; and Excel Transport, Inc. (the Companies).

Contributions

Each year, participants may contribute up to 100 percent of their eligible annual compensation on a pre-tax basis as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also make after-tax contributions subject to the annual limit of the sum of all contribution types (pre-tax, after-tax, employer contributions). Participants may also contribute amounts representing distributions from other qualified, defined-benefit or defined-contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Companies may make a discretionary matching contribution in accordance with Plan provisions. The Companies matched 30 percent of the salary reduction authorized by the participant up to a maximum of 1.2 percent of total eligible compensation for the years ended December 31, 2024 and 2023. Contributions are subject to certain limitations under the Internal Revenue Code.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Companies' contribution and (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Companies' contribution portion of their accounts is based on years of continuous service and is 20 percent per year. A participant is 100 percent vested after five years of credited service.

1. Plan Description, continued

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account and bear interest at a rate based upon the rates available for similar loans from commercial lending institutions. Loans range from one to five years, unless the loan is used to purchase a principal residence, in which case loan terms may go beyond five years. Principal and interest are paid ratably through weekly payroll deductions.

Payment of Benefits

Upon termination of service, death, disability, or retirement, a participant or their designated beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account, annual installments, or a life annuity. In-service distributions are permitted upon attainment of age 59½ in an amount not to exceed the participant's vested account balance.

The Plan also provides for hardship withdrawals in the event of an immediate and heavy financial need in an amount not to exceed the lesser of the participant's elective deferrals, excluding earnings, vested balance of the Companies match contribution, or the amount of the financial need.

Forfeited Accounts

The non-vested account of a participant shall be forfeited if a participant is terminated. Forfeited accounts are used to pay Plan expenses and future employer contributions. During the years ended December 31, 2024 and 2023, \$7,916 and \$4,682, respectively, were forfeited from participant accounts, which were used to reduce the Companies' contributions in the year forfeited. Ending forfeiture balances at December 31, 2024 and 2023 were \$486 and \$2, respectively.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments in pooled separate accounts, registered investment companies, and common/collective trusts are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants. The pooled separate accounts are valued at the quoted market prices of the underlying investments.

Investment Valuation and Income Recognition, continued

The value of the pooled separate accounts is expressed in “units.” Each separate account owns “units” in the pooled account and its value is determined by the prorated portion of units owned. See Note 8 for further discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. The net change in fair value of investments includes realized and unrealized gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative functions are performed by officers or employees of the Companies. No such officer or employee receives compensation from the Plan. Certain other administrative expenses are paid directly by the Companies, and therefore excluded from these financial statements, except for certain participant transaction fees paid by the Plan from assets in the participant’s account. Certain other administrative fees are paid from Plan assets and recorded when paid. Investment related expenses are included as a reduction of investment income. Fees for administration of notes receivable from participants are included in administrative expenses and charged directly to the participant’s account.

Recent Accounting Standard Adopted

On January 1, 2023, the Plan adopted Accounting Standards Update (ASU) 2016-13 Financial Instruments - Credit Losses (Topic 326): *Measurement of Credit Losses on Financial Instruments*, and all related amendments (ASC 326), which replaced the incurred loss methodology for recognizing credit losses with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. CECL requires an estimate of lifetime expected credit losses to be recognized for financial assets based on historical experience, current conditions, and reasonable and supportable forecasts, and for the financial assets to be presented at the net amount expected to be collected on the statements of net assets available for benefits. The financial assets held by the Plan that are subject to ASC 326 are employer contributions receivable and participant contributions receivable. There was no impact to the financial statements as a result of adopting this standard.

3. Information Prepared and Certified by Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the following information included in the accompanying financial statements and supplemental schedule was certified by Principal Life Insurance Company, the custodian of the Plan, as complete and accurate as of and for the years ended December 31:

4. Plan Termination

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of full or partial Plan termination, affected participants would become 100 percent vested in their Companies' contributions.

5. Tax Status

The Plan has been restated to adopt a standardized pre-approved profit-sharing plan with CODA. Principal Life Insurance Company, the sponsor of the prototype plan, has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the prototype plan was designed in accordance with applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

7. Related Party Transactions

Certain Plan investments are units of pooled separate accounts and common/collective trusts managed by Principal Life Insurance Company, the custodian of the Plan. Therefore, these transactions qualified as party-in-interest transactions. Fees paid to Principal Life Insurance Company amounted to \$20,884 and \$39,116 for 2024 and 2023, respectively.

8. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to its fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Recorded at fair value based on the stated net asset value (NAV) of the separate pooled account, which is used as a practical expedient to estimate fair value. Participant transactions may occur daily at NAV. Pursuant to Accounting Standards Update (ASU) 2015-07, *Fair Value Measurements*, the pooled separate accounts measured at NAV have not been classified in the fair value hierarchy. All pooled separate account investments held by the Plan have no unfunded commitments, and the investments may be redeemed by participants on a daily basis with no required notice period.

Registered investment companies: The Plan's investments are units of mutual funds held within a group annuity contract. These funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and considered to have a readily determinable fair value.

Common/collective trust: Units held in the common/collective trusts are valued using the NAV of the fund. The NAV is used as a practical expedient to estimate fair value and therefore common/collective trusts have not been classified in the fair value hierarchy. The NAV is based on the fair value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding. Participant transactions (purchases and sales) may occur daily at NAV. All common/collective trusts held by the Plan have no unfunded commitments, and the investments may be redeemed by the participants on a daily basis with no required notice period.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

9. Nonexempt Transactions

During the year ended December 31, 2024 there were no late remittances of participant contributions. During the year ended December 31, 2023 participant contributions totaling \$53,399 were not remitted to the Plan within the appropriate time period by the Companies. These transactions constitute prohibited transactions as defined by ERISA. The Companies are taking the appropriate steps to correct the situation in 2025 by reimbursing employees for lost earnings and interest.

10. Subsequent Events

Management evaluates events and transactions that occur after the statement of net assets available for benefits date as potential subsequent events. Management has performed this evaluation through the date of the independent auditor's report.
