### Note 1 - Plan Description

The following description of 403(b) Thrift Plan for Hospice of Northwest Ohio (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan adopted on January 1, 1999. Prior to 1999, Hospice of Northwest Ohio (the "Organization") offered a tax-deferred annuity (TDA) contract to eligible employees. The TDA was incorporated into the formation of the Plan on January 1, 1999. Currently, the TDA contract no longer accepts salary reduction contributions, rollovers, or transfers from other plans or contracts. The TDA contract is not available to any new participants who enrolled in the Plan subsequent to January 1, 1999. There is no minimum age or service requirement to participate in the Plan. Eligible employees can enroll in the Plan the first of the month following their hire date. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

The Plan provides for employee salary deferral contributions up to a maximum of 100 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. The Plan also allows participants to contribute up to 100 percent of their compensation on an after-tax basis. All employees of the Organization are eligible to participate in this portion of the Plan.

The Plan allows for a discretionary employer base contribution made on behalf of all eligible employees equal to a uniform percentage of participant compensation. Eligible employees consist of all employees of the Organization, with the exception of contingency staff employees. This contribution is made to all eligible employees whether or not they are participating in the Plan. There was no discretionary employer base contribution made in 2024 or 2023.

The Plan allows for an employer matching contribution for each plan year equal to 100 percent of salary contributions deferred during that plan year, not to exceed 3 percent of annual compensation. Eligible employees consist of all employees of the Organization, with the exception of contingency staff employees.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Organization's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### **Vesting**

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. Vesting in the Organization's contribution portion of their accounts, plus actual earnings thereon, is based on years of service. Participants are vested after three years of service.

#### **Forfeitures**

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future organization contributions or to pay administrative expenses of the Plan.

**Note 1 - Plan Description (Continued)**

***Plan Loans***

Participants may borrow from Mutual of America Life Insurance Company (the "Custodian") using the vested interest in their guaranteed interest account (Mutual of America Interest Accumulation Account) balances as collateral for the loan in an amount not to exceed 50 percent of their Mutual of America Interest Accumulation Account balances. Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their Mutual of America Interest Accumulation Account balances subject to annuity contract and plan provisions. Loan terms range from 1 to 5 years or up to 10 years for the purchase of the participant's primary residence. Loans bear interest at market rates. Principal and interest are paid ratably by the participant to Mutual of America Life Insurance Company, and each payment will reduce amounts collateralized by the participant's Mutual of America Interest Accumulation Account. The amount of these outstanding loans was \$0 and \$74,849 at December 31, 2024 and 2023, respectively. These loans are not included as assets in the accompanying financial statements. Effective January 1, 2024, plan loans were paid off and converted by issuing participant notes.

***Participant Notes Receivable***

Effective January 1, 2024, participants may borrow from their accounts subject to certain maximum and minimum amounts prescribed in the Plan and in the Internal Revenue Code. Notes receivable bear interest at a market rate.

***Payment of Benefits***

Distributions are payable upon retirement, death, disability, termination of employment, or attainment of 59½ years of age in the form of a lump-sum amount equal to the vested balance of a participant's account. Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document.

***Termination***

While it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Mutual of America Life Insurance Company or its affiliates. Mutual of America Life Insurance Company is the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation***

The Plan's investments are stated at fair value except as noted below. The fully benefit-responsive unallocated contract is valued at contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

The pooled separate accounts are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying net assets. There are no redemption restrictions or unfunded commitments on these investments. See Note 5 for additional information.

***Plan Expenses***

Various administrative costs are paid by the Organization.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest.

***Benefit Payments***

Benefits are recorded when paid.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain amounts and disclosures at the date of the financial statements and during the reporting period. Accordingly, actual results may differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including October 8, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Certified Information**

Mutual of America Life Insurance Company and Mid Atlantic Trust Company (collectively, the "Custodians") hold the Plan's investments and execute all related transactions. The investment balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Custodians.

**Note 4 - Investment Contracts**

The Plan has a benefit-responsive investment contract with Mutual of America Life Insurance Company (Mutual of America). Mutual of America maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a semiannual basis for resetting but may not be less than 1.5 percent. When establishing interest crediting rates for this product, Mutual of America considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account.

Generally, there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value paid over time. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.

There were no unfunded commitments or redemption restrictions on the investments described above.

**Note 6 - Tax Status**

The Plan, as adopted effective January 1, 2024, is a volume submitter plan, which does not require an application for a determination letter from the Internal Revenue Service (IRS). The Plan has not individually sought its own determination letter.

Previously the Plan used a prototype plan that had received a favorable opinion letter from the IRS indicating that the Plan, as designed, is qualified for federal income tax-exempt status.
