Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of Tarantino Properties Employee Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Tarantino Properties Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

NOTE 1 - DESCRIPTION OF PLAN

The following description of Tarantino Properties Employee Retirement Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all full-time employees of the Company who have six months of service and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The investment committee for the Plan Sponsor meets on a quarterly basis to review the appropriateness of the Plan's investment offerings, monitors investment performance, and initiates any changes in Plan investments.

Contributions: Participants may make an elective deferral, for each Plan year, in an amount equal to the maximum amount allowable not to exceed the limits of Code Sections 401(k), 404 and 415. In addition, participants over age 50 were allowed to contribute an additional \$7,500 for 2024. The Company will have the option of making a discretionary matching contribution to be determined by the Board of Directors each Plan year. For 2024, the Company matching contribution was equal to 33% of the first 6% of the participants' deferral election. The matching contribution for 2024 was \$186,699.

If a participant makes a contribution during any year in an amount which exceeds the maximum amount allowed under the Code pertaining to highly compensated employees, the contribution is refunded and the matching Company contribution on such additional participant contribution may be forfeited by the participant and applied to reduce the Company's matching contribution to the Plan for the following year.

Participant Accounts: Each Participant's account is credited with the Participant's contribution and an allocation of the Company's contribution and Plan earnings. Allocations are based on Participant earnings or account balances, as defined. The benefit to which a Participant is entitled is the benefit that can be provided from the Participant's vested account.

Investment Options: Upon enrollment in the Plan, the Participant is given a summary of the various investment options available under the Plan. The Participant then directs their contributions and any matching Employer contribution, to the various investments of their choosing. Changes in investments in the Participant's account are made directly by the Participant with American United Life Insurance Company, the Custodian of the Plan.

Participant Notes Receivable: Participants may borrow from their fund accounts an amount equal to the lesser of \$50,000 or 50% of their vested account balance with a minimum loan amount of \$1,000. The terms of the loans shall not exceed five years unless for the purchase of a primary residence. The loans are secured by the balance in the Participant's account and bear interest at a rate commensurate with rates charged by representative commercial banks, currently 6.25%. Principal and interest are paid ratably through monthly payroll deductions.

Vesting: Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. Vesting in the Company's matching and discretionary contributions portion of their accounts, plus earnings thereon is based on years of continuous service. A Participant is 100% vested after six years of credited service.

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

Payment of Benefits: On termination of service due to death, disability or retirement, a Participant may elect to receive an amount equal to the value of the Participant's vested interest in his or her account in a lump-sum amount, installments over a period of not more than the assumed life expectancy, or the purchase of a different form of annuity. For termination of service due to other reasons, a Participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeitures: Forfeitures are applied to reduce the Employer's contribution and Plan expenses for such Plan year. At December 31, 2024, the unapplied forfeitures were \$155,954. During 2024, unapplied forfeitures were used to reduce Plan expenses by \$18,028.

Administrative Expenses: Administrative expenses for the Plan for 2024 were \$22,170.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

Date of Management's Review: Subsequent events were evaluated through October 3, 2025, which is the date the financial statements were available to be issued.

Basis of Accounting: The financial statements of the plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Estimates: The preparation of the financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that effect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024, and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits: Benefits are recorded when paid.

NOTE 3 – FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Pooled Separate Accounts

These investments are valued at the net asset value (“NAV”) or equivalent based on units of the pooled separate accounts. The NAV, as provided by the Custodian, is used as a practical expedient to estimate fair value. The NAV is generally based on the fair value of the underlying investments held by the pooled separate account less its liabilities. This practical expedient is not used when it is determined to be probable that the pooled separate account will sell the investment for an amount different than the reported NAV.

Stable Value Fund

A stable value fund is a form of common collective trust fund which is composed primarily of fully benefit-responsive investment contracts and is valued at the NAV of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

NOTE 4 - INVESTMENTS CONTRACTS WITH INSURANCE COMPANY

The Plan's investments are held American United Life Insurance Company (AUL). Participant accounts are credited with employee contributions, employer matching contributions and actual earnings on the underlying investments and charged for Plan withdrawals and expenses. All Participant accounts are participant-directed as to both Employer and Employee contributions. AUL maintains the contributions in pooled separate accounts. The following information included in the accompanying financial statements and supplemental schedules was obtained from data that has been certified to as complete and accurate by AUL. The December 31, 2024 and 2023 Statements of Net Assets Available for Benefits, the investment activities included on the Statement of Changes in New Assets Available for Benefits for the year ended December 31, 2024, and the accompanying notes to the financial statements were prepared in part or entirely from information certified by AUL, the Custodians, in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes total investments of \$11,683,023 and \$10,048,059 at December 31, 2024 and 2023, respectively, and related increase of \$ 1,716,127 for the year ended December 31, 2024.

NOTE 5 - TAX STATUS

The Internal Revenue Service has determined and informed the Plans administrator that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believe the Plan is qualified and the related Trust is tax exempt.

Accounting principles generally accepted in the United State of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any interest to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, Participants are 100 percent vested in their accounts.

NOTE 7 – RELATED PARTY TRANSACTIONS

Certain Plan investments were shares of pooled separate accounts managed by American United Life Insurance Company (AUL). AUL is the Custodian as defined by the Plan and, therefore these transactions qualify as party-in-interest transactions. The Plan has notes receivable from participants at December 31, 2024 and 2023. As a result, these notes and all transactions relating to these notes qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risk includes global events, which could impact the value of investments and securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9 – NON-EXEMPT TRANSACTIONS

During 2024, the Company failed to timely remit to the Plan withheld employee contributions on one occasion in the amount of \$36,928 in accordance with the plan provisions of the Department of Labor ("DOL") Regulation 2510.3-102, resulting in prohibited, or non-exempt, transactions. The accompanying Schedule of Delinquent Participant Contributions discloses this transaction in accordance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The Company is in the process of calculating the required corrections to the Plan to reflect foregone earnings that would have been credited to the participants' accounts if the late remittances had been made on a timely basis.
