Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Service Alternatives, Inc. 401(k) Retirement & Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Service Alternatives, Inc. 401(k) Retirement & Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A.--DESCRIPTION OF PLAN

The following description of Service Alternatives, Inc. (Company or Sponsor) 401(k) Retirement & Savings Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The plan is a defined contribution volume submitter plan and trust originally effective March 1, 1995 and most recently restated January 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). An eligible employee is any person employed by the Company, excluding nonresident aliens. Employees are eligible to participate in the Plan upon reaching age 21 and after completing one consecutive year of service through December 31, 2021. Effective January 1, 2022, service requirements are 500 hours and 6 months of service. The entry date is the first day of each quarter following completion of eligibility requirements. Effective January 1, 2022, the Plan was restated as part of the cycle 3 restatement period. Effective August 15, 2022, the Plan was amended to have a QDIA. Effective October 1, 2023 the Plan was amended for modifications to the loan policy. Also, effective January 1, 2024, the Plan adopted, certain Secure 2.0 Act distribution options. See also below.

Contributions: The Plan is funded by eligible participant elective deferrals which may be up to the maximum amount allowed by law, discretionary employer matching contributions, and non-elective contributions. Employer non-elective contributions are allocated to participants in the same proportion as a participant's compensation bears to the total of all participants' compensation. A participant must be employed on the last day of the Plan year or complete 501 hours of service during the Plan year to be eligible to receive any non-elective contributions, unless the participant dies, becomes disabled or reaches the normal retirement age. The discretionary match is limited to 50% of participant contributions up to 4% of participant gross pay. There is no last day or service requirement to receive the match. Also, effective January 1, 2022, participants are auto enrolled at 1%, with an automatic increase of 1% each year up to 4%.

Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans. Also, all participants who are eligible to make elective deferral contributions may designate all or any portion of their deferrals as Roth elective deferral contributions. Contributions are subject to certain limitations.

Participant Accounts: Each participant's account is credited with the participant's contribution, an allocation of the Company's contributions, an allocation of the Plan earnings (losses), and charged with an allocation of certain administrative expenses. Allocations are based on participant compensation, account balances, or specific participant transaction, as applicable, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

Vesting: Participants are immediately vested in their rollover contributions and elective deferrals plus actual earnings thereon. Vesting in Company discretionary matching, or non-elective contributions is based on years of continuous service. A participant is 20% vested after two years of credited service, 40% vested after three years, 60% vested after 4 years of credited service, 80% vested after 5 years of credited service, with full vesting at six years, or upon death, disability, or attainment of early retirement age.

Retirement: The normal retirement date is the date the participant turns 65. Early retirement is permitted once a participant reaches age 55 and completes at least six years of service.

Payment of Benefits: On termination of service due to death, disability, or retirement, a participant may elect to receive a single lump-sum payment, partial withdrawals or installments. For termination of service due to other reasons, a participant may receive the vested interest of their account as a lump sum payment or partial withdrawals or continue to participate in the plan. For terminated participants, if the balance of the vested account is less than \$5,000 through December 31, 2023 or \$7,000 effective January 1, 2024, it will automatically be distributed to the participant in a single lump-sum payment. Termination distributions over \$5,000 through December 31, 2023 or \$7,000 effective January 1, 2024, require participant consent. Hardship distributions are allowed in accordance with the provisions of the Plan. In-service distributions are allowed at age 59 ½. Qualified reservist distributions are also allowed. Distributions may be taken from contributed rollover amounts at any time. Effective January 1, 2024, the Plan adopted, as part of the Secure 2.0 Act, the ability to allow federally declared disaster withdrawals, domestic abuse withdrawals, exception to penalty on early distributions from qualified plans for individuals with a terminal illness, and updating the dollar limit for mandatory distributions from \$5,000 to \$7,000. See also above.

Notes Receivable from Participants: Participant may borrow from their accounts a minimum of \$1,000 up to the maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balance in the participant's account. Loan transactions are treated as a transfer to (from) the investment fund from (to) the loan fund. A participant may have up to four loans outstanding at a time through September 30, 2023. Effective October 1, 2023, a participant may have up to two loans outstanding at a time. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case, the loan repayment term shall not exceed the usual repayment period required by commercial lenders for similar loans. Under the terms of the Plan agreement, plan loans will bear an interest rate of prime plus 2%. Principal and interest are paid through payroll deductions.

Investment Options: Participants direct their contributions and account balances in a variety of investment options offered by the Plan. The Plan Sponsor periodically reviews the investment fund options available to participants and changes them as warranted. Participants may change their investments at any time.

Forfeitures: Forfeitures are the non-vested portion of a participant's account that are lost upon termination of employment. Forfeitures are retained in the Plan and at the discretion of the Company, may first be used to reduce future Company contributions. As of December 31, 2024, and 2023, forfeited non-vested account totaled \$0. During 2024, \$8,406 of employer matching contributions were paid from forfeited non-vested accounts.

Plan Expenses: Expenses of maintaining the Plan may be paid by the Company or the Plan. Certain expenses of maintaining the Plan are paid for directly by the Company and are not included in these financial statements. Fees relating to administration of notes receivable from participants and for certain withdrawals are charged directly to the participant's account and are included in administrative expenses. Investment related expenses including 12b-1 fees are deducted from each funds' earnings and included in net appreciation (depreciation) in fair value of investments. Revenue sharing credits are credited to participant accounts.

NOTE B.--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the financial statements and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's committee determines valuation utilizing information provided by investment advisors and custodians. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative fees and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as benefit payments based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of Benefits: Benefits are recorded when paid.

NOTE C.--CERTIFIED INFORMATION

Certain information related to investments disclosed in the accompanying financial statements and the ERISA required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividend income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Matrix Trust Company, the custodian of the Plan. CMFG Life Insurance Company, the Plan Administrator, certifies information related to notes receivable from participants and interest income on notes receivable from participants as complete and accurate as of December 31, 2024 and 2023 and for the year ended December 31, 2024.

NOTE D.--FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The Putnam Stable Value Fund ("PSVF"): Valued at NAV of units held by the Plan at year end. PSVF is a common collective trust, invested directly or indirectly in fully benefit-responsive investment contracts. PSVF is valued at a NAV as provided by the custodian, which is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the PSVF, the issuer reserves temporary delay withdrawal from the PSVF in order to ensure that securities liquidations will be carried out in an orderly business matter. The PSVF, included in the fair value hierarchy table below, files a U.S. Department of Labor Form 5500, Annual Return/Report of Employee Benefit Plan, as a direct filing entity. Accordingly, certain disclosure requirements under FASB ASU 2015-12 with respect to investment strategies for investments measured using the net asset value practical expedient are not required in this report.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E.--RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are in funds managed by Matrix Trust Company, the custodian of the Plan and CMFG Life Insurance Company, the Plan Administrator therefore, these transactions qualify as party-in-interest transactions. Certain administrative functions of the Plan are performed by officers or employees of the Company. Certain employees and/or owners of the Company serve as trustees of the Plan. No such officer or employee receives compensation from the Plan.

NOTE F.--TAX STATUS

The Plan was amended and restated effective January 1, 2022 and adopted a non-standardized profit sharing money purchase with cash or deferred arrangement, which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated that the Plan is designed in accordance with applicable sections of the Internal Revenue Code.

Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G.--PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the respective accounts of the participants under the Plan, including employer contributions, shall become fully vested and non-forfeitable.

NOTE H.--RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as foreign currency exchange rate, interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

NOTE I.--OPERATIONAL ERRORS

Eligible participants were not enrolled into the plan

For the year ended December 31, 2024, it was discovered that five employees hired in March 2024 did not have the correct six month pay period hours listed, therefore, had less total hours listed, which made them appear to be ineligible. This was found in 2025 and the employees entered the Plan in May 2025. As a result, the plan sponsor made a qualified non-elective contribution of \$202 for 2024 and \$312 for 2025 to the affected participant accounts in order to remedy the errors in accordance with prescribed IRS and DOL methods during 2025.

Failure to effect a deferral election and a Roth contribution

For the year ended December 31, 2024, it was discovered that one participant's deferral elections were improperly reported resulting in an over contribution of Roth and pre-tax elective deferrals. The over contribution was corrected during 2025.

NOTE J.--SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 6, 2025, which is the date these financial statements were available to be issued.
