### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Arcturus Therapeutics, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (an "ERISA Section 103(a)(3)(C) audit"). ### NOTE 1. DESCRIPTION OF PLAN

The Arcturus Therapeutics, Inc. 401(k) Plan (the "Plan") is a defined contribution plan established on January 1, 2017. The Plan is sponsored by Arcturus Therapeutics, Inc. (the "Company") to allow eligible employees to adopt a regular program of savings for retirement. The Plan is subject to the requirements of the Employee Retirement Income Security Act of 1974 ("ERISA") and the provisions of the Internal Revenue Code ("IRC"). Significant elements of the Plan are summarized below. Participants should refer to the Plan document for a complete description of the Plan's provisions.

#### Eligibility

Employees who have completed one month of service with the Company are generally eligible to participate in the Plan and may enroll in the Plan on the first day of the month coincident with or next following the date on which they meet the eligibility requirements. The following employees are not eligible to participate in the Plan: Interns (unless they have attained 21 years of age and completed at least 1,000 hours of service); non-resident aliens who receive no earned income from sources within the United States; leased employees; and residents of Puerto Rico.

#### Participant Contributions

Eligible participants may contribute up to 100% of pretax eligible compensation as defined by the Plan. Participants may elect to have all or a portion of their contributions be Roth elective deferrals (after-tax) when contributed to the Plan. In addition, employees who are age 50 or older can elect to defer additional amounts (called "catch-up" contributions) to the Plan.

The Plan has adopted automatic enrollment provisions such that employees who have not made an affirmative elective deferral request, including a zero-deferral election, shall automatically have 6% of their eligible pre-tax compensation deferred into the Plan.

All participant contributions are subject to limitations imposed by the IRC. Employees may also contribute amounts representing rollover distributions from other qualified sources.

#### Employer Contributions

The Plan includes provisions for discretionary employer matching contributions as well as discretionary non-elective contributions. For 2024, the discretionary employer matching contribution is determined each payroll period and is equal to 50% of a participant's deferral contributions, subject to a maximum annual discretionary employer matching contribution of \$2,500. To share in any discretionary contributions, participants must be employed as of the last day of the Plan year and have been credited with 1,000 hours of service during the Plan year. The Company made no discretionary non-elective contributions to the Plan for the year ended December 31, 2024.

#### Notes Receivable from Participants (Participant Loans)

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum generally equal to the lesser of \$50,000 or 50% of their vested account balance. Loans bear interest at a reasonable rate as determined by the Plan administrator at the time of application, and are generally secured by the participant's vested account balance. Participants are permitted to have only one loan outstanding at any time. Principal and interest are paid ratably through payroll deductions over a term not to exceed five years unless the loan is used toward the acquisition of the participant's principal residence, in which case the loan term may be longer. As of December 31, 2024, the interest rates on outstanding loans ranged from 4.25% to 9.50%.

#### Vesting

Participants are vested immediately in the portion of their accounts related to their contributions (including earnings or losses thereon). Through January 31, 2022, participants vested in the portion of their accounts related to matching employer contributions and nonelective employer contributions (including earnings thereon) based on years of service as follows:

On February 1, 2022, the Plan was amended such that participants vest in the portion of their accounts related to matching employer contributions (including earnings thereon) based on years of service as follows:

In addition, upon reaching normal retirement age (65), or in the event of death or disability (as defined), employed participants become 100% vested in their accounts.

#### Payment of Benefits

Upon disability, death, termination, or attaining age 59½ or normal retirement age (65), participants (or, if applicable, their beneficiaries) may elect to receive a distribution of their vested account balance in a lump sum, or defer distribution if their vested account balance exceeds \$5,000 (\$7,000 effective January 1, 2024). Pursuant to the provisions in the Setting Every Community Up for Retirement Enhancement Act of 2019 (the "SECURE" Act), which became law on December 20, 2019, and the SECURE 2.0 Act of 2022 (the "SECURE 2.0 Act"), which became law on December 29, 2022, participants may defer taking distributions as follows:

- If a participant reached the age of 70½ in 2019, the participant may defer receiving distributions until the later of April 1, 2020, or the April following the calendar year in which the participant retires;
- If a participant reached the age of 70½ in 2020 or later, the participant may defer receiving distributions until the later of the April following the calendar year in which the participant reaches age 72 or retires, except that –
- Beginning in 2023, the age a participant must begin taking distributions was raised to 73. If a participant reached the age of 72 during 2023, the participant may defer receiving distributions until April 1, 2025, the latest date that a required minimum distribution may be taken for 2024.

#### Payment of Benefits (Continued)

The Plan was formally amended in September 2024 to allow hardship distributions from a participant's vested account balance, in accordance with Plan and IRC provisions regarding qualifying expenses.

Upon termination of employment, if a participant's vested account balance is between \$1,000 and \$5,000 (\$7,000 effective January 1, 2024), and if the participant has not elected to receive a cash distribution or have the balance rolled over into an individual retirement account ("IRA") of his/her choosing, the Plan may transfer the participant's account balance into an IRA separately managed and maintained by a trust company engaged by the Plan. Also at its discretion, the Plan may elect to distribute vested account balances of less than \$1,000.

#### Forfeitures

Forfeitures of terminated participants' accounts are held in an unallocated asset account. These amounts may be used to pay Plan administrative expenses or reduce employer contributions. During 2024, \$27,915 was added for amounts forfeited from participant accounts, \$564 was added related to investment gains, and \$40,188 was used toward Plan expenses. No amounts were used toward employer contributions. As of December 31, 2024 and 2023, the forfeitures account balance was \$4,361 and \$16,070, respectively.

#### Participant Accounts and Investment Options

Each participant's account is credited with the participant's contributions, any employer matching contributions, and allocations of (i) any employer non-elective contributions, (ii) Plan earnings or losses, and (iii) any administrative expenses. Allocations are based on participant contributions, earnings, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Upon enrollment in the Plan, a participant may direct employee and employer contributions in any of the Plan's investment options. Subsequently, participants may change their allocations and transfer account balances between investment options in accordance with Plan provisions.

### NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States ("U.S. GAAP").

#### Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net realized and unrealized appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes Receivable from Participants (Participant Loans)

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

The Plan's administrative expenses, such as custodian/trustee, accounting, and legal expenses, are paid by the Company, except for certain distribution and loan fee expenses, which are paid by the transacting participants.

#### Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires the Plan's management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

#### Subsequent Events

Plan management has evaluated subsequent events through the date of the independent auditors' report, which is the date these financial statements were available to be issued (Note 11).

### NOTE 3. INFORMATION CERTIFIED BY THE CUSTODIAN

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and the ERISA-required supplemental schedule (Schedule H, Part IV, Line 4i), including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation or depreciation in fair value of investments, dividends, and interest income for the year then ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, the custodian of the Plan.

### NOTE 4. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement for the asset or liability at the measurement date. These inputs reflect Plan management's best estimate of what market participants would use in pricing the asset or liability at the measurement date. Consideration is given to the risk inherent in the valuation technique and in the inputs to the model.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds (including Money Market Funds):* Valued at the daily closing price as reported by the fund. Mutual funds including money market funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded.

*Self-Directed Brokerage Accounts:* Accounts consist primarily of interest-bearing cash (money market), publicly traded stocks, and mutual funds for which identical securities are observable in active markets.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### NOTE 5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to provision of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

### NOTE 6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the accompanying financial statements.

### NOTE 7. TAX STATUS

The Company has adopted a non-standardized pre-approved defined contribution plan and relies upon the opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020 which stated that, in its opinion, the pre-approved plan and related trust are designed in accordance with applicable sections of the IRC. The Company has not applied for a determination letter from the IRS specific to the Plan. Although the Plan has been subsequently amended, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the accompanying financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### NOTE 8. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Company pays certain administrative costs of the Plan, and provides administrative services for the Plan at no cost to the Plan. Certain investments are managed by the Plan's custodian or recordkeeper or affiliates thereof. These transactions qualify as exempt party-in-interest transactions.

### NOTE 9. OPERATIONAL FAILURES

During 2023, the Company identified operational failures relating to the improper inclusion of a type of compensation in Plan eligible compensation which resulted in excess employee deferrals and employer matching contributions since Plan inception. Because the failures were in the favor of participants, the Company and the Plan administrator retroactively amended the Plan in September 2024 to include the type of compensation at issue and to reflect the historical administration of the Plan.

Based on the actions taken, Plan management and the Company believe the aforementioned operational failures will not cause the Plan to be disqualified by the IRS and that the self-corrective actions allow the Plan to be in compliance with the Plan documents and ERISA. Accordingly, no provision for income taxes has been included in the accompanying financial statements.

### NOTE 10. SECURE 2.0 ACT

On December 29, 2022, the SECURE 2.0 Act became law. The purpose of the legislation is to expand access to retirement plans and to help working Americans increase their retirement savings. In addition to the changes to distributions described in Note 1, The SECURE 2.0 Act includes various required and optional provisions that become effective through 2033, certain of which are described below:

- Beginning January 1, 2025, a participant from the ages of 60 to 63 can elect catch-up contributions up to the limit of the greater of \$10,000 or 150% of the catch-up contribution limit imposed by the IRS.
- Beginning January 1, 2025, long-term part-time workers (defined as employees who have worked for two consecutive 12 month periods during each of which they have at least 500 hours of service) will become eligible to enroll in their employer's retirement plan after two years.
- Beginning January 1, 2026, catch-up contributions will be made on a Roth basis, unless the participant earns \$145,000 or less.

In August 2024, Plan management formally elected to adopt the optional qualified birth or adoption distribution provision under the SECURE 2.0 Act, subject to certain requirements and participant certifications, as defined. The provision was adopted and made available to participants effective November 12, 2024. Additionally, during 2024 Plan management formally elected to adopt the additional catch-up contributions for participants from the ages of 60 to 63 provision that became effective January 1, 2025. Plan management expects to formally amend the Plan by December 31, 2026.

### **NOTE 11. SUBSEQUENT EVENT**

During 2025, as part of an ongoing corporate restructuring, the Plan Sponsor announced it would be cutting its workforce by approximately 23%. The employees impacted by the reduction in force were terminated between March and September 2025. Plan management is in the process of determining if the reduction in force during 2025 triggered a partial plan termination.
