The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years ended, and the related notes to the financial statements.

1. Plan Description

The following brief description of the Cassling 401(k) Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits for the employees of Cassling Diagnostic Imaging, Inc. (the Company).

Employees are eligible to make salary deferral contributions and receive Company safe harbor matching contributions and Company discretionary profit-sharing contributions after attaining age 18 and completing 60 days of service. Eligible employees become participants on the first day of the month coinciding with or next following the date on which eligibility requirements are met.

Participants are eligible to receive discretionary profit-sharing contributions if they are employed on the last day of the Plan year.

Contributions

Participants may make voluntary pre-tax salary deferral contributions up to the maximum dollar limits allowable by law. The Plan allows participants to designate a portion or all of their elected contributions as designated after-tax Roth contributions. Participants may also contribute amounts representing distributions from other qualified plans. Employees who become eligible to participate will be automatically enrolled with an initial 5% salary deferral, which will increase by one percentage point annually on January 1, up to a maximum rate of 10%. Automatic enrollment will apply to all participants except those who have a salary deferral agreement in place provided the deferral amount under agreement is at least 5%. At any time, a participant can elect not to contribute. Participants can make any other modification on the first day of each month. All participants who are eligible to make deferral contributions and who will attain age 50 before the close of the calendar year shall be eligible to make catch-up contributions.

The Company will make safe harbor matching contributions equal to 100% of the participant's elective deferrals that do not exceed 3% of eligible compensation plus 50% of the participant's elective deferrals that exceed 3% of eligible compensation up to 5% of eligible compensation. Safe harbor matching contributions made by the Company totaled \$1,105,323 and \$859,647 for the years ended December 31, 2024 and 2023, respectively. The Company may also elect to make annual discretionary profit-sharing contributions. Discretionary profit-sharing contributions made by the Company totaled \$1,023,511 and \$952,624 for the years ended December 31, 2024 and 2023, respectively. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of a) the Company's safe harbor matching contributions, b) the Company's discretionary profit-sharing contributions and c) Plan earnings or losses. The Company's safe harbor matching contributions are allocated among participants based upon each participant's elected salary deferral. The Company's discretionary profit-sharing contributions are allocated among participants based upon compensation of eligible participants and years of service. Plan earnings or losses are allocated on the basis of actual results of the investments held in participant accounts. Participant-directed investments are maintained in individual member accounts managed by John Hancock Trust Company LLC (John Hancock).

Vesting

Participants are immediately vested in their contributions and Company safe harbor matching contributions plus actual earnings thereon. The Company's discretionary profit-sharing contributions credited to participants' accounts are vested based on years of continuous service. A participant is 20% vested after two years of credited service and vesting increases 20% per year until a participant is 100% vested after six years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates. Principal and interest are paid through payroll deductions or payment by check only for prepayments or terminated participants.

Payment of Benefits

Upon termination, retirement, disability, or death, the participant or beneficiary may receive a lump sum, installment or partial payments equal to the value of the vested funds allocated to the participant's account. The Plan requires mandatory distribution payments of \$7,000 (\$5,000 prior to January 1, 2024) or less to be directly rolled over to an individual retirement account designated by the plan administrator in the event the participant does not elect otherwise. Benefits are recorded when paid.

Forfeitures

Upon a participant's termination of employment before normal retirement, disability, or death, the portion of the Company's contributions not then vested shall be forfeited. The forfeited portion of any participant's account may be used to pay administrative expenses or to reduce the Company's contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$59,018 and \$50,743, respectively. During the years ended December 31, 2024 and 2023, forfeitures totaling \$73,570 and \$87,042 were used to reduce Company contributions.

2. Summary of Significant Accounting Policies

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting and in conformity with accounting principles generally accepted in the United States of America.

Presentation of Participant-Directed Funds

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gain and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Expenses

All reasonable Plan administration expenses, including those involved in retaining necessary professional assistance may be paid from the assets of the Plan to the extent permitted by the participant’s individual agreements. These expenses may be allocated to the Plan participants. Expenses specifically incurred by or attributable to individual participants are paid from the applicable participants’ accounts. Certain indirect investment-related expenses are included in net appreciation in fair value of investments. The Company may, at its discretion, pay a portion or all of these expenses.

Subsequent Events

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through October 2, 2025, noting no items requiring disclosure.

3. Information Certified by John Hancock

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by John Hancock, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplementary information.

4. Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded

Pooled Separate Account: The pooled separate account is valued at NAV based on the market value of its underlying investments. FASB ASC 820, *Fair Value Measurement*, allows NAV per unit to serve as a practical expedient to estimate the fair value as long as certain requirements are met. It is the Plan’s assessment that this account meets those requirements. Participants can redeem the account at NAV as of the measurement date on a daily basis and there are no unfunded commitments as of December 31, 2024 and 2023. The NAV is the basis for current transactions and the account can be redeemed at NAV as of the measurement date.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Investment Contract with John Hancock

The Plan has entered into an investment contract with John Hancock. John Hancock maintains the contributions in a pooled separate account. The account is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by John Hancock.

The pooled separate account, as reported to the Plan by John Hancock, is included in the financial statements at fair value, which represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses.

6. Tax Status

The Plan is qualified as a profit-sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed as soon as practicable after the termination date.

8. Related-Party Transactions

Certain Plan investments are managed by John Hancock. John Hancock is the custodian of the Plan and therefore these transactions qualify as party-in-interest transactions.
