INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Trustee

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of 403 (b) Thrift Plan of East Bay Agency for Children (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

NOTE 1 - DESCRIPTION OF PLAN

The following description of 403 (b) Thrift Plan of East Bay Agency for Children (the "Plan") provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

A. General

The Plan is a defined contribution plan available to eligible employees of 403 (b) Thrift Plan of East Bay Agency for Children. The Plan is intended to qualify under Section 403(b) of the Internal Revenue Code (IRC). Generally, all employees of the Employer are eligible to enroll in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

B. Plan Administration

The employer is the administrator of the Plan and, as such, carries out the duties imposed by ERISA. The employer has delegated certain responsibilities for the operation and administration of the Plan. Trustee and record keeping services are provided by Mutual of America Life Insurance Company.

Certain administrative expenses of the Plan, including recordkeeping, were paid directly by the Employer for the year ended December 31, 2024. Investment fees, which may vary according to the individual funds selected, are paid out of the assets of the Plan. Participants should refer to the prospectus of the individual investment funds for further details on individual investment fees.

C. Contributions

Under the provisions of the Plan, an employee can elect to contribute any percentage of their salary, provided they do not contribute more than the maximum permitted by law. Additionally, if the employee has attained age 50, then the employee is eligible to make an additional catch-up contribution as specified in the Plan. The maximum contribution limits permitted by law:

The employer makes a matching contribution on behalf of an eligible participant amounting to the lesser of 100% of the salary reduction amount contributed by the participant and 4% of the participant's compensation received during the plan year.

D. Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Employer's contributions, and earnings thereon and is charged with an allocation of applicable administrative expenses. Allocations are based on participant earnings or account balances, as defined. Participants select the allocation of investment funds to be applied to contributions credited to their account. Participants are allowed to transfer or rollover funds into the Plan from other qualified or 403(b) plans.

E. Investment Options

Upon enrollment in the Plan, participants may direct the investment of their contributions and the employer's contributions into various investment contracts and annuity options offered by the Plan.

F. Refundable Contributions

The Plan conducts annual non-discrimination testing in accordance with IRS regulations. For the year ended December 31, 2024, the Plan initially failed the Actual Contribution Percentage (ACP) test; however, corrective actions were implemented within the required timeframe in accordance with applicable IRS correction procedures. For the year ended December 31, 2023, the Plan passed all required non-discrimination tests.

G. Vesting

Participants are fully and immediately vested in their voluntary contributions. The value of the participant's account attributable to the Employer's contribution is fully vested when a participant completes 3 years of vesting service.

H. Forfeitures

Forfeitures are first used to reduce employer contributions, and any remaining balance is used to pay administrative expenses. Forfeitures are disposed of in the Plan year in which they occur.

I. Payment of Benefits

Participants can receive a distribution upon attainment of age 59½, termination of employment, retirement, death, or disability. The distribution of participant's salary reduction contributions without any earnings can also be made upon a showing of hardship.

J. Participant Loans

Participants may borrow from their accounts up to a maximum amount generally equal to the lesser of \$50,000 and 50% of their vested account balance. All loans must be repaid within 5 years unless the loan is for the purchase of a principal residence for which the loan repayment may be for a longer term. Participant's account balance in the insurance company's general account will serve as the sole collateral security for the loan. Loans will bear interest at a rate declared by MOA in commensurate with local prevailing rates. Principal and interest are generally repaid through payroll deductions to the participant's segregated account.

K. Participant Investment Rollovers

Participants are allowed to transfer or rollover funds into the Plan from other qualified or 403(b) plans.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting

The financial statements of the Plan have been prepared on a modified cash basis of accounting which is a comprehensive basis of accounting other than generally accepted accounting principles in the United States of America. Under this basis, contribution revenues are recognized when cash is transferred and deposited in the Plan, and benefit/distribution expenses are recognized when cash is disbursed, except for investments, which are measured and valued at fair value.

B. Use of Estimates

The preparation of financial statements in accordance with generally accepted accounting principles in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts in the financial statements and disclosures. Accordingly, the actual amounts could differ from those estimates. Any adjustments applied to estimated amounts are recognized in the year in which such adjustments are determined.

C. Investment Valuation and Income Recognition

On December 31, 2024, the Plan's investments were held in various insurance contracts and annuities and are reported at fair value. The net appreciation in the fair value of investments includes realized and unrealized gains and losses on the fair value of investments held by the Plan. Purchases and sales of investments are recorded on a settlement-date basis. Interest income is accrued as it is earned, and dividends are recorded as of the ex-dividend date.

Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of net assets available for benefits for a defined contribution plan attributable to fully benefit responsive investment contracts because contract value is the amount that participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invests in investment contracts. The plan Management believes that the difference between fair value and contract value of these investment contracts is not material. Therefore, the Statement of Changes in Net Assets Available of Benefits is prepared on a contract value basis.

Management fees and operating expenses charged to the Plan for investment in mutual funds are reflected as a reduction of net assets in the Statement of Changes in Net Assets Available of Benefits.

The change in net unrealized appreciation/depreciation of investments held from the beginning of the Plan year to the end of the Plan year is included with realized gains/losses as net investment income/loss reported in the accompanying statements of net assets available for benefits.

D. Loans to Participants

Loans to participants are measured at their unpaid principal balance. In 2024, there have been no defaulted loan.

E. Contributions

Contributions from employees and the employer are recorded in the period in which the employer transfers the funds to the Plan.

F. Rollovers

Participants may elect to rollover amounts from other qualified plans or individual retirement accounts into the Plan, provided that certain conditions are met. As of December 31, 2024, and 2023, the Plan has participants rollovers amounting to \$23,855 and \$91,301, respectively.

G. Distributions

Distributions are recorded when paid.

H. Expenses

Certain administrative expenses of the Plan are paid by the Employer.

NOTE 3 - TAX STATUS

The Plan is subject to Section 403(b) of the Internal Revenue Code. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that is more likely than not to be sustained upon examination by the federal and state taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 - INFORMATION CERTIFIED BY THE TRUSTEE

At the request of 403 (b) Thrift Plan of East Bay Agency for Children, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing the certified investment information with the related information presented and disclosed in the financial statements and supplemental schedule, reading the disclosures relating to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP and whether the supplemental schedule is in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 5 - PARTY-IN-INTEREST TRANSACTION

Certain plan investments are managed by Mutual of America Life Insurance Company. Mutual of America Life Insurance Company is the trustee as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions.

NOTE 6 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Valuation inputs are unobservable and significantly impact fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

As of December 31, 2024, and 2023, management determined that the underlying investments of the funds that pooled separate accounts invest in are based on quoted market prices within an active market and as such are classified as Level 1. Investments held in pooled separate accounts are stated at market value, which represents fair value. The Plan's group annuity contract held in the insurance company general account of Mutual of America Life Insurance Company is valued at contract value which is equal to fair value and is considered to be a cash equivalent. Contract value represents contributions made under the contract, plus interest at the credited rate, less funds used to purchase annuities and pay administrative expenses charged. For the years ended December 31, 2024, and 2023, the insurance company general account has been excluded from the fair-value hierarchy.

The Plan has evaluated all subsequent events through July 23, 2025, the date on which the financial statements were available to be issued, and has determined that no adjustments are necessary to the amounts reported in the accompanying financial statements, nor have any subsequent events occurred, the nature of which would require disclosure.
