**Note 1 – DESCRIPTION OF PLAN**

The following description of the 401(k) Profit Sharing Plan for the Employees of Forgotten Harvest, Inc. (“Company”) (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan began operations on February 1, 2004. The Plan is a defined contribution plan covering all employees of the Company who have attained the age of 18. It is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

Contributions

Participants may elect to defer an amount of pretax compensation or post tax compensation (Roth deferral) as defined by the Plan subject to various limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers). Participants direct the investment of their contributions and any Company contribution into various options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible participants are automatically enrolled in the plan unless they affirmatively elect not to participate. The deferral rate for auto enrollment is 3% of eligible compensation with annual increases of 1% up to a maximum of 6%. Also, the Company contributes to the Plan matching and profit-sharing contributions for participants who have completed one year of service. The matching contribution is 100% of the first 3% of base compensation deferred. The profit-sharing contribution is 3% of eligible compensation.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and the Company’s contribution, if any, as well as allocations of Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately 100% vested in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts is based on years of service, as defined by the Plan. A participant begins vesting after one year of service (50%) and is fully vested upon three years of service.

**Note 1 – DESCRIPTION OF PLAN (CONTINUED)**

Payment of Benefits

At the time a participant is entitled to receive a distribution under the Plan, the participant may elect to receive lump-sum payment equal to the value of the participant's vested account balance, or partial payments may be permitted to satisfy the required minimum distribution rules.

Administration

The Company is the Plan sponsor and is responsible for the administration of the Plan. The investment custodian is Alerus Retirement and Benefits. The custodian holds all the Plan's assets and executes all of the Plan's transactions.

Forfeitures

Forfeitures are used to reduce future Company contributions. For the year 2024, Company contributions were reduced by \$16,078 from forfeited non vested accounts.

**Note 2 – SUMMARY OF ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the investment custodian and investment advisors. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Note 2 – SUMMARY OF ACCOUNTING POLICIES (CONTINUED)**

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses incurred in maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's accounts and are included in administration expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated events through October 8, 2025, which is the same date the financial statements were available to be issued.

**Note 3 – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the hierarchy under FASB ASC 820 are described as follows:

- Level 1 inputs to the valuation methodology are the unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access.
- Level 2 inputs to the methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

**Note 4 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions, if applicable.

**Note 5 – RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS**

Certain plan investments are managed by Insurance Company, who is the Plan's custodian. Additionally, the Plan pays direct compensation to the third-party administrator related to recordkeeping and administration services. Indirect compensation is also paid to the custodian and is netted against net appreciation of assets. Transactions involving these investments and services are considered party-in-interest transactions; however, they are not considered prohibited transactions under the ERISA regulations.

**Note 6 – TAX STATUS**

The Plan is an adoption of a volume submitter defined contribution plan that the Internal Revenue Service has issued a favorable determination letter dated June 30, 2020. Although the Plan has been amended since receiving the determination letter, the Plan Sponsor believes the Plan is designed, and is currently operating, in compliance with applicable requirements of the Internal Revenue Code and therefore, believe that the Plan is qualified and is exempt from Federal income tax.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. As of December 31, 2024, the Plan Sponsor believes that the Plan has no uncertain tax positions that qualify for either recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are no examinations currently in progress. The Plan Sponsor believes that the Plan is no longer subject to income tax examinations for years prior to 2022.

**Note 7 – RISKS AND UNCERTAINTIES**

The participants invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
