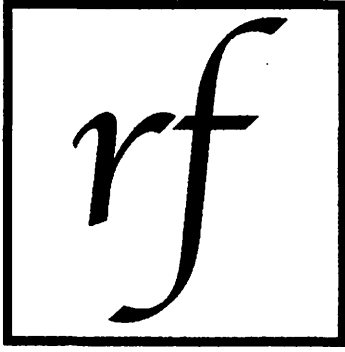

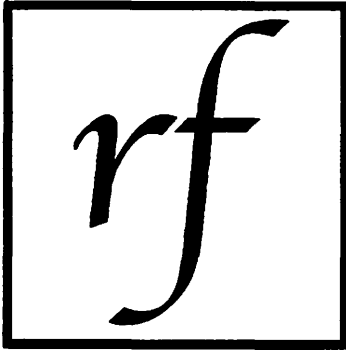

Note 1 Description of Plan

The following description of the Mind Springs Employee Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document and Summary Plan Description, which are available from the Plan administrator, for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Colorado West Inc. d/b/a Mind Springs, Inc. (the Company) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was adopted under the provisions of Internal Revenue Code (IRC) Section 401 (a). Participation in the Plan is entirely voluntary. Participants are eligible to make salary deferral contributions if the participant works on average more than 20 hours per week.

Employee Contributions

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions up to 100% of eligible compensation. Employee rollover and catch-up contributions are also permitted. The Plan does allow for special code section 403(b) catch-up contributions for those participants with 15 years of service. Contributions may not exceed dollar limits set by the IRC.

Employer Contributions

The Plan also allows for the Company to make matching contributions for employees age 21 or older that have one year of service. Effective October 1, 2022, the Company changed its matching contribution to 100% of employees' salary deferral amounts up to 2.50% to a discretionary match which was determined to be 6% of the participant's eligible compensation. The Company may make other discretionary contributions to the Plan, as determined by the Company's board of directors. For the years ended December 31, 2024 and 2023, the Company did not make any discretionary contributions to the Plan. For the years ended December 31, the Company made matching contributions of \$602,245 (2024) and \$479,122 (2023).

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions on the participant's behalf, and an allocation of the Plan earnings. An individual participant's account is charged a fee for obtaining a participant loan, including on-going maintenance of the loan. Allocations are based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Elections

Investment account options available include various mutual funds and guaranteed investment contracts. Each participant has the option of directing his or her contributions into any of the

investment accounts and may change the allocation daily, however; for certain investment accounts, in an effort to reduce market timing and excessive trading, certain restrictions may apply.

Vesting

Participants are immediately vested in their elective voluntary contributions plus earnings thereon. Vesting in the Company's matching contributions plus earnings thereon is based on years of continuous service. A participant is fully vested after three years of qualified credited service. The nonvested balance is forfeited upon termination of service. In the event of a participant's death, disability, or attainment of normal retirement age (65) while employed with the Company, the participant is automatically 100% vested.

Notes Receivable from Participants

The plan document includes provisions authorizing loans from the Plan to active eligible participants. Loans are made to any eligible participant demonstrating a qualifying need. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loan is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are secured by the participant's vested balance and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on local prevailing rates as determined by the plan administrator.

Payment of Benefits

Upon termination of service, a participant with an account balance of \$5,000 or less will receive a lump-sum payment equal to the value of his or her vested account balance. An employee with an account balance greater than \$5,000 may elect to receive a lump-sum amount or remain in the Plan and continue to participate in investment earnings.

Participants may withdraw amounts for their accounts subject to certain limitations imposed by the Plan. Such withdrawals are also subject to certain taxes and penalties as assessed by the Internal Revenue Service (IRS).

Forfeitures

If a participant terminates service prior to being fully vested in their account under the Plan, they will forfeit the amount in which they are not vested. Forfeitures may first be used to pay administrative expenses. Forfeitures that have not been used to pay administrative expenses shall be applied to reduce the earliest plan sponsor contribution made after the forfeitures are determined. Net forfeitures used to pay administrative expenses for the years ended December 31 were \$2,174 (2024) and \$932 (2023). Net forfeitures used to reduce employer contributions for the years ended December 31 were \$-0- (2024) and \$12,700 (2023). At December 31, 2024 and 2023, there were no forfeited nonvested accounts.

Note 2 Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Investment Valuation and Income Recognition

The Plan's pooled separate account investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the Plan's trustees. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid by the trustee and upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Plan or the Company, at the Company's discretion.

Use of Estimates

The preparation of financial statements, in conformity with accounting principles generally accepted in the United States of America, requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

Note 3 Information Certified by the Plan's Trustee

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. American United Life Insurance Company (AUL), the trustee of the Plan has certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reflected in the statements of changes in net assets available for benefits for the year ended December 31, 2024.

Note 4 Fair Value of Investments

The Plan accounts for fair value in accordance with Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, Fair Value Measurements and Disclosures (ASC 820). ASC 820 defines fair values, establishes a consistent framework for measuring fair value and expands disclosure requirements for fair value measurements. The

framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

Under ASC 820, assets and liabilities are grouped in three levels, based on the markets in which the assets and liabilities are traded and the reliability of the assumptions used to determine fair value. These levels are:

- *Level 1* - Valuation is based upon quoted prices for identical instruments traded in active markets.
- *Level 2* - Valuation is based upon quoted prices for similar instruments in active markets, quoted prices for identical or similar instruments in markets that are not active, and model-based valuation techniques for which all significant assumptions are observable in the market.
- *Level 3* - Valuation is generated from model-based techniques that use significant assumptions not observable in the market. These unobserved assumptions reflect the Plan management's own estimates of assumptions that market participants would use in pricing the asset or liability. Valuation techniques include use of option pricing models, discounted cash flow models, and similar techniques.

Under ASC 820, the Plan bases fair values on the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements for assets and liabilities where there exists limited or no observable market data and, therefore, are based primarily upon the Plan's estimates, are often calculated based on current pricing policy, the economic and competitive environment, the characteristics of the asset or liability, and other such factors. Therefore, the results cannot be determined with precision and may not be realized in an actual sale or immediate settlement of the asset or liability. Additionally, there may be inherent weaknesses in any calculation technique, and changes in the underlying assumptions used, including discount rates and estimates of future cash flows, that could significantly affect the results of current or future values.

Following is a description of the valuation methodologies used for assets measured at fair value.

Pooled Separate Accounts: The Plan is invested at December 31, 2024 in the AUL American Unit Trust pooled separate account through a group variable annuity contract issued by American United Life Insurance Company. The AUL American Unit Trust, also referred to as the Variable Account, is divided into subaccounts. Each subaccount is exclusively invested in a single mutual fund. The subaccounts are valued at their accumulation unit value (AUV). The subaccounts are valued daily based on the number of accumulation units held by the Plan in each respective subaccount multiplied by each respective subaccount's AUV. The AUV is determined daily based on the net asset value (NAV) of the shares of the underlying mutual fund that each respective subaccount is invested in. The combined AUV of all subaccounts that the Plan is invested in represents the fair value of the Plan's investment in the Variable Account.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the Plan's use of different methodologies or assumptions to determine the fair

value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 Investment Contract with Insurance Company

As described in Accounting Standards Codification (ASC) 962, *Plan Accounting-Defined Contribution Pension Plans*, as updated by ASU 2015-12, investment contracts held by a defined contribution plan are required to be reported at contract value. The Principal Guaranteed Option and AUL Stable Value Fund (the Funds) are group annuity contracts issued by Principle and AUL; and are backed by the full faith and creditworthiness of the issuers. The Funds do not operate like a mutual fund, variable annuity product, or conventional fixed rate individual annuity product. Under the group annuity contracts that supports these products, participants may ordinarily direct a permitted withdrawal or transfer of all or a portion of their account balance at contract value, within reasonable timeframes. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

Note 6 Plan Termination

Although they have expressed no intention to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants will become 100% vested in their accounts.

Note 7 Tax Status

The Plan is intended to be a tax-sheltered annuity plan under Section 403(b) of the Internal Revenue Code of 1986, as amended. The Plan has not requested or obtained a determination letter, as the IRS does not currently provide that service for 403(b) plans. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and not subject to tax.

Note 8 Related-Party Transactions

The Plan pays for certain expenses while the Company absorbs certain administrative expenses, such as accounting fees. Party-in-transit transactions include those with fiduciaries or

employees of the Plan, any person which provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

During the years ended December 31, 2024 and 2023 the Plan held investment contracts in which the underlying pooled separate account and insurance company general account investments are managed by AUL and Principal, the trustees of the Plan.

The Company provides certain administrative services on behalf of the Plan at no cost to the Plan.

Note 9 Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10 Subsequent Events

The Plan's management has evaluated subsequent events through October 4, 2025, the date which the financial statements were available to be issued, and determined that no events have occurred that would require disclosure.
