

NOTE 1- SUMMARY PLAN DISCRPTION

The following description of Butler National Corporation 401(k) Profit Sharing Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution salary deferral plan available to qualifying employees of Butler National Corporation (the "Company"). The plan excludes from participation; union employees whose employment is governed by a collective bargaining agreement under which retirement benefits were the subject of good faith bargaining, non-resident aliens who have no earned income from the sources within the United States, and part time, temporary, or seasonal workers. Employees not in an excluded class will be eligible to participate if credited with one hour of service during a one consecutive month time-period and have attained age 18; however, the entry date for beginning participation is the first day of the Plan year and the first day of the seventh month of the Plan year coinciding with or next following the date the employee satisfies the eligibility. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan's Custodian is Nationwide Financial Services, Inc.

Contributions

Participants may elect to contribute not less than one percent of their gross annual compensation, subject to certain limitations, with the contributions and earnings thereon being nontaxable until withdrawn from the Plan in accordance with the provisions of Section 401(k) of the Internal Revenue Code (the "Code"). The maximum allowable employee elective deferral contribution for a participant for a plan year shall be limited to \$23,000 for 2024. A participant's minimum employee elective deferral shall be an amount equal to at least 1% of a participant's applicable compensation for the Plan year. The elected contribution percentage may be changed as often as desired. Participants may roll their funds into the Plan from another qualified Plan. In addition, any participant age 50 or more may make a catchup contribution up to \$7,500 for 2024.

An employee will be credited with a year of eligibility service upon completion of at least 1,000 hours during 12 months from the date of hire, and for each subsequent year thereafter.

A participant becomes eligible to begin profit sharing and safe harbor contributions on the first day of the first month and seventh month of the Plan year coincident with or next following the date an employee attains age eighteen and completes one month of eligibility service.

The Company matched employee contributions up to 6% of the participant's compensation for the year ended December 31, 2024. The participant must be an employee on the last day of the calendar year to be eligible for the company match. The matching contribution is made under the Safe Harbor rules and is, therefore, 100% vested. The employer match contribution for the year ended December 31, 2024 was \$576,243. This amount was subsequently received in April of 2025.

The Company may make a discretionary contribution to the plan allocated to the participants on the same proportion that their compensation bears. The Company did make such a discretionary contribution for the year ended December 31, 2024 of 7.33% of executive compensation and 2.45% of all other compensation. The employer discretionary contribution for the year ended December 31, 2024 was \$314,218. This amount was subsequently received in July of 2025.

Participant Accounts

Each participant's account is credited with the participant's salary deferral contributions and the Company's profit sharing and safe harbor matching contributions. Allocations are based on participant elective deferrals of compensation, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participants vested account balance. Loans are not allowed under the Plan.

Vesting

Participants are fully vested in their own contributions to the Plan, plus any earnings thereon. Participants are also fully vested in benefits provided by the Company matching and profit-sharing contributions, plus earnings thereon.

Forfeitures

Upon termination from employment by the Company, a participant's non – vested portion of Company contributions and earnings is considered forfeiture and is used to reduce future Company contributions to the Plan. The Plan maintained a balance of \$1,118 in the forfeiture account at December 31, 2023. During the year ended December 31, 2024, there were no forfeitures and no forfeited amounts were used to reduce Company contributions and there were \$56 in investment gains. As of December 31, 2024, there was \$1,174 in the forfeiture account.

Administrative Expenses

Trustee's fees are billed directly to the Company, with the Trustee reserving the right to pay the fees and expenses directly from the Plan or the Plan sponsor. In addition, the cost of the annual audit is paid by the Company. During the year ended December 31, 2024, total fees paid by the Company for the plan

amounted to \$20,450. The remainder of the administrative fees related to the Plan are paid out of the Plan assets.

Payment of Benefits

Participants are entitled to the benefit which can be provided from the participant's vested account balance. Upon termination of service due to death, the participant's beneficiary shall receive a lump-sum distribution in cash. If the distribution exceeds \$5,000, then the beneficiary may elect to have the death benefit paid in a single lump-sum cash payment or in annual installments at least equal to the required minimum distribution amount.

Upon termination of service other than due to death for participants with a Plan vested account balance of more than \$5,000, the account balance may not be distributed prior to the participant's 62nd birthday or normal retirement date unless the participant consents to the distribution. If the participants vested Plan account balance does not exceed \$5,000, the account balance may be distributed by the Plan Sponsor without the participants consent.

Certain participants may make withdrawals prior to termination of employment. Hardship withdrawals are available to Plan participants, as defined by the Plan Document and permitted by the IRC. Hardship withdrawals are limited to the participant's account balance that is 100% vested. Participants who have obtained the age of 59 ½ may elect to receive a distribution of all or any portion of their vested account balances in a single lump sum payment.

Investment options

A participant directs all deferral contributions into mutual funds or guaranteed investment contracts managed by the Plan trustee. Employees can change their investment allocation at any time.

Amendment and termination

The Company shall have the right at any time to amend the Plan in any manner it deems necessary or appropriate. Although the Company has not expressed an interest to do so, it shall have the right, at any time, to suspend or discontinue its contributions under the Plan, and to terminate, at any time, this Plan, subject to the provisions of ERISA. In the event that the Plan should be terminated, the entire balance of the participant's account will become fully vested, and all remaining Plan assets shall be allocated to the participants as described in the full text of the Plan documents.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statement follows:

Basis of Accounting

The financial statements have been prepared in conformity with accounting principles generally accepted in the United States (“GAAP”). Plan financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of these financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make certain estimates and assumptions that affect the reported amounts of net assets available for plan benefits at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan investments are stated at fair market value. See Note 4 for discussion of fair value measurements. Purchases and sales are recorded on a trade-date basis. Interest and dividend income are recorded on the accrual basis.

Management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Employer and participant contributions are reported in the year services are rendered to the Company by the plan participants.

Realized and Unrealized Gain/Losses on Investments

The realized gain or loss on investments represents the difference between the proceeds at the transaction date and the cost or recorded value of the investment. Unrealized gains or losses on investments represent the net change at the year-end between current value and the recorded value of the investments at the time of purchase or the beginning of the year, whichever is later.

Risks and Uncertainties

The Plan provides for various investment options in any combination of stock, bonds, fixed income securities, mutual funds, and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for Plan benefits and the statement of changes in net assets available for Plan benefits.

Payments of Benefits

Benefits are recorded when paid.

Recently Issued Accounting Pronouncements

The Trustees have reviewed all recent accounting pronouncements issued by the FASB (including its Emerging Issues Task Force) and the AICPA and feel they did not or will not have a material impact on the Plan's present or future financial statements.

Subsequent events

The Plan Management has evaluated subsequent events for recognition and disclosure through October 7, 2025, which is the date the financial statements were available to be issued and has determined that there are no transactions that need to be recorded and the following transaction to be disclosed:

Subsequent to year end, the Company contributed \$890,461 to the Plan in satisfaction of the employer contribution receivable.

NOTE 3 - INCOME TAX STATUS

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan is designed in conformity with the applicable requirements of the Code. The Company and Plan management believe that the Plan is currently designed and operated in compliance with the applicable requirements of the Code, and the Plan continues to be tax exempt. Generally accepted accounting principles ("GAAP") require management to evaluate the tax position taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more than likely not would be sustained upon examination by the IRS. As the Plan is tax-exempt, the Plan Administrator has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the Financial Statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no IRS audits for any tax periods in progress. The Plan is subject to income tax examinations for years 2024, 2023, 2022, and 2021.

NOTE 4 - FAIR VALUE OF FINANCIAL INSTRUMENTS

The Plan has adopted ASC Topic 820-10 to measure the fair value of certain of its financial assets required to be measured on a recurring basis. ASC Topic 820-10 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). ASC Topic 820-10 defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants on the measurement date. A fair value measurement assumes that the transaction to sell the asset or transfer the liability occurs in the principal market for the asset or liability. The three levels of the fair value hierarchy under ASC Topic 820-10 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2024:

Mutual Funds, Employer Securities, and Self-directed Brokerage – Valued at the closing price reported on the active market on which the individual securities are traded.

Common/Collective Trusts – The fund manager calculates a net asset value per unit on the Fund's valuation date and the underlying investments of these funds are valued as described in their respective financial statements.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6 – RELATED PARTIES AND PARTIES-IN-INTEREST

Nationwide Financial Services, Inc., custodian of the Plan, its subsidiaries, and affiliates maintain and manage certain investments of the Plan, for which the Plan is charged investment and/or administrative expenses. The Plan also holds employer securities of Butler National Corporation which is a related party/party-in-interest to the Plan.

NOTE 7 – INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan provides the Nationwide Fixed Select Option Account, a fully benefit-responsive group annuity contract with a fixed rate of interest issued by Nationwide Financial Services, Inc. as an investment option for participants. The objective of this investment option is to guarantee principal and provide a stated interest crediting rate. The contract is included in the financial statements at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Under the existing contract, the composite crediting rate on participant accounts ranged from 1.96% to 2.32% during 2024. The weighted average interest crediting rate for 2024 was 2.14%. There are no reserves against contract value for credit risk of the contract issuer or otherwise. Certain events that may limit the ability of the Plan to transact at contract value are not probable of occurring.


