### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Nilit America, Inc. **Note 1 – Description of Plan**

---

The following description of the Nilit America, Inc. Retirement Savings Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

*General*

The Plan is a defined contribution plan covering all eligible employees of Nilit America, Inc. (the “Company”). Employees are eligible for entry to the Plan on the first day of the month following completion of age and service requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Contributions*

Participants may contribute a percentage of their compensation as a pre-tax or Roth deferral to the Plan and may also contribute amounts representing distributions from other qualified plans. Employees become eligible to participate after completing three months of service and attaining age 18. Participants of qualifying age may make additional “catch-up” contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company requires all participants to have twelve months of service to receive the Company’s contribution, unless they had previously contributed to another predecessor employer retirement plan. Effective March 31, 2023, predecessor employer service was no longer considered for eligibility. The Company matches 100% of the first 3% of a participant’s deferral contribution, plus 50% of each participant’s deferral contribution between 3% and 5% of the participant’s compensation. The Company’s Board of Directors may also decide to contribute a discretionary profit-sharing amount. No such amount was elected for the year ended December 31, 2024. Contributions are subject to certain limitations.

*Participant Accounts*

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and (b) Plan earnings and administrative expenses. Allocations are based on participant compensation or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Vesting*

Participants are immediately vested in their contributions and the Company’s portion of their account, plus actual earnings thereon.

*Payment of Benefits*

Upon termination of service due to death, disability, retirement, in-service, or other reasons, a participant may elect to receive a lump sum distribution, or periodic payments as defined in the Plan provisions.

*Notes from Participants*

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the present value of their account balance. Note terms range from one to five years unless the note is for purchase

of a primary residence, in which case the term may exceed five years. Notes are secured by the balance in the participant's account and bear interest at a rate of Prime + 1.00%. The interest rates ranged from 3.25% to 9.50% at December 31, 2024. Principal and interest are paid ratably through payroll deductions.

*Administrative Expenses*

Plan fees and administrative expenses are paid by the Company or the Plan on a discretionary basis. A portion of these fees and expenses were paid by the Plan for the year ended December 31, 2024.

**Note 2 – Summary of Significant Accounting Policies**

---

*Basis of Accounting*

The financial statements have been prepared on the accrual basis of accounting.

*Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect reported amounts and disclosures. Actual results may differ from those estimates.

*Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

*Notes from Participants*

Notes from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

*Payment of Benefits*

Benefits are recorded when paid.

Subsequent events have been evaluated through October 8, 2025, the date the financial statements were available to be issued.

**Note 3 – Fair Value Measurements**

---

The Plan’s investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs were used when Level 1 inputs were not available.

The following table sets forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

**Note 6 – Tax Status**

The Plan is an adoption of a non-standardized 401(k) plan previously sponsored by Ascensus, Inc. Effective March 31, 2023, the Plan document was restated to a non-standardized 401(k) profit sharing plan sponsored by Paychex, Inc. The Internal Revenue Service has determined by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the *Internal Revenue Code (IRC)*. The Plan has been amended; however, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the *IRC*.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

**Note 1 – Description of Plan**

---

The following description of the Nilit America, Inc. Retirement Savings Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

*General*

The Plan is a defined contribution plan covering all eligible employees of Nilit America, Inc. (the “Company”). Employees are eligible for entry to the Plan on the first day of the month following completion of age and service requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Contributions*

Participants may contribute a percentage of their compensation as a pre-tax or Roth deferral to the Plan and may also contribute amounts representing distributions from other qualified plans. Employees become eligible to participate after completing three months of service and attaining age 18. Participants of qualifying age may make additional “catch-up” contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company requires all participants to have twelve months of service to receive the Company’s contribution, unless they had previously contributed to another predecessor employer retirement plan. Effective March 31, 2023, predecessor employer service was no longer considered for eligibility. The Company matches 100% of the first 3% of a participant’s deferral contribution, plus 50% of each participant’s deferral contribution between 3% and 5% of the participant’s compensation. The Company’s Board of Directors may also decide to contribute a discretionary profit-sharing amount. No such amount was elected for the year ended December 31, 2024. Contributions are subject to certain limitations.

*Participant Accounts*

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution and (b) Plan earnings and administrative expenses. Allocations are based on participant compensation or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Vesting*

Participants are immediately vested in their contributions and the Company’s portion of their account, plus actual earnings thereon.

*Payment of Benefits*

Upon termination of service due to death, disability, retirement, in-service, or other reasons, a participant may elect to receive a lump sum distribution, or periodic payments as defined in the Plan provisions.

*Notes from Participants*

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the present value of their account balance. Note terms range from one to five years unless the note is for purchase

of a primary residence, in which case the term may exceed five years. Notes are secured by the balance in the participant's account and bear interest at a rate of Prime + 1.00%. The interest rates ranged from 3.25% to 9.50% at December 31, 2024. Principal and interest are paid ratably through payroll deductions.

*Administrative Expenses*

Plan fees and administrative expenses are paid by the Company or the Plan on a discretionary basis. A portion of these fees and expenses were paid by the Plan for the year ended December 31, 2024.

**Note 2 – Summary of Significant Accounting Policies**

---

*Basis of Accounting*

The financial statements have been prepared on the accrual basis of accounting.

*Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect reported amounts and disclosures. Actual results may differ from those estimates.

*Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

*Notes from Participants*

Notes from participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

*Payment of Benefits*

Benefits are recorded when paid.

*Subsequent Events*

Subsequent events have been evaluated through October 8, 2025, the date the financial statements were available to be issued.

---

**Note 3 – Fair Value Measurements**

---

The Plan’s investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs were used when Level 1 inputs were not available.

The following table sets forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

**Note 4 – Related Party Transactions**

---

Certain employees of the Plan’s Sponsor provide administrative and accounting services to the Plan at no additional cost to the Plan. These employees are also participants of the Plan.

Fees paid to Merrill Lynch, the investment manager, and Paychex, Inc., the recordkeeper, amounted to \$25,044 for the year ended December 31, 2024.

**Note 5 – Plan Termination**

---

Although they have not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA.

---

**Note 6 – Tax Status**

---

The Plan is an adoption of a non-standardized 401(k) plan previously sponsored by Ascensus, Inc. Effective March 31, 2023, the Plan document was restated to a non-standardized 401(k) profit sharing plan sponsored by Paychex, Inc. The Internal Revenue Service has determined by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the *Internal Revenue Code (IRC)*. The Plan has been amended; however, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the *IRC*.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
