## INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of  
Retirement Plan for Bargaining Unit Employees of Landis+Gyr  
Alpharetta, Georgia

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Retirement Plan for Bargaining Unit Employees of Landis+Gyr (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended and the related notes to the financial statements (Financial Statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's Financial Statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the Financial Statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying Financial Statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying Financial Statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Emphasis of Matter - Change in Accounting Policy**

As further discussed in Note 2 to the financial statements, Plan Management has elected to change the presentation of the accumulated plan benefits from an end-of-year presentation to a beginning-of-year presentation effective in the 2024 Financial Statements. As a result, the presentation of amounts reported in Note 5 have been revised to conform to beginning-of-year presentation. Our opinion is not modified with respect to this matter.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these Financial Statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the Financial Statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the

effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the Financial Statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



### NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

#### NOTE 1 - DESCRIPTION OF PLAN

The following brief description of the Retirement Plan for Bargaining Unit Employees of Landis+Gyr (the "Plan") is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### GENERAL

The Plan is a contributory defined benefit plan sponsored by Landis+Gyr Technology, Inc. (the "Company"). The Plan covers all hourly, non-supervisory bargaining unit employees of the Company, who are represented by Local 812 of the International Union of Electronic, Electrical, Salaried, Machine, and Furniture workers, a division of Communications Workers of America. Employees become eligible to participate in the Plan after attaining age 18 and completing one year of qualifying service, as defined by the Plan.

In 2005, layoffs by the Company resulted in a partial termination of the Plan, and all participants became 100% vested as of March 31, 2005. There are no active participants in the Plan. Further benefit accruals under the Plan were also frozen as of close of business, March 31, 2005.

Effective June 30, 2020, the Plan was amended. Included in the amendment was a plan name change to Retirement Plan for Bargaining Unit Employees of Landis+Gyr; the Sponsor name was changed to Landis+Gyr Technology, Inc. All other material terms and conditions remained the same.

#### TRUSTEE AND ADMINISTRATION

In December 2021, the Company appointed Principal Trust Company as the trustee of the Plan. Principal Trust Company holds all assets of the Plan.

#### PARTICIPANT CONTRIBUTIONS

Prior to the partial termination of the Plan in 2005, active participants made annual contributions to the Plan equal to 1.5% of annual compensation, as defined by the Plan, through weekly payroll deductions. Employees who did not contribute to the Plan did not receive credited service, as defined by the Plan.

#### PENSION BENEFITS

A participant with at least five years of qualifying service is entitled to an annual pension benefit beginning at his or her normal retirement date (generally age 65), as defined by the Plan.

A participant at his or her normal retirement date is entitled to annual pension benefits for life, equal to the greater of:

- The sum of 60% of the aggregate amount of contributions made by the participant under the Plan on and before December 31, 1987, plus 120% of the aggregate amount of contributions made by the participant under the Plan on and after January 1, 1988.
- The unit of retirement income that corresponds to the participant's date of retirement or other termination of employment (\$324 on or after January 1, 2005) multiplied by the participant's full years of credited service, as defined by the Plan.

The Plan permits early retirement with a reduced benefit, provided the participant has reached age 55. If benefit payments are commenced before age 65, the early retirement benefit will be further reduced by 5% for each year between ages 60 and 65, and 4% for each year before age 60. Effective January 1, 2004, the Plan was amended to permit certain participants to elect a retroactive annuity starting date for benefit payments. This election must have been made by December 31, 2004.

Effective January 1, 2004, if a participant's termination of employment was the result of a layoff, the participant could take a lump-sum distribution within one year from the expiration date of recall rights. If a participant's termination of employment was not the result of a layoff, the participant could take a lump-sum distribution within one year from the date of termination.

Effective November 5, 2004, any participant who had attained age 58 and had been credited with ten years of credited service as of the termination date, was entitled to elect a special early retirement option. The participant's election must have been made by December 31, 2004. The participant's benefit must have started 12 months after the termination date. A participant electing this option received the full, unreduced accrued benefit amount.

#### DEATH BENEFITS

The Plan provides for pre-retirement and post-retirement death benefits, as follows:

**Pre-Retirement** - If a participant not eligible for a vested benefit dies, the beneficiary will receive an amount equal to the accumulated contributions with credited interest payable in a lump sum. If a married participant eligible for a vested benefit dies prior to meeting requirements for early retirement, the surviving spouse will receive the greater of accumulated contributions, or the amount that would have been received had the participant lived to the date when first meeting the eligibility requirements for early retirement and retired, having elected the 50% contingent annuity option (based on the benefit accrued to date of death). If a married participant eligible for early retirement dies, the surviving spouse will receive the greater of the accumulated contributions, or a lifetime benefit equal to the benefit that would have been received had the participant retired on the first day of the month in which death occurred, having elected the 50% contingent annuity option.

**Post-Retirement** - The benefit payable is equal to the annuity payment option provided under the Plan, as elected by the participant at the time of retirement.

#### DISABILITY BENEFITS

If a participant becomes totally and permanently disabled, they may continue to earn credit toward retirement benefits, as long as they remain disabled. Pension benefits are available at age 65. The benefits are based on average compensation as of the date of disability and years of service as if the employee had continued to work until his or her normal retirement date.

#### ADMINISTRATIVE EXPENSES

All applicable administrative expenses, including trustee, actuary, and audit fees, may be paid by the Plan.

#### FUNDING POLICY

Contributions by the Company are determined annually by actuarial valuations of the Plan by an independent actuary. The actuary determines the maximum amount permitted by law or regulation as a federal income tax deduction, and the minimum amount necessary during any Plan year to avoid an accumulated funding deficiency, as defined by ERISA. No Company contributions were required for the years ended December 31, 2024 and 2023 which meets the minimum funding requirements of ERISA.

#### NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

##### BASIS OF ACCOUNTING

The financial statements of the Plan are prepared under the accrual method of accounting.

##### CHANGE IN ACCOUNTING POLICY

Management has elected to change the presentation of the accumulated plan benefits from an end of year presentation to a beginning of year presentation effective with the December 31, 2024 financial statements. This change has no impact on the calculation of the accumulated plan benefits or changes therein and represents only a change in the timing of the financial statement presentation of these amounts.

##### ESTIMATES

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein; disclosure of contingent assets and liabilities; and the actuarial present value of accumulated plan benefits at the date of the financial statements, and changes therein. Accordingly, actual results could differ from those estimates. The actuarial present value of accumulated plan benefits is particularly subject to change in the near term.

##### INVESTMENT VALUATION AND INCOME RECOGNITION

The investments of the Plan are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### PAYMENT OF BENEFITS

Benefits are recorded when paid.

### NOTE 3 - CERTIFIED INVESTMENT INFORMATION

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and investment income for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Life Insurance Company ("Principal"), a qualified institution. The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related information included in the financial statements and ERISA-required supplemental schedules.

### NOTE 4 - FAIR VALUE MEASUREMENT

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds*. Valued at the published daily net asset value ("NAV") as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

- *Pooled* separate account. Valued at the net asset value ("NAV") of units of participation held in the pooled separate account, as reported by the issuer insurance company, based on the value of underlying investments in the pooled separate account. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the pooled separate account will sell the investments at an amount different than the reported NAV. The investment strategy is to maintain liquid short term assets in the pooled separate account. The pooled separate account provides for daily redemptions by the Plan with no advance notice requirements and has redemption prices that are determined by the account's net asset value per unit.
- *Collective trusts*: Valued at the net asset value ("NAV") of units of a bank collective trust. The NAV, as provided by the trustee or custodian of the collective trust, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The collective trust invests in mutual funds with investment-grade bonds. Participant transactions (purchases and sales) may occur daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - ACTUARIAL PRESENT VALUE OF ACCUMULATED PLAN BENEFITS**

Accumulated plan benefits are those estimated future periodic payments, including lump-sum distributions, that are attributable under the Plan's provisions to services rendered by the employees to the valuation date. Accumulated plan benefits include benefits expected to be paid to: (a) retired or terminated employees or their beneficiaries, and (b) present employees or their beneficiaries. Benefits for retired or terminated employees or their beneficiaries are based on average compensation, as defined, and years of credited service as of the date of retirement or termination. The accumulated plan benefits for active employees are based on employee contributions and years of credited service as of the valuation date. Benefits payable under all circumstances (retirement, death, disability, and termination of employment) are included to the extent they are deemed attributable to employee service rendered to the valuation date.

An actuary estimates the actuarial present value of accumulated plan benefits, which is the amount that results from applying actuarial assumptions to adjust the accumulated plan benefits earned by the participants to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

**NOTE 6 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, liquidity, political uncertainty, pandemic environmental risks, cybersecurity and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Plan contributions are made and the actuarial present value of accumulated benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

#### **NOTE 7 - TRANSACTIONS WITH PARTIES-IN-INTEREST**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. The Plan held investments managed by Principal, which qualify as party-in-interest transactions. Some fees paid by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of investments. During 2024 and 2023, the Plan paid administrative fees to Principal and Cambridge Investment Research and paid audit fees to Kruggel Lawton which also qualify as party-in-interest transactions.

#### **NOTE 8 - PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to completely terminate the Plan subject to the provisions set forth in ERISA. In the event the Plan is terminated, the net assets of the Plan will be allocated for payment of Plan benefits to the participants in order of priority determined in accordance with ERISA, applicable regulations thereunder, and the Plan document.

Certain benefits under the Plan are insured by the Pension Benefit Guaranty Corporation (PBGC) if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivors' pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination, subject to a statutory ceiling on the amount of an individual's monthly benefit.

Whether all participants receive their benefits, should the Plan be terminated at some future time, will depend on the sufficiency, at that time, of the Plan's net assets to provide those benefits, the priority of those benefits to be paid, and the level and type of benefits guaranteed by the PBGC at that time. Some benefits may be fully or partially provided for by the then existing assets and the PBGC guaranty, while other benefits may not be provided for at all.

#### **NOTE 9 - TAX STATUS**

The IRS has determined and informed the Company by a determination letter dated June 23, 2020, stating that the Plan is qualified under Section 401(a) of the Internal Revenue Code (IRC) and, therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. Although the Plan has been amended since receiving the determination letter, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that no uncertain positions are taken or are expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Target normal cost is based on benefits expected to accrue during the current plan year and includes an estimate of plan expenses for the year.

Methods selected by plan sponsor

Asset method

The asset valuation method is prescribed by law for plans that elect to use a value other than market value.

For each of the preceding two years, an expected value of assets at the end of the year is compared to the end of year market value. The resulting gain or loss is recognized evenly over three plan years.

The expected value includes contributions, distributions, any deducted administrative expenses, and expected earnings (based on the lesser of the assumed interest rate or the maximum allowable rate). The deferred gains and losses are added to the current market value and then restricted to no more than 110% and no less than 90% of that market value.

When actual returns exceed the assumed return, the actuarial value of assets will lag below market value. The lag and the smoothing effect are limited since the value must be within 10% of market value.

Segment rates

The Society of Actuaries (SOA) is an actuarial organization that periodically reviews mortality data and publishes mortality tables and improvement scales. In October 2019, the SOA released the Pri-2012 Mortality Tables for private-sector retirement plans in the U.S. The Pri-2012 report contains different sets of mortality tables based on complete dataset or various subsets. The Blue collar base rate table was selected based on information provided by the plan sponsor.

Pri-2012 section 12.4. provided three approaches for designated beneficiaries in the calculation of joint-and-survivor annuities. We believe “Approach 1” is reasonable for this plan.

**Mortality improvement** MP-2021 is the most recent improvement scale published by the SOA in October 2021.

In selecting this assumption, we considered the other parameters available in the MIM-2021-v4 application tool issued by the SOA in October 2023 and consider the selections in MP-2021 reasonable. Based on the sponsor’s input, plan experience does not show a need for long-term excess death or Covid death load adjustments.

Treatment of administrative expenses

No adjustments are made for administrative expenses, either through a reduction in the discount rate or by calculating a present value of future expenses.

Plan sponsors may change their administrative expense handling at any time. Our approach provides consistent handling of ASC 960 liabilities from year to year, whether expenses are paid with plan assets or directly by the employer.

Note - expenses paid with plan assets are required to be included in funding normal cost. As a result, the plan is reimbursed annually through required funding. Exception – contributions are not required due to assets sufficiently in excess of liabilities to fund both expenses and normal cost. In this case, administrative expenses are taken from the excess assets.

#### Early retirement benefit

The optional form conversion basis is 6% interest and the 1971 TPF&C Forecast Mortality Table for payments other than lump sums.

#### Lump sum provisions

Small amount force out (SAFO) – allowed up to \$7,000.

Lump sums in excess of SAFO - aren't allowed.

Conversion – deferred rate with early retirement factor based on the applicable interest rate and applicable mortality table as set forth in Code Section 417.

The applicable interest rate uses the fifth calendar month preceding the first day of the stability period which is the plan year.

#### Changes in Principal Eligibility or Benefit Provisions

There have been no changes in principal eligibility or benefit provisions since the last valuation.

Certain non-prescribed assumptions have been changed since last year. These assumptions were changed to better reflect the anticipated experience of your plan. See the attachment, Part V – Statement of Actuarial Assumptions/Methods, for the rationale for each assumption.

The assumed asset return for the current year has decreased from 5.75% to 5.50%. This rate is used in the calculation of the actuarial value of plan assets.
