Report of Independent Auditors

To the Administrator of MyEyeDr. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of MyEyeDr. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, including the related notes (collectively referred to as the "financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Basis for Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Notes to Financial Statements

December 31, 2024 and 2023

1. Description of the Plan

The following description of the MyEyeDr. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Principal Financial Group Pre-Approved Basic Saving Plan - Plus (the “Plan Document”) as of June 30, 2020, and the most recent amendment effective January 1, 2024, for a more complete description of the Plan’s provision.

General

The Plan, established on June 1, 2004, is a defined contribution plan covering all employees of Capital Vision Services, LP and its affiliated companies, which was converted to Capital Vision Services, LLC on August 29, 2019, and is collectively referred to as the “Company”, “MyEyeDr”, “Employer”, “Plan Administrator” or “Plan Sponsor.” This Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Plan Administration

The Company is the Plan’s named fiduciary and Plan Administrator. Principal Trust Company (“Principal” or “Trustee”) is the trustee of the Plan. Principal Life Insurance Company (“Insurance Company” or “PLIC”) provides the investment contract discussed in Note 6.

Eligibility

All employees, regardless of age, but excluding part-time, temporary or seasonal employees whose regularly scheduled service is less than 1,000 hours of service within a consecutive twelve months, are eligible to participate in the Plan. An eligible employee becomes a participant in the Plan on the date all the eligibility requirements are met, and deferrals commence as soon as administratively feasible following an employee’s satisfaction of the eligibility requirements and election to contribute.

Contributions

Participants can contribute up to the maximum amount allowed by the Internal Revenue Code (“IRC”). Contributions are subject to certain limitations. Participants may designate all or a portion of their contributions as Roth contributions. When eligible, the Company makes matching contributions to participants each pay period, not to exceed 3% of the participant’s compensation, plus 50% of the amount of the participant’s elective deferrals that exceed 3% of the participant’s compensation but do not exceed 5% of the participant’s compensation.

Prior to 2024, any Highly Compensated Employees (“HCEs”), per IRS rules and regulations, did not receive any matching contributions from the Company. Instead, the HCEs received the Safe Harbor Match. Starting on January 1, 2024, the Plan Sponsor updated the Plan’s guidelines to make the contribution to HCEs’ 401(k) plans for 1% of the HCEs’ compensations.

The Plan Sponsor can separately make discretionary contributions, which in each Plan Year are in an amount determined by the Plan Sponsor. No such discretionary contributions were made for the year ended December 31, 2024.

The Plan qualifies as a safe harbor plan.

Notes to Financial Statements

December 31, 2024 and 2023

Vesting

Participants are immediately vested in their contributions, and Company matching contributions plus earnings thereon at all times. Company discretionary contributions, plus actual earnings thereon, vest incrementally, based on years of continuous service as follows:

1 year	20 %
2 years	40
3 years	60
4 years	80
5 years	100

Participants become fully vested upon reaching the age of 65, death or permanent disability.

Forfeitures

Upon withdrawal of a participant's vested balance, any nonvested balance is forfeited and is used to offset Plan expenses or to reduce future Company contributions. As of December 31, 2024 and 2023, there were no forfeited nonvested amounts. There were no forfeited participant's vested balance amounts available for allocation during the years ended December 31, 2024 and 2023.

Investment Options

Each participant has the responsibility of determining how the funds in his or her account are invested. Participants may invest their contributions in various mutual funds, a self-directed brokerage account, various pooled separate accounts and a fully benefit-responsive investment contract.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions; and (b) Plan earnings (losses), net of administrative expenses. Allocations are based on the participant's eligible compensation, deferrals or account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable From Participants

A participant may borrow a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of the participant's vested account. No more than one loan can be outstanding at one time. The loans are secured by the balance in the participant's account and bear interest at rates equal to the Wall Street Journal Prime rate plus 2%. All loans must be repaid within five years, except those that are used for the purchase of a principal residence, in which case the loan repayment period may extend beyond five years from the date of the loan, but the extended period shall be consistent with commercial home loan practices. Repayment of the loan are made through after-tax payroll deductions. As of December 31, 2024, interest rates for the notes receivable from participants ranged from 3.25% to 10.50%. As of December 31, 2023, interest rates ranged from 3.25% to 10.50%.

Related loan administration fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits

Benefits may be paid to the participant or beneficiary upon death, disability, retirement, financial hardship, qualified domestic relation order, or termination of employment, as defined in the Plan agreement. The Plan provides for normal retirement at age 65. The total vested portion of a participant's account balance is generally distributed in the form of a lump-sum payment. The Plan also has a cash-out provision. Any account balance less than \$1,000 is automatically cashed out upon a distribution event.

Partial withdrawals or installments are only permitted for required minimum distributions under IRC 401(a)(9). In-service distributions can be made to participants who have not separated from service provided that the participant attained the age of 59 1/2. Participants experiencing financial hardship may withdraw a portion of their account balance as defined in the Plan document.

Administrative Expenses

The Company provides certain accounting and administrative services to the Plan, for which no fees are charged. All such services qualify as party-in-interest transactions and are exempt from the prohibited transaction rules. The Company did not pay any of the Plan's administrative expenses for the year ended December 31, 2024.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to reduce or discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in any unvested amounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from management's estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the Plan's direct investment in the fully benefit-responsive investment contract, which is reported at contract value. The Plan Administrator determines the Plan's valuation policies utilizing information provided by Principal. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the amount that Plan participants would receive, if they were to initiate permitted transactions under the terms of the Plan (Note 6). See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risks and Uncertainties

The Plan provides for various investment options to its participants. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which participant compensation is earned. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan agreement. Delinquent amounts reclassified as distributions were \$328,111 for the year ended December 31, 2024.

Payment of Benefits

Benefit payments are recorded when paid.

3. Information Provided and Certified by Trustee

The following is a summary of the information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan's financial statements, notes to financial statements and the supplemental Schedule of Assets (Held at End of Year) that were obtained or derived from information provided by the Trustee and furnished to the Plan Administrator. 5. Fair Value Measurements

The Accounting Standards Codification (“ASC”) Topic 820: *Fair Value Measurements and Disclosures* (“ASC 820”), issued by the Financial Accounting Standards Board (“FASB”), provides a framework for measuring fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring the use of observable inputs when available. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Asset Valuation Techniques

Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds

Valued at the daily closing price as reported by the fund, if available. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission (“SEC”). These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-Directed Brokerage Account

All holdings in this account are publicly traded securities. This account is valued at the aggregated fair value of its underlying securities.

Pooled Separate Accounts

Valued at NAV per unit based on quoted market prices of underlying investments. The NAV as provided by the Trustee is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the pooled separate account, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to confirm that securities liquidations will be carried out in an orderly business manner.

Noninterest Bearing Cash

The noninterest bearing cash is liquid and observable with unadjusted quoted price.

6. Traditional Guaranteed Investment Contract With Principal Life Insurance Company

The Plan holds a fully benefit-responsive guaranteed investment contract (GIC) provided by PLIC. PLIC maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The GIC is included in the financial statements at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

7. Tax Status

The Plan uses a prototype plan document sponsored by Principal Financial Group. The prototype plan has received an opinion letter dated June 30, 2020 from the Internal Revenue Service stating that the written form of the underlying prototype plan document is qualified under Section 401(k) of the Internal Revenue Code ("IRC") and that any employer adopting this form of the Plan will be considered to have a plan qualified under Section 401(k) of the IRC. The adoption agreement has been amended since the receipt of the opinion letter; however, Plan management and tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and; therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan Sponsor to evaluate tax positions taken by the Plan and to recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan Sponsor has determined that, as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits

by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Therefore, no provision for income tax has been included in the Plan's financial statements. The Plan Sponsor believes it is no longer subject to income tax examinations for the years prior to 2021.

8. Related Party and Party-in-Interest Transactions

Certain Plan investments are units of investment managed by the Trustee or an investment contract provided by the Insurance Company, and therefore, these transactions qualify as party-in-interest transactions. Accordingly, fees paid by the Plan for investment management services by the Trustee and Insurance Company are party-in-interest transactions. The Plan incurred administrative expenses of \$445,102 for the year ended December 31, 2024 that are permissible party-in-interest transactions under ERISA. The Plan also issues loans to participants under the deferred arrangement portion of the Plan, which are secured by the vested balances in the participants' accounts.

9. Subsequent Events

The Plan evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued. During this period, no material recognizable subsequent events beyond that stated below were identified that would require disclosure in these financial statements.

Effective January 1, 2025, the Company changed the Trustee of the Plan to Fidelity. On December 31, 2024, Principal liquidated \$160,161,424 and initiated a transfer of these funds to Fidelity. As of December 31, 2024, these funds remained in Principal's custody, in the form of noninterest bearing cash. On January 2, 2025, the transfer of \$160,161,424 was delivered to Fidelity. Subsequent to January 2, 2025, Principal transferred the remaining investments held in its custody to Fidelity.
