We have performed an audit of the financial statements of Tri/Mark Corporation 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### Notes to Financial Statements

---

#### Note 1. Plan Description

The following description of the Tri/Mark Corporation 401(k) Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering substantially all employees of Tri/Mark Corporation (the Company) who have completed 60 days of service. Eligible employees are automatically enrolled in the Plan with a deferral amount of 3% of their eligible compensation unless the employee elects otherwise. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Participant accounts:** Participants may direct the investment of their account balances by selecting among different investment alternatives provided by the Plan. Participants are allowed to change investment options on a periodic basis as allowed by the Plan Administrator. Each participant's account is credited with the participant's contributions and an allocation of: (a) the Company's matching contribution, if any, (b) the Company's discretionary contribution, if any, (c) plan earnings (losses) and (d) Plan administrative expenses. Allocations are based on participant earnings (losses) or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Contributions:** Participants may contribute a portion of their salary in the form of a salary reduction not to exceed 100% of their eligible compensation. Participants may elect to contribute a Roth 401(k) that would allow the participant to make after-tax contributions. Contributions may not exceed the limits of code Section 401(k). Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Plan allows the Company to make discretionary matching contributions. There were no matching contributions made for the year ended December 31, 2024. The Plan also allows the Company to make discretionary profit-sharing contributions. There were no discretionary profit-sharing contributions for the year ended December 31, 2024.

**Vesting:** Participants are immediately vested in their salary deferral contributions and actual earnings thereon. Vesting in the Company contributions and related earnings are based on years of service. Participant's vest 20% per year and are fully vested after five years of service.

**Forfeitures:** Forfeitures of terminated participants' nonvested accounts are used to reduce future employer contributions. There were no forfeitures used to reduce employer contributions for the year ended December 31, 2024, and no material unused forfeitures existed at December 31, 2024 and 2023.

**Payment of benefits:** On termination of service or other certain qualifying situations, a participant may receive a lump-sum amount equal to the vested value of his or her account, substantially equal installments or partial withdrawals greater than \$1,000. Participant accounts equal to or less than \$1,000 prior to the commencement of benefits shall be distributed in a single lump sum. In addition, upon reaching 59½, a participant may elect to withdraw all or a portion of their vested account balance. Participants are also allowed to withdraw benefits in the event of financial hardship. Hardship withdrawals are limited to the participant's vested account balance.

**Rollovers from ESOP:** Participants in the Tri/Mark Corporation Employee Stock Ownership Plan (ESOP) age 55 and over and having 10 years of participation in the ESOP are eligible to diversify 25% to 50% of their ESOP balance into this Plan.

#### Note 2. Summary of Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared under the accrual basis of accounting.

**Contributions:** Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Risks and uncertainties:** The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of benefits:** Benefits are recorded when paid.

**Administrative expenses:** Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. The Plan paid administrative expenses of \$73,428 for the year ended December 31, 2024.

**Subsequent events:** The Plan Administrator has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

#### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

**Mutual funds:** Valued at the closing price reported on the active market on which the mutual funds are traded.

**Common collective trust fund (CCT):** The CCT is valued at net asset value (NAV). The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchase and sales) may occur daily. Were the Plan to initiate a full redemption of the CCT, the investment advisor reserves the right to temporarily delay the withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. There were no unfunded commitments as of December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Changes in fair value levels:** To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Level 3.

#### Note 5. Income Tax Status

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

#### **Note 5. Income Tax Status (Continued)**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination, all amounts credited to a participant's account will become 100% vested.

#### **Note 7. Related-Party Transactions and Party-in-Interest Transactions**

Certain investments are managed by Empower Trust Company, LLC. Empower Trust Company, LLC is the custodian as defined by the Plan and, therefore, those transactions qualified as party-in-interest transactions.
