Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of **The Village Network 403(B) Plan**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. 

NOTE A – DESCRIPTION OF THE PLAN

The following description of **The Village Network 403(B) Plan** (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Village Network (the "Organization") established the plan effective April 1, 1995 and has been amended on various dates. The Plan is a contributory tax deferred plan established under section 403(B) of the Internal Revenue code and covers all full-time and part-time employees of the Organization who normally work 20 or more hours per week and have one year of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Organization is the Plan Administrator and is responsible for the day-to-day operation of the Plan. They designate other parties to perform certain duties.

The Plan's trustees are **Lincoln National Life Insurance Company & CMFG Life Insurance Company/Matrix Trust Company**.

Tax Status

The Internal Revenue Service has determined by letter dated **March 31, 2008** that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code ("IRC"). The Plan administrator believes that the Plan is designed and is currently being operated in compliance with applicable provisions of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Organization's matching contribution, and an allocation of Plan earnings. Allocations are based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeited Accounts

Forfeitures are all allocated first to plan expenses, then to fixed non-elective contributions and last to fixed matching contributions. During the years ended **December 31, 2024** and **2023**, terminated non-vested participants forfeited **\$172,984** and **\$69,793** respectively, in Organization contributions. The Organization used forfeitures of **\$28,260** and **\$-0-** in **2024** and **2023**, respectively, to reduce Organization contributions and **\$11,279** and **\$-0-** of the forfeitures in **2023** and **2022** to reduce plan expenses, respectively. At **December 31, 2024** and **2023** forfeited non-vested accounts totaled **\$118,668** and **\$4,575**, respectively.

Contributions

Each year **The Village Network** matches the contributions of each of its participating employees. The match is **50%** of a qualified participant's elective deferral up to **7%** of his/her compensation. Non-elective contributions are made by the Organization as follows: a fixed amount of **5%** of each participant's compensation, per plan year; and an additional discretionary employer contribution based on years of service. Participating employees make contributions to the Plan according to their written wage reduction agreement not to exceed the maximum amount allowed by the IRS.

Contributions are subject to certain limitations. The Organization withholds & remits to the trustee bi-weekly contributions in an amount in accordance with the participant's written wage reduction agreement.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the organization contributions portion of their accounts plus earnings thereon is based on years of continuous service. A participant is **100%** vested after **three** years of credited service.

Net assets available for benefits include the accounts of active participants, as well as certain separated, vested and retired participants who have elected to receive their benefits in installment payments. These participants share in the earnings of the investments.

Investment Options

Upon participation in the Plan, a participant may direct contributions in one or more of the investment funds provided under the Plan. Separate accounts are maintained for elective contributions, matching contributions and discretionary contributions. Participants may change their investment options at their own discretion.

Participant Loans

Notes receivable from participants are measured at their unpaid principal balance. Participants may borrow from their fund accounts a minimum of **\$1,000** up to a maximum equal to the lesser of **\$50,000** or **50%** of their account balance. The loans are secured by the balance in the participant's account and bear interest at a rate of Prime plus **1%** (ranging from **4.25%** to **9.50%**). No allowance for credit losses has been recorded as of **December 31, 2024** and **2023**.

Payment of Benefits

On termination of service due to death, disability, or retirement a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or in annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Hardship Distribution

In certain hardship situations, as described in the Plan agreement, participants may withdraw part of their account balances while actively employed, but such withdrawals are limited to the amount dictated by the hardship.

Plan Termination

Although it has not expressed any intent to do so, **The Village Network** has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan termination, participants will become **100%** vested in their accounts.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

This summary of significant accounting policies of **The Village Network 403(B) Plan** is presented to assist in understanding the Plan's financial statements. The financial statements and notes are representations of the Plan's management who is responsible for the preparation and fair presentation of the financial statements. These accounting policies conform to the modified cash basis of accounting and have been consistently applied in the preparation of the financial statements.

Basis of Accounting

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Fair Value of Financial Instruments

Financial Accounting Standards Board *Accounting Standards Codification* (FASB ASC) 825 requires disclosures about the fair value for all financial instruments, whether or not recognized, for financial statement purposes. Disclosures about fair market value of financial instruments are based on pertinent information available to management as of **December 31, 2024** and **2023**. Accordingly, the estimates presented in these statements are not necessarily indicative of the amounts that could be realized on disposition of the financial instruments.

Investment Valuation and Income Recognition

The Plan's investments are held by contracts with insurance companies and are valued at contract value (**Note F**). Marketable securities are stated at fair value. The change in the difference between fair value and the cost of the investments is reflected in the statements of changes in net assets available for benefits as net appreciation (depreciation) in fair value of investments.

Administrative Expenses

Trustee fees and other costs of administering the Plan are paid by the Organization. Certain administrative and clerical functions are performed by Organization employees at no charge to the Plan.

Risks and Uncertainties

The Plan provides for various investment options in any combination of money market funds, mutual funds, exchange traded funds and fully benefit responsive investment contracts. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participant account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

Reclassifications

Certain accounts in the prior-year financial statements have been reclassified for comparative purposes to conform with the presentation in the current-year financial statements.

Subsequent Events

Management has evaluated subsequent events through **October xx, 2025**, the date on which the financial statements were available to be issued. No additional events occurred that would require adjustments to, or disclosures in the financial statements.

NOTE D – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The plan has entered into investment contracts with Lincoln National Life Insurance Company and Matrix Life Insurance Company. These contracts meet the fully-benefit responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participants withdrawals, and administrative expenses.

The traditional investment contracts held by the Plan are guaranteed investment contracts. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The credit rating is based on a formula established by the contract issuer. The credit rate is reviewed on a quarterly basis for resetting.

Certain events may limit the ability of the plan to transact at contract value. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or other withdrawal restrictions may apply. If the plan sponsor views the occurrence of any of these events as probable as of the measurement date, details about market value adjustments or other withdrawal restrictions can be obtained through the plan’s account manager.

The issuer may terminate the contract with 30 days advance written notice to the contract owner for reasonable cause, which includes the contract owner’s failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain assets of at least **\$5,000**, plan disqualification, and failure to adopt the plan in a reasonable period of time. Upon termination by the issuer, a market value adjustment or other withdrawal restrictions may apply. The plan sponsor may choose to pay the market value adjustment directly, if applicable, so that participants’ contract values are not affected.

NOTE F – FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- a. Quoted prices for similar assets or liabilities in active markets
- b. Quoted prices for identical or similar assets or liabilities in inactive markets
- c. Inputs other than quoted prices that are observable for the asset or liability
- d. Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable inputs for the asset or liability.

The classification of fair value measurements within the hierarchy is based upon the lowest level of input that is significant to the measurement. Valuation methodologies used for assets and liabilities measured at fair value are as follows:

- Mutual funds: Valued at closing price reported on the active market in which the individual securities are traded.

Money Market Funds

A money market fund that is composed seeking to provide current income while maintaining liquidity and a stable share price of \$1. The fund invests at least 99.5% of its total assets in cash, U.S. government securities, and/or repurchase agreements that are collateralized solely by U.S. government securities or cash (collectively, government securities). This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily.

Transfers Between Levels

For years ended **December 31, 2024** and **2023**, there were **no** transfers between Levels 1 and Level 2 and no transfers in or out of Level 3.

NOTE G – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE H – PARTIES-IN-INTEREST

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services for the Plan, and employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent of more of such employer or employee association, or relatives of such person. **Lincoln National Life Insurance Company, Matrix Trust Company, CMFG Life Insurance Company (CUNA Mutual), CPI Qualified Plan Consultants, Inc., Creative Retirement Systems, Inc., Gallagher Fiduciary Services, LLC, and Kestra Investment Services, LLC.** are the service providers.

Reportable direct expenses on the 5500 were paid to **CUNA Mutual** for various recordkeeping administrative services in the amount of **\$38,828** and **\$50,146** for **2024** and **2023**, respectively. Reportable direct expenses on the 5500 were paid to **Creative Retirement Systems, Inc.** for various third-party administrative recordkeeping administrative services in the amount of **\$21,400** and **\$9,000** for **2024** and **2023**, respectively. Reportable direct expenses on the 5500 were paid to **Gallagher Fiduciary Services, LLC** for advisory services in the amount of **\$19,201** and **\$22,235** for **2024** and **2023**, respectively. Reportable indirect expenses on the 5500 were paid to **Lincoln National Life Insurance Company** for service provider services in the amount of **\$950** and **\$925** for **2024** and **2023**, respectively. Reportable indirect expenses on the 5500 were paid to **Kestra Investment Services, LLC** for investment management in the amount of **\$-0-** and **\$12,048** for **2024** and **2023**, respectively.

Certain administration functions are performed by officers and employees of the Organization (who also may be participants in the Plan) at no cost to the Plan. These transactions are not deemed prohibited party-in-interest transactions because they are covered by the statutory or administrative exceptions from the Internal Revenue Code's and ERISA's rules on prohibited transactions.

Certain plan investments are shares of mutual funds managed by Lincoln National Life Insurance Company and CMFG Life Insurance Company/Matrix Trust Company. Lincoln National Life Insurance Company and CMFG Life Insurance Company/Matrix Trust Company are the trustees as defined by the Plan, therefore, these transactions qualify as party-in-interest transactions.
