INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Memorial Community Health, Inc. Tax Deferred Annuity Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (.).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 Memorial Community Health, Inc. Tax Deferred Annuity Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note J to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Memorial Community Health, Inc. Tax Deferred Annuity Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

The following brief description of the Memorial Community Health, Inc. Tax Deferred Annuity Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General. The Plan, which became effective January 1, 1987, and was most recently amended April 1, 2024, is a defined contribution plan covering all employees of Memorial Community Health Inc. (the Company). Employees are eligible to participate in elective deferrals upon hire and in discretionary matching contributions after attaining the age of 21 and completing one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Retirement Plan Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

Elective Contributions. Each year eligible employees may make pre-tax and Roth salary reduction contributions to the Plan not to exceed Internal Revenue Code limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. In addition, certain employees with more than fifteen years of service may make additional contributions of up to \$3,000. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers 25 mutual funds and one insurance contract as investment options for participants.

Employer Contributions. The Company may make discretionary matching contributions on behalf of each eligible participant. During 2024, the Company contribution was five percent of eligible compensation, as defined by the Plan document and limited to \$120,000, for those employees who elected to make salary reduction contributions equal to at least two percent, but less than six percent, of eligible compensation. A contribution of eight percent of eligible compensation is made for those employees who elect to make salary reduction contributions of six percent or more of eligible compensation. During the year ended December 31, 2024, the total discretionary matching contribution was \$767,035.

Participant Accounts. Each participant's account is credited with the participant's contribution, Company contributions, and Plan earnings, and charged with an allocation of investment advisory and administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting. Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's discretionary matching contribution portion of their accounts is based on years of continuous service. A participant is 10 percent vested after one year of credited service, 20 percent after two years, 40 percent after three years, 60 percent after four years, 80 percent after five years and 100 percent vested after six years of service. Participants are also 100 percent vested if they are an employee and reach normal retirement age, upon death, or due to total permanent disability.

Payment of Benefits. On termination of service due to death, disability, retirement, or attainment of age 59½, a participant may elect to receive a single lump sum payment or an annuity equal to the value of the participant's vested interest in his or her account.

Termination of employment prior to normal retirement age requires distribution in a lump-sum payment if the account balance does not exceed \$5,000. The participant can elect to receive: (a) a direct rollover to an IRA or another qualified retirement plan or (b) a payment in cash, subject to federal tax withholding and generally a penalty tax if under age 59½. If the vested account balance is greater than \$5,000, the participant may defer distribution until normal retirement age or further defer to age 73.

NOTES TO FINANCIAL STATEMENTS

NOTE A - DESCRIPTION OF PLAN - CONTINUED

Forfeited Accounts. Forfeitures can be used to offset Plan expenses or to reduce employer matching contributions. At December 31, 2024 and 2023, nonvested accounts totaled \$8,250 and \$36,956, respectively. During the year ended December 31, 2024, \$3,586 of forfeitures were used to pay for plan expenses and \$36,985 were used to reduce employer matching contributions.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting. The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition. The Plan's investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company.

The Plan utilizes a framework to prioritize the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full-term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTES TO FINANCIAL STATEMENTS

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED

Participant Contribution Receivable. Participant contribution receivable is measured at the amount owed to participant accounts that has been withheld from participant paychecks at December 31, 2023. There was no participant receivable at December 31, 2024.

Payment of Benefits. Benefits are recorded when paid.

Expenses. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Expenses incurred for investment advisory services and the administration of the Plan are the responsibility of the Plan and are shown on the statement of changes in net assets available for benefits. Other investment related expenses are included in net appreciation in fair value of investments.

Use of Estimates. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

NOTE C - FAIR VALUE

There have been no changes in the methodology used during the years ended December 31, 2024 and 2023. Following is a description of the valuation methodology used for assets measured at fair value:

Registered Investment Companies: Valued at the closing price reported in the active market in which the funds are traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE D - INVESTMENTS AT CONTRACT VALUE

The Plan held two traditional investment contracts. One contract was held with American United Life Insurance Company, the former custodian, and the other was held with Standard Insurance Company. These contracts meet the fully benefit-responsive investment contract criteria; therefore, are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. The following represents the contract value of the investment contracts held by the Plan:

With traditional investment contracts, the Plan owns only the contract itself and not the underlying assets of the contract. Traditional investment contracts are designed to accrue interest based on crediting rates established by the contract issuers.

The traditional investment contracts held by the Plan are guaranteed investment contracts. The contract issuers are contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuers but may not be less than zero percent. The crediting rate is reviewed on a monthly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuers. These events may be different under each contract. Examples of such events include the following:

1. The failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code
2. Premature termination of the contracts
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the Company or other Company events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participant.

In addition, certain events allow the issuers to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer.

NOTES TO FINANCIAL STATEMENTS

NOTE E - EXCLUDED ANNUITY AND CUSTODIAL ACCOUNTS

The Plan Administrator has elected to exclude certain contracts and accounts from Plan assets in accordance with Department of Labor Field Assistance Bulletin 2009-02 due to the fact that:

1. The contract or account was issued to current or former employees before January 1, 2009;
2. Memorial Community Health, Inc. ceased to have any obligation to make contributions (including employee salary reduction contributions), and, in fact, stopped making contributions to the contract or account before January 1, 2009;
3. All of the rights under the contract or account are legally enforceable against the insurer by the individual owner of the contract or account without any involvement by Memorial Community Health, Inc.; and
4. The individual owner of the contract should be fully vested in the contract or account.

Because the Plan Administrator has elected to exclude certain contracts in accordance with Department of Labor Field Assistance Bulletin 2009-02, the excluded contracts are not in accordance with United States generally accepted accounting principles and, accordingly, it is not intended that these financial statements be presented in accordance with United States generally accepted accounting principles.

NOTE F - PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are held by State Street Bank and Trust Company (the custodian of the Plan) and by American United Life Insurance Company (the former custodian of the Plan) and, therefore, these transactions qualify as party in interest transactions.

For the year ended December 31, 2024, the Plan made direct payments of \$48,164 and additional indirect payments to Transamerica Retirement Solutions for recordkeeping. The Plan also made direct payments to USI Advisors of \$37,739 for investment advisory services for the year ended December 31, 2024. Additional indirect compensation was paid to National Financial Services for security broker services, which is included in net appreciation in fair value of the investments. The Plan made direct payments to HBE, LLP for \$12,724 for audit services provided during the year ended December 31, 2024. The Company pays directly any other fees related to the Plan's operations.

Transamerica receives revenue from mutual fund service providers for services they provide to the funds. This revenue is used to offset certain amounts owed to Transamerica for its administrative services to the Plan.

If revenue received by Transamerica from such mutual fund service providers exceeds the amount owed under the service agreement, Transamerica remits the excess to the Plan on a periodic basis. These amounts may be applied to pay Plan administrative expenses. During the year ended December 31, 2024 the Plan received \$38,452 of such funds and \$47,043 was used to pay administrative expenses.

NOTE G - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

NOTE H - TAX STATUS

The Plan is based on the Volume Submitter 403(b) Plan of Transamerica Retirement Solutions LLC. The Internal Revenue Service notified Transamerica by a letter dated March 31, 2017 that this prototype plan is acceptable under Section 403(b) of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

For the years ended December 31, 2024 and 2023, the Plan had no tax liability on unrelated business activity. The Plan believes that it has appropriate support for any tax positions taken, and as such, does not have any uncertain tax positions that are material to the financial statements. The Plan's federal returns for December 31, 2024, 2023, and 2022 are subject to examination by the IRS, generally for three years after they were filed.

NOTE I - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE J - INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by State Street Bank and Trust Company (the custodian of the Plan). Accordingly, State Street Bank and Trust Company has certified that the following data included in the accompanying financial statements and supplemental schedules is complete and accurate:
