DECEMBER 31, 2024 AND 2023

#### 1. Description of plan

The following description of **G & W Foods, Inc. 401(k) Plan** (the Plan) provides only general information. Participants should refer to the plan document for a complete description of the Plan's provisions.

##### General

The Plan is a defined contribution plan covering certain full-time employees of **G & W Foods, Inc.** (the Company) who have one year of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On December 20, 2019, the Setting Every Community Up for Retirement Enhancement Act of 2019 (SECURE Act) was enacted and was effective beginning on January 1, 2020. The SECURE Act provisions included, among other things, an increase in the age limit for required minimum distributions from age 70 ½ to 72. The Plan is in the process of operationally being amended to implement certain changes related to the SECURE Act. Written amendments to the Plan to reflect these operational changes will be adopted at a later date in accordance with applicable law and IRS guidance.

Effective May 1, 2022, the Plan was restated with no additional changes other than to be under the Cycle 3 Plan Document compliance and reflect the change in Trustees to Lincoln Financial Group Trust Company, the new trustee and custodian.

##### Contributions

Each year, participants may contribute up to 100% of their annual compensation in the form of salary reductions, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Employee contributions are subject to certain limitations as limited by the IRS regulations.

The Plan also has a employer contribution feature whereby the employer may make additional discretionary contributions to the Plan each year as determined by the Board of Directors. Under provisions of the Plan, the employer is not required to make a contribution each year. Participants are eligible to receive an additional discretionary contribution if they were employed on the last day of the prior plan year and worked a minimum of 1,000 hours of service. For the year ended December 31, 2024 and 2023, the Company did not make any additional discretionary employer contributions.

Effective January 1, 2023, the Plan was amended to implement a tiered employer matching contribution. Participant contributions will now be matched 100 percent on the first 3 percent of compensation contributed and 50 percent of the next 2 percent of compensation contributed for a maximum employer match of 4 percent.

#### Participant accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) earnings. Each participant's account is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. A participant is 100 percent vested after three years of credited service for the discretionary matching contributions. Forfeitures will be used to reduce future employer contributions or administrative expenses. In 2024 and 2023, the ending forfeitures account balance was \$1,557 and \$353, respectively.

#### Payments of benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants can also take in-service distributions once they have reached age 62. The distributions can be made as long as they have a 100 percent vested interest in their account, and the withdrawal can be all or a portion of their total account.

## **2. Summary of significant accounting policies**

This summary of significant accounting policies of the Plan is presented to assist in understanding the Plan's financial statements. The financial statements and notes are representations of the Plan's trustee, who is responsible for their integrity and objectivity. The Plan's policy is to prepare its financial statements on the modified cash basis of accounting; consequently, certain revenue and the related assets are recognized when received rather than when earned, and certain expenses are recognized when paid rather than when the obligation is incurred. This basis has been modified to record investments at market value. The preparation of the financial statements requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Accordingly, actual results could differ from those estimates.

#### Basis of accounting

The Plan's financial statements are presented on the accrual basis of accounting.

#### Use of estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Investment valuation and income recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Payment of benefits

Benefit payments to participants are recorded when paid.

#### Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements.

#### Subsequent events

The Plan has evaluated subsequent events through October 12, 2025, the date the financial statements were available to be issued.

### **3. Fair value measurement**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

<i>Level 1</i>	Quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
<i>Level 2</i>	Observable inputs other than Level 1 process, such as quoted prices for similar assets or liabilities; quoted prices for identical or similar assets in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities. If the asset or liability has a specified contractual term, the Level 2 input must be observable for substantially the full term of the asset or liability.
<i>Level 3</i>	Unobservable inputs that are supported by little or no market activity and that are significant to fair value of the assets or liabilities.

Following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

**4. Summary of certified information**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator has obtained certification from Lincoln Financial Group Trust Company, Inc., the custodian, for the years ended December 31, 2024 and 2023, that all investment information disclosed in the accompanying financial statements and supplemental schedules, including investments held at December 31, 2024 and 2023, and net change in fair value of investments and interest income for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the Plan's trustees.

**5. Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their employer contributions.

#### 6. Tax status

The Plan was designed under a volume submitter prototype non-standardized pre-approved profit-sharing plan with CODA accepted by the Internal Revenue Service by a letter dated June 30, 2020, in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter, but the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan is qualified and that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examinations by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

#### 7. Guaranteed investment contracts with insurance companies

The Plan invests in a benefit-responsive Guaranteed Interest Investment Contract with Lincoln Financial Group Trust Company, Inc. Lincoln Financial Group Trust Company, Inc. maintains the contributions in separate guaranteed interest accounts based on the maturity date and provides a guaranteed interest rate. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The Guaranteed Interest Investment Contract promises contract value for a benefit event (termination, death, disability, and retirement); however, there is a possible market value adjustment when funds are withdrawn prior to their maturity. The crediting interest rate is guaranteed for the lifetime of the contract at 3 percent.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Lincoln Financial Group Trust Company, Inc., represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

#### **8. Related party transactions and party-in-interest transactions**

Certain Plan investments are shares of funds managed by Lincoln Financial Group Trust Company, Inc. Lincoln Financial Group Trust Company, Inc. is the custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan incurs expenses related to general administration and record-keeping. The Plan Sponsor pays a portion of these expenses and certain accounting and auditing fees relating to the Plan.

#### **9. Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
