Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Project Lead the Way 403(b) Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Project Lead the Way 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Note 1. Description of the Plan

The following description of Project Lead The Way 403(b) Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

General

The Plan is a defined-contribution plan sponsored by Project Lead The Way, Inc. (Organization) for the benefit of its employees who are scheduled to work more than 20 hours per week. An employee is immediately eligible to participate in the Plan upon hire. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Teachers Insurance and Annuity Association (TIAA) serves as the issuer of the TIAA Traditional Annuity contract and variable annuity accounts, and College Retirement Equities Fund (CREF) serves as the issuer of the CREF mutual funds held by the Plan. TIAA is a recordkeeper of the Plan. American United Life Insurance Company (AUL) is also a custodian and recordkeeper of the Plan.

Effective January 1, 2024, the Plan was amended to allow part-time employees, interns and temporary employees who work more than 1,000 hours of service in an eligibility computation period to be eligible for the plan.

Contributions

The Plan permits eligible employees through a salary deferral election to have the Organization make annual contributions up to the maximum allowed by law. Employee Roth and rollover contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Organization may make a discretionary matching contribution determined annually by the Organization's Board of Directors. The Organization's discretionary matching contribution is 100% of the first 6% of the employees' eligible compensation for the years ended December 31, 2024 and 2023. The Organization also makes a nondiscretionary employer contribution of 4% of the employees' eligible compensation. Contributions are subject to certain limitations.

Participant Investment Account Options

Investment account options available include various annuity accounts, pooled separate accounts mutual funds and insurance contracts. Each participant has the option of directing contributions into any of the investment account options selected by the Organization and may change the allocation to the extent permitted by the individual agreements.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Organization's contribution and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their voluntary and Organization contributions plus earnings thereon.

Payment of Benefits

Upon termination of service, death, or disability, a participant may elect to receive either a lump-sum amount equal to the value of his account, an annuity contract (if assets are held in a custodial account) or converted to an income option (if assets are invested in an annuity contract). A participant may elect to receive a distribution of their rollover contributions at any time. Withdrawals other than for termination are permitted under certain circumstances provided by the Plan.

Plan Termination

Although it has not expressed an intention to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

A portion of the Plan is funded by individually controlled TIAA and CREF investments. Contributions are allocated to the TIAA traditional annuity contract, CREF variable annuity accounts, CREF mutual funds and the TIAA real estate pooled separate account. The Plan also includes AUL pooled separate accounts and the AUL Stable Value Account.

TIAA Traditional Annuity

The TIAA traditional annuity is a fixed-dollar annuity and investment product offered by TIAA, an insurance company. The TIAA traditional annuity is maintained in the TIAA general account. Contributions to the TIAA traditional annuity purchase a contractual or guaranteed amount of future benefits for the participants and are secured by the general assets of TIAA.

The fully benefit responsive TIAA traditional annuity account is recorded at contract value. Contract value, as reported to the Plan by TIAA, represents contributions made under the contract, plus interest at the contract rate, less funds to pay withdrawal benefits and administrative expenses. The nonbenefit-responsive investment contracts with TIAA approximates fair value and contain liquidity restrictions that require withdrawals and transfers from the investment contract to other investment options available to the Plan to be spread over a period of ten annual installments or five annual installments for withdrawals after a participant's termination of employment.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause significant withdrawal from the plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

Crediting interest rates on the TIAA traditional annuity are determined quarterly by the issuer with a minimum rate of approximately 3%, subject to limitations relating to Plan termination, early retirements, etc. There are no reserves against the contract value for credit risk or the contract issuer or otherwise.

TIAA Variable Annuity Accounts

Participants purchase accumulation units in the variable annuity contracts and their value is calculated daily. Variable annuity accounts, except for the money market account, are recorded at their estimated fair value, which is based upon the underlying value of the assets. The money market account is recorded at amortized cost, which approximates fair value. The amortized cost of an instrument is determined by valuing it at its original cost and thereafter amortizing any discount or premium from its face value at a constant rate until maturity. TIAA publishes the unit price daily.

TIAA Real Estate Pooled Separate Account and AUL Pooled Separate Accounts

The TIAA real estate pooled separate account is valued at the net asset value (NAV) per accumulation unit of the investment. The underlying real estate holdings or other real estate-related investments are valued principally utilizing external appraisals. Although the underlying assets of the account cannot be quickly sold and converted to liquid assets, the TIAA general account provides the Plan with a liquidity guarantee. Transfers out of the pooled separate account are limited to one per calendar quarter. There are no unfunded commitments or redemption notice period. TIAA publishes the unit price daily.

The TIAA real estate pooled separate account seeks favorable long-term returns primarily through rental income and appreciation of real estate investments owned by the Account. The Account will also invest in publicly traded securities and short-term higher quality liquid investments that are easily converted to cash to enable the Account to meet participant redemption requests, purchase or improve properties or cover other expense needs.

AUL pooled separate accounts are valued at estimated fair value as provided by One America Life Insurance Company. AUL publishes the unit price daily.

CREF Mutual Funds

Mutual funds are valued at quoted market prices.

AUL Stable Value Account

The AUL Stable Value Account is a fixed-dollar annuity and investment product offered by AUL, an insurance company. The AUL Stable Value Account is maintained in the AUL general account. Contributions to the AUL Stable Value Account purchase a contractual or guaranteed amount of future benefits for the participants and are secured by the general assets of AUL.

The AUL Stable Value Account is recorded at contract value by AUL. Contract value, as reported to the Plan by AUL represents contributions made under the contract, plus interest at the contract rate, less funds to pay withdrawal benefits and administrative expenses. Minimum guaranteed rate is 0%.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause significant withdrawal from the plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Plan Loans

The Plan allows for participants to have Plan loans. TIAA issues loans to Plan participants outside the scope of the Plan. Participants pledge as a security a portion of their balance in the TIAA traditional annuity, which represents 110% of the outstanding loan balance. The amount pledged as collateral at December 31, 2024 and 2023 was immaterial. The interest rates on outstanding loans as of December 31, 2024 was 4.00%.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. There can be no more than two loans outstanding. The loan interest rate, determined annually, is a reasonable rate of interest based on comparable rates being charged by lending institutions in the same geographic locale as the Organization. Principal and interest is paid ratably through payroll deductions.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

Plan Tax Status

The Plan operates under a volume submitter adoption agreement in connection with a prototype retirement plan and trust document sponsored by One America Financial Partners, Inc. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested an individual determination letter due to the prototype receiving a favorable opinion letter. The Plan has been amended since the prototype received its favorable opinion letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and tax-exempt as of the financial statement date.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Organization or the Plan, at the Organization's discretion.

Note 3. Certification of Plan Custodians

The Organization has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, TIAA, CREF and AUL, all qualified institutions, have certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information and participant loans included in the accompanying schedule of assets (held at year end) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. Level 1 securities include mutual funds. If quoted market prices are not available, then fair values are estimated by using pricing models, quoted prices of securities with similar characteristics or discounted cash flows. Level 2 securities include the variable annuity accounts and the pooled separate accounts. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. The TIAA traditional annuity has been classified as Level 3 investments. See Note 2 for definition of inputs utilized to determine fair value.

Fair value determinations for Level 3 measurements of securities are the responsibility of the Plan Administrator. The Plan Administrator contracts with TIAA to generate fair value estimates on a quarterly basis. The Plan Administrator challenges the reasonableness of the assumptions used and reviews the methodology to ensure the estimated fair value complies with accounting standards generally accepted in the United States.

Note 5. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

Certain Plan investments are units of variable annuity accounts or a pooled separate account that are managed by an entity related to TIAA, which is the recordkeeper of the Plan. The Plan's traditional annuity contract is maintained in TIAA's general account. Total fees paid to AUL were \$2,624 and \$648 for the years ended December 31, 2024 and 2023, respectively.

The Organization provides certain administrative services at no cost to the Plan.

Note 6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7. Subsequent Events

Effective August 22, 2025, the Plan was transferred to Transamerica (Transamerica) as custodian and recordkeeper of the Plan. The conversions initiated a blackout period beginning July 25, 2025 and continued through August 22, 2025. During this period, participants were unable to direct or diversify the assets held in their accounts until the trust had time to accurately complete the conversion. During this period, participant contributions continued to be made through payroll deductions, and the contributions were deposited and held in a money market account until the completion of the blackout period. At the end of the blackout period, these funds were transferred and invested in funds as requested by each participant. All assets transferred to Transamerica on August 22, 2025. The plan also adopted a new adoption agreement sponsored by Transamerica.

Effective January 1, 2025, the Plan was amended to include an auto-enrollment feature, automatically enrolling newly eligible employees at a 3% deferral rate. The automatic deferral percentage will be 3% for the first two years of participation in the plan and increase each year until the participant reaches 6%. The plan will also allow for in-plan Roth rollover contributions.

Subsequent events have been evaluated through October 13, 2025, which is the date the financial statements were available to be issued.
