## REPORT OF INDEPENDENT AUDITORS

To the Administrative Committee  
Aisin Retirement Security Plan  
Seymour, Indiana

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Aisin Retirement Security Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the

information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

#### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

#### Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### 1. DESCRIPTION OF THE PLAN

The following description of the Aisin Retirement Security Plan (the "Plan") provides only general information. Participants should refer to the plan document, available from the plan administrator, for a more complete understanding of the Plan's provisions.

#### General

The Aisin Retirement Security Plan is a defined contribution plan established under the provisions of Internal Revenue Code ("IRC") Section 401(k) and is sponsored by Aisin Holdings of America, Inc. ("the Company") for the benefit of all employees participating in the Plan. Any employee who has attained 18 years of age and completed 6 months of service is eligible to participate in the Plan. Employees subject to collective bargaining agreements and certain other employee classifications, as defined in the plan document, are not eligible. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended.

The Plan is a multiple-employer plan. The employees of the following companies are also eligible to participate in the Plan: Aisin World Corp. of America; IMRA America, Inc.; Aisin Technical Center of America; Aisin Drivetrain, Inc.; Aisin Automotive Casting Tennessee, Inc.; Aisin Light Metals, LLC; Aisin Manufacturing Illinois, LLC; Aisin Automotive Casting, Inc.; Aisin Electronics, Inc.; Aisin Electronics Illinois, LLC; Aisin USA Manufacturing, Inc.; Aisin Chemical Indiana, LLC; FT Techno of America, LLC; AW Texas Inc.; AW Transmission Engineering USA Inc.; and AW North Carolina, Inc.

Fund transfers from an affiliate plan, which is also sponsored by the Company, are recorded in the accompanying financial statements as "Fund transfers with affiliate plan."

#### Contributions

The Plan permits participants to make deferred savings contributions up to 60% of their salary, not to exceed the maximum annual limit established by the IRC. Deferred savings contributions and earnings on such contributions are exempt from federal and state income tax until distributed to the participant. Participant contributions are 100% vested at all times and are non-forfeitable. The Plan automatically enrolls participants at 5% of compensation if they do not voluntarily decline participation.

The Plan allows the Company to make a discretionary match contribution, but there were no such contributions made during 2024 or 2023. In addition, the Plan allows for a safe-harbor nonelective contribution, equal to 100% of the first three percent of eligible compensation, and 50% of the next two percent of eligible compensation. Participants are 100% vested in these contributions when made.

All contributions are invested in mutual funds and a common/collective trust. At the participants' discretion, contributions may be invested in various investment options as defined by the Plan.

### Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching contributions, an allocation of the Plan's earnings, and expenses. Allocations are based on participant's earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's own account.

### Vesting

Participants are fully vested in the Company's safe harbor matching contributions. For any discretionary contributions made, participants are fully vested after six years of service. Any part of the discretionary contribution portion that is not vested at the time of the earlier of (1) distribution of the participant's benefits or (2) five consecutive years of breaks in service shall be forfeited.

### Forfeitures

According to the plan document, forfeitures may be used to pay administrative expenses as directed by the Company or to reduce the Company's contribution. Forfeitures not yet used by the Company as of December 31, 2024 and 2023 were \$272,636 and \$265,000, respectively. During the year ended December 31, 2024, \$81,730 was used to reduce administrative expenses.

### Payment of Benefits

Upon retirement, participants can opt to receive a lump-sum payment or benefit payments in monthly, quarterly, semiannual, or annual installment payments over any period not exceeding the life expectancy of the participant determined at the time benefits commence. Participants are also eligible to receive distributions upon death, disability, and termination. Participants age 59 ½ are eligible to elect in-service withdrawals. Participants who experience a qualified financial hardship may withdraw the amount of their deferred savings contributions. However, they cannot withdraw more than necessary to meet the financial needs created by the hardship.

### Administrative and Investment Management Expenses

The Company pays a significant amount of the Plan's administrative expenses.

### Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range up to five years unless the loan is for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate determined by the administrator based on the prevailing interest rates charged by persons in the business of lending money for loans, which

would be made under similar circumstances. Participants may have one loan outstanding at a time.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Accounting

The financial statements of the Plan have been prepared on an accrual basis of accounting.

#### Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

#### Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Payment of Benefits

Benefits are recorded when paid.

#### Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

#### Risk and Uncertainties

The Plan provides participants with various investment securities. The underlying investments are exposed to various risks, such as interest rate, market, liquidity and credit risk. Due to the level of risk associated with certain investments, and the sensitivity of certain fair value estimates to

change in valuation assumptions, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### Subsequent Events

The Plan has evaluated events or transactions occurring subsequent to the statement of net assets available for benefits date for recognition and disclosure in the accompanying financial statements through the date the financial statements were available to be issued, which is October 10, 2025.

### **3. INFORMATION CERTIFIED BY THE TRUSTEE**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 and in the supplemental schedule as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

### **4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of inputs within the fair value hierarchy are defined as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds*: Valued at the daily closing price as reported by the fund. Mutual funds are held by the Plan and are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.
- *Collective trust fund*: Valued at the net asset value of units of the collective trust. The net asset value, as provided by the trustee, is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

## 5. PARTIES-IN-INTEREST AND RELATED PARTY TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Company and certain others. Certain administrative expenses of the Plan are paid by the Company. The investment management fees are paid to Sageview by the Plan. At December 31, 2024 and 2023, certain investments of the Plan are held in investment funds managed by Fidelity Management Trust Company, the trustee of the Plan. Blue & Co., LLC serves as the independent auditor of the Plan and receives payment from the Company for these services.

## 6. INCOME TAX STATUS

The Plan has adopted a preapproved plan document sponsored by FMR LLC ("Fidelity"), which has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by various federal and state taxing authorities. Management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require

recognition of a liability or disclosure in the accompanying financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 7. PLAN TERMINATION

Although the Company has not expressed any intent to discontinue participation in the Plan, it has the right to terminate the Plan. All accounts of the participants shall vest and become non-forfeitable in the event the Plan is terminated, partially terminated, or contributions by the Company are discontinued. Upon termination, the Company shall direct the trustee regarding distribution of accounts to participants or their beneficiaries.
