Note 1 - Plan Description

The following description of Datavail Corporation 401K Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established on January 1, 2014 and most recently restated effective March 24, 2022. The Plan is available to all employees age 21 years or older. The entry date for eligible participants is immediate upon meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

Management of Datavail Corporation (the "Company") administers the Plan. Fidelity Management Trust Company (the "Trustee") serves as trustee, manages plan assets, and maintains the Plan's records.

Contributions

The Plan provides for employee salary deferral contributions, including before-tax and after-tax Roth contributions, up to a maximum of 100 percent of annual eligible compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. This maximum percentage may be reduced by the plan administrator in certain circumstances. Eligible employees are automatically enrolled at a deferral rate equal to 3 percent of eligible compensation after receiving sufficient notice unless they make an affirmative election not to defer or to defer a different percentage. There is also an annual deferral increase of 1 percent until a deferral rate of 8 percent is reached for participants who were automatically enrolled in the Plan on or after January 1, 2019. Eligible employees who have reached age 50 during the plan year may elect to make catch-up contributions, as limited by the Internal Revenue Service (IRS). Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan. Employee contributions to the Plan are made through regular payroll deductions.

The Company may make matching contributions at its sole discretion. During the year ended December 31, 2024, the Company made matching contributions equal to 50 percent of the first 6 percent of employees' elective deferrals. The Company may also make discretionary qualified employer contributions. There were no discretionary qualified nonelective contributions during the year ended December 31, 2024.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. Participants may have a maximum of two loans outstanding at any given time. Loans have a maximum term of five years unless such loan is for the purchase of the participant's primary residence, in which case the repayment period will be determined by the plan administrator. Principal and interest are paid ratably through semimonthly payroll deductions. Upon termination of a participant from employment, the participant's loan shall continue to be payable in accordance with the provisions of the participant's loan or be due in full.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses and plan losses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Note 1 - Plan Description (Continued)

Vesting

Participants are immediately 100 percent vested in their voluntary contributions, allocated earnings or losses thereon, and any qualified matching contributions.

Any employer contributions and the earnings or losses thereon not fully vested when contributed will vest as follows:

A participant account becomes 100 percent vested upon death, attaining normal retirement age (the age of 65) while an employee, retirement due to disability, or termination of the Plan.

Benefit Payments

Upon death, disability, retirement, or termination of service, a participant or his or her beneficiary may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

The Plan allows in-service distributions and partial distributions to participants age 59½ or older who have not terminated employment with the plan sponsor. The Plan also allows for terminated participant vested account balances of \$1,000 or less to be automatically distributed in cash and balances of \$1,000 to \$5,000 to be automatically rolled out of the Plan into an IRA if the participant does not make an election in a timely manner. The IRS has required minimum distributions once a participant reaches age 72 during the previous plan year and is no longer employed by the Company.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited account balances were insignificant.

The Plan used approximately \$148,873 for the year ended December 31, 2024 to reduce employer contributions.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Fidelity Management Trust Company or its affiliates. Fidelity Management Trust Company is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines. In addition, the Plan provides for loans to participants, which are also party-in-interest transactions under ERISA guidelines.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value based on quoted market values. See Note 4 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties and Concentrations

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Company.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including September 15, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

The Trustee holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and schedule of assets held at end of year are based solely on information certified by the Trustee.

Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Note 4 - Fair Value Measurements (Continued)

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management’s own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan’s assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
