## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of  
the 403(b) Thrift Plan of Sadler Health Center Corporation

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements***

We have performed an audit of the financial statements of 403(b) Thrift Plan of Sadler Health Center Corporation, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for plan benefits as of December 31, 2024, and the related statement of changes in net assets available for plan benefits for the year ended December 31, 2024, and the related notes to the financial statements (2024 Financial Statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Mutual of America Life Insurance Company, a qualified institution as of December 31, 2024 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### ***Opinion on the 2024 Financial Statements***

### NOTE 1 DESCRIPTION OF PLAN

---

The following description of the 403(b) Thrift Plan of Sadler Health Center Corporation (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan covering all eligible employees of Sadler Health Center Corporation (the "Company" or "Employer"). There is no age or service requirement for participant or employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### ***Contributions***

Each year, participants may elect to defer a portion of their Plan compensation on a pre-tax or Roth basis up to the maximum amount allowed under IRS regulations, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions and any Company contributions into various investment options offered by the Plan. The Company will make employer base contributions in the amount equal to 100% of their participant contribution that do not exceed 2% of eligible compensation for the plan year. Employer contributions for the year ended December 31, 2024 totaled \$136,259. Contributions are subject to certain IRS limitations.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contribution and employer matching contribution as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### ***Vesting***

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the employer contribution portion of their account is based on years of continuous service. Participants automatically become fully vested upon reaching normal retirement age (65 years old), or in the event of disability or death.

Participants become vested in their employer contribution as follows:

#### *Plan Assets Pledged as Collateral*

Participants are permitted to obtain loans directly from Mutual of America Life Insurance Company (Mutual of America). These loans are considered Plan loans and are issued directly from funds owned by Mutual of America and not directly from a participant's account. Adequate security is required, and a portion of the participant's account serves as collateral, to cover 120% of the outstanding loan in case of default. In general, the amount of the loan may not exceed the lesser of \$50,000 or 50% of the participant's account balance. The minimum loan amount is \$1,000. The loans bear a rate of interest as determined in the controlling contract and may be fixed or variable. The amount of Plan assets held as collateral for loans issued to participants by Mutual of America at December 31, 2024 and 2023 was \$18,242 and \$2,986, respectively.

#### *Payments of Benefits*

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive either a lump-sum amount equal to the vested balance of his or her account. Distributions of account balances of less than \$1,000 that meet the provisions for a mandatory distribution will automatically be paid to participants in a cash distribution if the participant does not elect the distribution method. In addition, hardship and in-service distributions (for those age 59 ½ and older) are permitted if certain criteria are met.

Participants who are age 59 ½ or older, or have terminated employment at age 55 or later, can also elect to receive regularly scheduled withdrawals from their account. Under this form of benefit, eligible participants can choose to receive regular monthly payments of \$100 or more.

#### *Forfeited Accounts*

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$26,499 and \$11,945, respectively. These accounts can be used to pay plan charges, restore participant accounts or to reduce future employer contributions. In 2024, there were no forfeitures used to pay plan charges, restore participant accounts or to reduce employer contributions.

### NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

---

#### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and (losses) on investments bought and sold as well as held during the year.

#### *Contributions*

Contributions from Plan participants and employer matching contributions are recorded in the year in which the employee contributions are withheld from compensation and on compensation paid during the year.

#### *Payment of Benefits*

Benefits are recorded when paid.

#### *Expenses*

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Fees related to the administration of the Plan, including fees associated with notes receivable from participants and distributions, are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

### NOTE 5 FAIR VALUE MEASUREMENTS

---

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means;

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies and significant investment strategies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### ***General Account***

Valued at participant contributions, plus interest, less withdrawals, transfers, and fees. Amounts placed in the Interest Accumulation Account of Mutual of America's General Account are credited with interest at a rate determined by Mutual of America.

#### ***Pooled Separate Accounts***

Valued at the net asset value of the underlying funds on the last day of the plan year. The net asset value of the fund is based on the market value of its underlying investments (registered investment companies), but it is not a publicly quoted price in an active market.

- b) These funds primarily invest in stocks and aim for capital appreciation. These funds seek to achieve a high level of return, through both appreciation of capital and current income.
- c) These funds seek to provide maximum real return, consistent with preservation of real capital and prudent investment management. Additionally, the funds seek current income and capital preservation.
- d) These funds seek to provide a high level of income and moderate long-term capital appreciation by tracking the performance of a benchmark index that measures the performance of publicly traded real estate investment trusts (known as REITS).
- e) These funds seek to provide current income and capital appreciation appropriate for the asset allocation associated with its target retirement date. The funds invest in shares of other series of the Investment Company in proportions that the Adviser selects to seek to meet the objective of the fund.

#### **NOTE 6 RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

---

Certain Plan investments are managed by Mutual of America Life Insurance Company, the custodian of the Plan and therefore, these transactions qualify as party-in-interest transactions. The Plan made direct payments to Mutual of America Life Insurance Company for recordkeeping services of \$2,205.

#### **NOTE 7 PLAN TERMINATION**

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

#### **NOTE 8 TAX STATUS**

---

The Company adopted a non-standardized prototype 403(b) plan sponsored by Mutual of America Life Insurance Company that received a favorable opinion letter from the Internal Revenue Service (IRS) on March 31, 2017. The opinion letter stated that the prototype plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's consultant believe that the plan is designed, and is currently being operated, in compliance with the applicable requirements of IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan is subject to routine audits by taxing jurisdictions; generally for a period of three years after the returns are filed; however, there are currently no audits for any tax periods in progress.

### NOTE 9 RISKS AND UNCERTAINTIES

---

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

### NOTE 10 RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

---

The following is a reconciliation of investments per the financial statements to the Form 5500. Mutual of America Life Insurance Company, the custodian does not file separate Form 5500's for its sub-accounts and therefore, the asset value for the pooled separate accounts held by the Plan must be reported on the Form 5500, Schedule H under the Value of interest in registered investment companies (mutual funds) and not reported under the Value of interest in pooled separate accounts.
