The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

1. Description of plan:

---

The following description of the Mary T., Inc. 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering substantially all employees of Mary T., Inc. and the affiliated entities under a controlled group (Employer). An employee is eligible to participate in the Plan after completing six months of service and attaining age 21. The Plan is subject to the provisions of Employee Retirement Income Security Act of 1974 (ERISA). Deferrals begin on the first day of the month coinciding with or next following the attainment of eligibility.

Contributions:

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage, limited by Plan provisions, of their compensation contributed as pre-tax 401(k) or Roth contributions to the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in the designated default fund until changed by the participant. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Employer may, at its discretion, elect to make a discretionary matching or profit-sharing contribution to the Plan in an amount determined by the Employer annually. Participants must be employed on the last day of the Plan year and complete at least 501 hours of service during the Plan year in order to receive an allocation of the Employer discretionary profit-sharing contribution, unless termination is due to retirement, death, or total and permanent disability. For the year ended December 31, 2023, the employer matching contribution was equal to 50% of deferrals up to a maximum of 3% of compensation deferred. During the year ended December 31, 2024, the Employer increased the match to 67% of the deferrals up to a maximum of 3% of compensation deferred. There were no discretionary profit sharing contributions to the Plan for the years ended December 31, 2024 and 2023.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitation.

Participant accounts:

Each participant's account is credited with the participant's contributions, the Employer contributions, and Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

1. Description of plan (continued):

---

Vesting:

Participants are immediately vested in their contributions and the Employer's contributions, plus actual earnings thereon. Therefore, there are no forfeitures.

Notes receivable from participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note transactions are treated as a transfer to (from) the investment fund (to) from the participant note. Note terms are up to five years, except for notes to fund the purchase of a principal residence, for which the note may be repaid over a maximum period of 10 years. The notes are secured by the balance in the participant's account and bear interest at a rate that is determined by Prime plus 1%. Principal and interest is paid on a monthly or bi-weekly payments.

Benefit payments:

Upon termination of service, death, disability, or retirement, the participant may elect to receive the value of the vested interest in his or her account in the form of a lump sum, installments, or partial withdrawals. If a participant terminates employment and the participant's account balance is not greater than \$5,000, the Plan administrator will authorize the benefit payment without the participant's consent. The Plan also allows for in-service withdrawals at age 59½ and hardship withdrawals subject to Plan provisions.

Use of estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition:

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrator determines the Plan's valuation policies utilizing more information provided by the investment advisors, insurance company, trustee, and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivables are recorded as distributions on the basis of the terms of the Plan document.

2. Summary of significant accounting policies:

Benefit payments:

Benefits are recorded when paid.

Administrative expenses:

Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Employer. Expenses paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Concentrations:

At December 31, 2024 and 2023, approximately 60% and 56% of the investments for both years were held in four and three investment funds, respectively.

Subsequent events:

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

3. Information certified by Fidelity Management Trust Company:

The following is a summary of the Plan's asset information as of and for the years ended December 31, 2024 and 2023, included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information provided by the trustee and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the custodian that information provided to the Plan Administrator by the custodian related to the following assets is complete and accurate. Accordingly, as permitted by ERISA Section 103(a)(3)(c) as of and for the years ended December 31, 2024 and 2023 and 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA as of and for the years ended December 31, 2024 and 2023, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information related to the following assets:

4. Fair value measurements:

---

The Plan's investments are reported at fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

The three levels of the fair value hierarchy are described as follows (continued):

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement. The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust* - Measured at fair value using NAV per share as a practical expedient for the shares held by the Plan at year end. The NAV is determined in accordance with a valuation methodology adopted by the collective trust's trustee.

Additionally, investments measured at the NAV per share practical expedient are not categorized within the fair value hierarchy.

5. Common collective trust:

The Plan invests in the Reliance Trust New York Anchor Account Series I (the Fund) in the Reliance Trust New York Anchor Trust (the Trust), a common collective trust, which is a direct filing entity. The Trust does not have a finite life, unfunded commitments, or significant restrictions on redemptions. While there is no redemption notice period for the Fund, withdrawals from the Trust may only be made upon 24 months' advance written notice of intent to redeem.

6. Risks and uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

7. Plan termination:

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

8. Tax status and Plan amendments:

The Plan is placing reliance on an opinion letter dated June 30, 2020, received from the IRS on the Non-Standardized Pre-Approved Profit Sharing Plan indicating that the pre-approved plan is qualified under section 401 of the IRC and is therefore not subject to tax under current income tax law. The Plan has been amended on April 1, 2022. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. Plan management evaluated the Plan's tax positions and concluded that the Plan had taken no uncertain tax positions that require adjustment to the financial statements to comply with the provisions of this guidance. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Related party and Party-in-interest transactions:

As of and for the year ended December 31, 2024, certain investments were managed by Fidelity Management Trust Company, the Plan's trustee. Therefore, these transactions qualify as party-in-interest.
