## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Information Systems of Florida, Inc. Retirement Savings & Profit Sharing Plan & Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. ### Basis for Opinion

certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### Supplemental Schedule Required by ERISA

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**December 31, 2024 and 2023**

**A. Description of the Plan:**

The following description of the Information Systems of Florida, Inc. Retirement Savings & Profit Sharing Plan & Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Information Systems of Florida, Inc. Retirement Savings & Profit Sharing Plan & Trust is a defined contribution plan covering employees of ISF, Inc., Wired People, Inc. and Santa Teresa Holdings, LLC (the “Company or Employer”). The Plan covers all employees of the Employer and participants are automatically enrolled in the Plan effective the first day of the next month after hire and will have their pre-tax deferral at 3% in accordance with the provisions of the Plan unless they elect otherwise. Employee deferrals automatically increase at the rate of 1% per year up to 10%. The Plan is subject to the provisions of the Employer Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may elect to contribute up to 60% of their pre-tax annual compensation to the Plan up to IRS limits. Participants may also elect to make after-tax Roth contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to IRS limits. The Company may make a matching contribution equal to a percentage of the base compensation that an employee contributes to the Plan. During the year ended December 31, 2024 the Company made matching contributions of 25% of deferrals limited to 10% of gross compensation deferred to eligible participants of Wired People, Inc and Santa Teresa Holdings and 100% up to 4% of compensation for eligible participants of ISF, Inc. Additional amounts may be contributed at the option of the Company’s board of directors. All contributions to the Plan are participant directed. Contributions are subject to certain statutory limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the employers’ contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions, plus earnings thereon. Vesting in the Employers’ matching and discretionary contribution portion of the participants’ accounts plus actual earnings thereon is based on years of continuous service. A participant is fully vested after five years of credited service.

Participant Loans

The Plan allows for participants to take loans with the minimum loan being \$1,000 and the maximum loan being the lessor of \$50,000 or 50% of the participants account balance.

**A. Description of the Plan (continued):**

Payment of Benefits

On termination of service a participant may receive the value of the vested interest in his or her account as a lump sum distribution, or one of several annuity installments.

There have been no amounts allocated for benefit claims that have been processed and approved for payment prior to December 31, 2024 but not yet paid as of that date.

Forfeited Accounts

At December 31, 2024 and 2023 forfeited accounts totaled \$33,704 and \$68,201, respectively. Forfeited non-vested accounts may be used to pay Plan expenses and reduce employer contributions. During the year ended December 31, 2024, no forfeitures were used.

**B. Summary of Significant Accounting Policies:**

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Date of Management's Review

Subsequent events were evaluated through the date of the independent auditors' report which is the date the financial statements were available to be issued.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C. for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The net decrease in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Plan Administrative Expenses

Substantially all administrative expenses are paid by the Plan.

C. Fair Value Measurements:

FASB ASC topic 820 on *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using level 1 inputs because they generally provide the most reliable evidence of fair value. The hierarchy is measured in three levels based on the reliability of the inputs:

- Level 1 Valuations based on unadjusted quoted prices in active markets for identical assets that the Plan has the ability to access at the measurement date.
- Level 2 Valuations based on inputs other than quoted prices included within Level 1 that are observable for the asset, either directly or indirectly. Observable inputs include quoted prices for similar assets in active or non-active markets.
- Level 3 Valuations derived through the use of valuation models or methodologies using significant unobservable inputs. Level 3 valuations incorporate certain assumptions and projections that are not observable in the market and as a result significant professional judgment may be used in determining the fair values.

**D. Information Certified by the Plan's Custodian:**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

**E. Related Party Transactions:**

Fidelity Investments Institutional is the Plan's recordkeeper, and as such those transactions qualify as party-in-interest transactions. Amounts paid directly to Fidelity Investments Institutional for related fees were \$23,767 for the year ended December 31, 2024.

**F. Plan Termination:**

Although the participating Employers have not expressed any intent to do so, they have the right under the Plan, to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**G. Tax Status:**

The Internal Revenue Service has opined and informed Fidelity Management & Research Co., the volume submitter by letter dated June 30, 2020, that the Volume Submitter Profit Sharing Plan with CODA plan adopted by the Employer is designed in accordance with the applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained by the relevant taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

**H. Risks and Uncertainties:**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonable possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
