NOTE 1 - PLAN DESCRIPTION

The following descriptions of the Rasmussen Group, Inc. 401(k) Profit Sharing Plan & Trust (the Plan) provide only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General and Eligibility

The Plan is a defined contribution plan covering employees of The Rasmussen Group, Inc., RGI Materials, Inc., Jensen Construction Company, Central Iowa Trucking, Inc., Argee Transport Company, Concrete Supply Inc., Central Iowa Ready Mix Inc., Circle V Specialized, Inc., Grimes Asphalt and Paving Corp., TransCo Ready Mix, LLC, Jensen Crane Services, Ideal Ready Mix Company, Inc. and L & W Quarries, Inc. (the Companies) who have completed two months of service and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions and Participants' Investment Options

A participant may designate from 1 to 15% of compensation, subject to qualified limitations. The Companies will provide a matching contribution up to 50% of the first 6% of the participant's compensation and may also make additional discretionary contributions. The amounts contributed by the participant and employer are deposited into various registered investment companies (common/collective fund or mutual funds) at the participant's discretion. Participants may change their allocation on a daily basis.

Participant Accounts and Forfeitures

Each participant account is credited with the participant's contributions, an allocation of the Companies' contributions and plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Forfeitures of participants' nonvested accounts are used to reduce future employer contributions. Employer contributions were reduced by \$138,237 in forfeitures for the year ending December 31, 2024. At December 31, 2024 and 2023 forfeited nonvested accounts totaled approximately \$2 and \$32,340 respectively.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. The portion of the participants' accounts attributable to the Company's matching and discretionary contributions become 20% vested after two years of credited service as defined and continues to vest at the rate of 20% for each successive year of service until 100% vested after six years of service.

Payment of Benefits

Participants (or the beneficiary, if the participant is deceased) will be eligible to receive their benefits in a cash lump sum payment on the earlier of retirement, death or termination due to any other reason.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The Plan's significant accounting policies are as follows:

Basis of Accounting

The financial statements of the plan are prepared under the accrual method of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value, as reported to the Plan by Principal Trust Company. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value assessments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 3 - UNAUDITED INFORMATION CERTIFIED BY THE PLAN TRUSTEE

The 2024 and 2023, Statements of Net Assets Available for Benefits, the investment activities included on the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the accompanying notes to the financial statements were prepared in part or entirely from information certified as complete and accurate by Principal Trust Company (trustee of the plan), in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. The information certified includes total investments of \$46,475,609 and \$37,125,430 at December 31, 2024 and December 31, 2023, respectively and related net gains of \$5,321,867 for the year ended December 31, 2024.

NOTE 4 - ADMINISTRATIVE EXPENSE

Certain administrative functions are performed by officers or employees of the Companies. No such officer or employee receives compensation from the Plan. Certain other administrative expenses of maintaining The Plan are paid by the Company and are therefore excluded from these financial statements.

NOTE 5 - FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available.

Level 1 Fair Value Measurements

The Plan's valuation methodology used to measure the fair values of mutual funds was derived from quoted market prices of active markets.

Valued at the daily closing price as reported by the fund, mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The fair value of common/collective funds are valued using the net asset value (NAV) of units held by the Plan as of December 31, 2024 are provided by Principal Trust Company. The NAV is based on the fair value of the underlying assets owned by the fund, net of the investment management fee. The investment management fee is deducted prior to setting the daily unit value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024, there were no significant transfers between Level 1 and 2 and no transfers into our out of Level 3.

NOTE 6 - PLAN TERMINATION

Although they have not expressed any intent to do so, the Companies have the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. Upon termination, all participants become 100% vested in their accounts.

NOTE 7 - TAX STATUS

The Internal Revenue Service has determined and informed the Companies by a letter dated January 30, 1995, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

NOTE 7 - TAX STATUS - CONTINUED

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9 - PARTY-IN-INTEREST

Plan investments are shares of registered investment companies and common/collective funds managed by Principal Life Insurance. Principal Trust Company is the trustee as defined by the Plan. Purchases and sales of these funds are performed in the open market at fair value and qualify as party in interest transactions under ERISA regulations. Fees paid by the Plan investment management services were included as a reduction of the return earned on each fund.

Contract Administrator fees paid the by the Plan to Principal Life Insurance Company, amounted to \$106,758 for the year ending December 31, 2024.

Investment advisory fees paid by the Plan to Choreo, LLC amounted to \$41,877 for the year ending December 31, 2024.

These transactions are permitted under provisions of the Plan and are specifically exempt from the prohibition of party in interest transactions under ERISA.

NOTE 11 - DATE OF MANAGEMENT'S REVIEW

Subsequent events were evaluated through October 1, 2025 which is the date the financial statements were available to be issued.

In October 2025, the Sponsor of the Plan sold substantially all of the assets of Jensen Crane Services, Inc.
