### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Cleaning Technologies Group, LLC 401(k) Profit Sharing Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### Notes to Financial Statements

---

#### Note 1. Plan Description

The following description of the Cleaning Technologies Group, LLC 401(k) Profit Sharing Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering substantially all nonunion employees of Cleaning Technologies Group, LLC (the Company) who are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions:** Each eligible employee (participant), as defined in the Plan, may elect to contribute, through payroll deductions, a percentage of their compensation limited to the maximum allowable under the Internal Revenue Code (IRC) for such plan year. Plan participants may contribute from 1% to 100% of their annual salary on a pretax or after-tax basis. Eligible employees are automatically enrolled in the Plan with an elective pretax deferral rate of 3% of compensation, increasing 1% annually (up to 10%), unless the participant affirmatively elects out of the automatic deferral feature or elects a different deferral rate. Participants may change their contribution amount at any time. The Plan allows participants who have attained age 50 by the end of the plan year to make catch-up contributions in accordance with Code Section 414(v). Participants may also contribute amounts on a pretax basis representing distributions from other qualified plans.

The Plan provides for employer matching contributions of 100% of the first 1% and 50% of the next 5% of eligible compensation deferred. The Company may also make additional matching contributions and discretionary contributions. No additional matching or discretionary contributions were made during 2024.

**Participant accounts:** Each participant's account is credited with the participant's own contributions and an allocation of any Company contributions and an allocation of plan earnings and losses and is charged with their own benefit payments and an allocation of administrative expenses. Allocations are based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment options:** Upon enrollment in the Plan, a participant may direct contributions in a variety of investment choices more fully described in the Plan's literature. Participants may change their investment options at any time.

**Notes receivable from participants:** Participants may borrow from their accounts subject to certain minimum and maximum amounts, as prescribed in the Plan and in the IRC. Notes receivable are collateralized by the participant's account and bear interest at rates commensurate with local prevailing rates as determined by the Plan Administrator. Participants are limited to one outstanding note at any given time. Principal and interest are paid ratably through payroll deductions.

**Payment of benefits:** A participant may receive the vested interest of his or her account upon normal retirement at age 65, total disability, or termination of service. Upon death of a participant, the beneficiary shall be entitled to the vested interest of the account. Distributions are made in either a lump-sum or installment payments. Participants who have attained the age 59½ may request voluntary withdrawals of all or part of their account balances. Hardship withdrawals, as defined in the Plan, are also available to the participants and limited to participant deferral account balances.

#### Note 1. Plan Description (Continued)

**Vesting:** Participants are immediately vested in their contributions plus actual earnings thereon. For employer matching contributions, a participant is fully vested after two years of credited service. For discretionary contributions, participants become vested at 20% per year of service and are fully vested at five years of credited service. Participants who have attained early retirement age of 55 or have terminated as a result of death or disability, are immediately fully vested in Company contributions, plus actual earnings thereon.

**Forfeitures:** If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future Company contributions or to pay administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited account balances totaled \$40,382 and \$42,258, respectively. Forfeitures of \$24,640 were used to reduce Company contributions in 2024. Accumulated forfeitures will be applied to pay expenses or reduce Company contributions in 2025.

**Plan termination:** Although it has not expressed any intent to do so, the Company has the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make certain estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions:** Participant contributions and Company matching contributions are recognized when the participant contributions are withheld from the participant's earnings. Discretionary Company contributions are recognized when declared.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Notes receivable from participants are written off when deemed uncollectible.

**Risk and uncertainties:** The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Payments of benefits:** Benefits are recorded when paid.

#### Note 2. Summary of Significant Accounting Policies (Continued)

**Administrative expenses:** The Plan is responsible for certain administrative expenses, which are recognized when incurred. A portion of the administrative expenses are paid by the Company, at the Company's discretion.

**Subsequent events:** The Plan Administrator has evaluated subsequent events through October 10, 2025, the date on which the financial statements were available to be issued.

#### Note 3. Information Certified by Fidelity Management Trust Company

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution.

Fidelity Management Trust Company also certified to the completeness and accuracy of \$2,036,145 of net appreciation in the fair value of investments, \$675,492 of interest and dividends related to the aforementioned investments, and \$17,711 of interest income on notes receivable from participants for the year ended December 31, 2024.

#### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification 820 guidance are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

#### Note 4. Fair Value Measurements (Continued)

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methods used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

**Money market fund:** Valued at the closing price reported on the active market on which the individual security is traded.

**Mutual funds:** Valued at quoted market prices which represent the net asset value (NAV) of the shares held by the Plan at year-end.

**Self-directed brokerage accounts:** Accounts primarily consist of mutual funds and common stocks that are determined by obtaining quoted prices on nationally recognized securities exchanges.

**Common/collective trust:** A stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the NAV of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require up to 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

#### **Note 6. Tax Status**

The nonstandardized pre-approved plan opinion letter has been relied upon by the Plan. The Plan has been amended since the nonstandardized preapproved plan document provider received the opinion letter. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.
