Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Alley Theatre 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Alley Theatre 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

Notes to Financial Statements for the year ended December 31, 2024

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Alley Theatre 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering substantially all employees of the Alley Theatre (the Alley) who are not union employees, nonresident aliens, temporary employees, seasonal employees, production help, or part-time employees whose regularly scheduled service is less than 1,000 hours. Covered employees over the age of 21 are eligible to participate after one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions – The Plan provides for contributions by both the participant and employer as follows:

- *Participant contributions* – Participants may elect to defer up to 100% of their compensation as defined by the Plan, subject to certain limitations under the Internal Revenue Code (the Code). All eligible participants automatically defer 5% of compensation each pay period, unless the participant elects not to defer or to defer an alternative amount. The Plan allows catch-up contributions, as defined by the Code, for participants who have attained the age of 50 prior to the end of the plan year. Participants also may rollover any amounts they receive as distributions from another qualified retirement plan and make after-tax Roth contributions to the Plan.
- *Employer contributions* – For all eligible employees, the Alley makes safe harbor matching contributions equal to 100% of the participant's contribution that do not exceed 5% of the participant's compensation as defined by the Plan. The Alley may make a discretionary profit sharing or an additional discretionary matching contribution to participants. There were no additional discretionary employer contributions in 2024.

Participants direct the investment of all contributions into investment options offered by the Plan.

Vesting – Participants are immediately 100% vested in all contributions plus actual earnings thereon.

Participant accounts – Each participant's account is credited with the participant's contributions, employer contributions, and an allocation of the investment income and expenses for each fund in which the account is invested. Allocations of investment income are based on the proportion that each participant's account balance bears to the total of all participant account balances. Plan expenses not paid by the employer are allocated to each participant's account. The only benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Notes receivable from participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by the highest outstanding loan balance in the preceding one-year period or 50% of their account balance. No more than two loans can be outstanding at any one time. The loans are secured by the balance in the participant's account. Loan terms range from one to five years, unless the loan is used to purchase a primary residence, for which loan terms may range up to ten years. Interest rates are determined by the plan administrator.

Benefit payments – The Plan provides for benefit distributions to plan participants, or their beneficiaries, equal to the balance of their accounts upon death, disability, retirement, or other termination of employment. Participants may withdraw a portion or all of their elective participant contributions, while still employed, upon reaching the age of 59½. Additionally, participants may qualify for a hardship withdrawal of their elective participant contributions, while still employed, for the purpose of immediate and heavy financial needs, as defined by the Plan.

Plan termination – Although it has not expressed any intent to do so, the Alley has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting – The Plan’s financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment valuation – Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s management determines the Plan’s valuation policies utilizing information provided by the investment advisers and insurance company. See Note 6 for discussion of fair value measurements.

The Plan invests in a fully benefit-responsive investment contract, the AUL Stable Value Account, and presents this investment in the financial statements at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The contract value for the fully-benefit responsive investment contract represents contributions plus earnings, less participant withdrawals and administrative expenses.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Contributions from Plan participants and the employer matching contributions are recorded in the year in which the participant contributions are withheld from compensation.

Benefit payments – Benefit payments to participants are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid directly by the Alley and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant’s account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Estimates – Management must make estimates and assumptions to prepare financial statements in accordance with generally accepted accounting principles. These estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities, and the reported amounts of additions and deductions. Actual results could vary from the estimates that were used.

NOTE 3 – TAX STATUS

The Alley has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated August 19, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Code. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The plan sponsor has indicated that it will take the necessary steps, if any, to bring the Plan’s operations into compliance with the Code.

NOTE 4 – INVESTMENTS

At December 31, 2024 and 2023, substantially all assets of the Plan were invested in funds managed by American United Life Insurance Company (AUL), as an insurance company of the Plan. These transactions qualify as party-in-interest transactions. These transactions are exempt from the prohibited transaction rules of ERISA.

Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and participant account balances.

NOTE 5 – INFORMATION CERTIFIED BY INSURANCE COMPANY

Certain information in the accompanying financial statements and ERISA-required supplemental schedules related to notes receivable from participants and investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by AUL, a qualified institution.

NOTE 6 – FAIR VALUE MEASUREMENTS

Generally accepted accounting principles require that certain assets and liabilities be reported at fair value and establish a hierarchy that prioritizes inputs used to measure fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The three levels of the fair value hierarchy are as follows:

- *Level 1* – Inputs are unadjusted quoted prices in active markets for identical assets or liabilities that the reporting entity has the ability to access at the reporting date.
- *Level 2* – Inputs are other than quoted prices included in Level 1, which are either directly observable or can be derived from or corroborated by observable market data at the reporting date.
- *Level 3* – Inputs are not observable and are based on the reporting entity’s assumptions about the inputs market participants would use in pricing the asset or liability.

- (a) The investment accounts included in the pooled separate accounts consist of (1) managed asset allocation accounts, (2) equity accounts, (3) fixed-income accounts, and (4) global and international equity accounts. Managed asset allocation accounts seek high total return over time through a combination of capital appreciation and income by investing in an asset allocation strategy designed for investors planning to retire at certain intervals. Equity accounts seek a favorable rate of return through capital appreciation and investment income by investing primarily in a broadly diversified portfolio of U. S. common stocks. Fixed-income accounts seek a maximum total return, consistent with preservation of capital by investing in fixed-income securities. Global and international equity accounts seek a favorable long-term rate of return through capital appreciation and income from broadly diversified portfolios that consist primarily of foreign and domestic equity securities. There are no participant-directed redemption restrictions; however, the Plan is required to provide a notice 7 days in advance to liquidate its entire share in the accounts.

Pooled separate accounts are variable annuities valued at net asset value per share as determined by the issuer based on market quotations of the underlying investments or prices obtained from independent sources who may employ various pricing methods to value the underlying securities. There has been no change in the valuation method used at December 31, 2024 and 2023.

This valuation method may produce a fair value that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate, the use of different methods or assumptions could result in a different fair value measurement at the reporting date.

NOTE 7 – INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan entered into a fully benefit-responsive investment contract with AUL. The general account portion of this contract, or the AUL Stable Value Account, is an interest-earning investment option, and the assets in the account are commingled with other assets of the insurance company. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The crediting rate is determined yearly by the issuer but may not be less than 1%.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events may limit the ability of the Plan to transact at contract value with AUL. Such events include termination of the contract, spin-offs, divestitures, layoffs, partial or total plan termination and liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment may apply. The Alley does not believe the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

NOTE 8 – SUBSEQUENT EVENTS

Effective January 1, 2025, the Plan was amended to change eligibility from one year of service to six months of service and to include a provision to allow for Roth rollover contributions.

Management has evaluated subsequent events through October 8, 2025, which is the date that the financial statements were available for issuance. As a result of this evaluation, no other events were identified that are required to be disclosed or would have a material impact on reported net assets available for benefits or changes in net assets available for benefits.
