INDEPENDENT AUDITORS' REPORT

To the Trustees and Management
Mid-Atlantic Solutions, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Mid-Atlantic Solutions, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Mid-Atlantic Solutions, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Note 1 Description of Plan

The following description of the Mid-Atlantic Solutions, Inc. ("the Company") 401(k) Plan, ("the Plan"), established on January 1, 2017, provides only general information. Interested parties should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a section 401(k) defined contribution plan covering eligible employees. Employees are eligible to participate in the Plan after completing three months of service and attaining age 18. Upon completion of the eligibility requirements, employees are automatically enrolled in the Plan at a deferral rate of 2% per pay period unless the participant declines participation. Automatic deferrals will increase 1% per year up to a maximum of 3% on the anniversary date of the eligible employee's initial automatic deferral. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan also allows participants to obtain loans from the Plan in accordance with the Plan's loan policy.

Contributions

Each participant may authorize the employer to withhold from his or her compensation up to the maximum allowed under the provisions of Internal Revenue Code Section 415. The Company may elect to make discretionary matching contributions and/or profit sharing contributions to the Plan. Employer matching contributions are allocated up to a discretionary percentage of a participant's compensation, on a uniform basis for all participants, as determined by the Company. The Company's profit sharing contributions are allocated based upon each participant's compensation in proportion to the compensation of all participants. The Company did not make a matching or profit sharing contribution in 2024 and 2023. The Company made a corrective employer contribution of \$ 866 in 2024 for 2023 for omitted deferral calculation on participant car allowance compensations.

Participant's account

Each participant's account is credited with the participant's contribution, Company's contribution, and Plan earnings, and charged with an allocation of any administrative expenses paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$ 1,000 up to a maximum of \$ 50,000 or 50% of their account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Principal and interest is paid ratably through payroll deductions.

Note 1 Description of Plan (cont'd)Vesting

Participants are immediately vested in the accumulated value of their elective contributions to the Plan.

With respect to the Company's discretionary profit sharing and employer matching contributions, participants are vested as follows:

Payment of benefits

Upon termination of service due to death, disability, retirement, or termination of employment, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a ten year period. A lump sum distribution is automatic for account balances of \$ 7,000 or less.

Forfeitures

Forfeitures may first be used to pay any administrative expenses and then used to reduce any employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$ 0. Also, during 2024 and 2023, there were no used or unused forfeitures.

Note 2 Summary of significant accounting policiesBasis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of estimates in the preparation of financial statements

The preparation of financial statements in conformity with U. S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Note 2 Summary of significant accounting policies (cont'd)Investment valuation and income recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Income tax status

The Internal Revenue Service has determined and informed the company in a letter dated November 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examination for years prior to 2021.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Note 2 Summary of significant accounting policies (cont'd)Benefit payments

Benefit payments are recorded when paid.

Note 3 Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Mutual funds - valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 5 Plan termination

Although it has not expressed an intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will continue to be 100 percent vested in their accounts.

Note 6 Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

Note 7 Related-party transaction and party-in-interest transactions

The Plan invested in shares of mutual funds managed by Mutual of America. Mutual of America acted as custodians for only these investments as defined in the Plan. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

Effective January 1, 2024, Mutual of America became the new custodian and provides certain administrative services to the Plan pursuant to a service agreement between the Company and Mutual of America. For the administration of the Plan and for recordkeeping services, an annual fee of 0.62% (billed monthly) is charged to the Plan's account. Fees incurred by the Plan for recordkeeping and administration services with Mutual of America were \$ 7,899.
