### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the A.M.C. Management Corp. (the Company) 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

*General*

The Plan is a defined contribution plan covering substantially all eligible employees of the Company who have one year of service and are age twenty-one or older. The Plan does not include union employees, leased employees, non-resident aliens, and interns. The Plan is subject to the provisions of ERISA.

The Plan was created on January 1, 2021 with a special effective date of November 15, 2021. At that time, eligible employees affirmatively elected to participate in the Plan and the safe harbor match was a single rate equal to 100% of a participant's contribution that was not in excess of 4% of the participant's compensation.

The Plan was amended on January 1, 2022 to implement a Qualified Automatic Contribution Arrangement ("QACA") whereby participants without an existing affirmative election or whose affirmative election was less than the automatic enrollment amount were automatically enrolled at a 6% contribution rate. The safe harbor match was updated to a two rate formula to include 100% of the participant's contribution for the first 1% of compensation plus 50% of the participant's contribution in excess of 1% but does not exceed 6% for a maximum safe harbor match of 3.5%.

*Contributions*

Participants may elect to defer a percentage of their pretax or after tax annual compensation subject to annual deductibility limits specified under the Internal Revenue Service limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified benefit or defined contribution plans (rollover). Participants direct the investment of their contribution into various investment options offered by the Plan. Effective January 1, 2022, eligible employees will be automatically enrolled in the Plan at 6% of compensation for each payroll period unless the employee elects a different deferral percentage or elects not to participate in the Plan.

The Plan also allows the Company to make safe harbor matching contributions and discretionary non-elective contributions. During the years ended December 31, 2024 and 2023, the Company matched 100% of the first 1% plus 50% of the next 5% of compensation that a participant contributed to the plan, for a maximum safe harbor contribution of 3.5%. There were no discretionary non-elective contributions during the years ended December 31, 2024 and 2023.

*Participant Accounts*

Each participant's account is credited with the participant's deferral contributions, rollovers, the Company's safe harbor matching contributions, the Company's discretionary non-elective contributions, and a proportionate interest in the investment earnings or losses of the funds which the contributions are invested. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balance, or specific participant transactions, as defined. Participants may direct employee contributions to any of the Plan's investment alternatives and may transfer among investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting*

Participants are vested immediately in their contributions, the Company's safe harbor contributions, and their rollover contributions plus actual earnings thereon. Prior to amending the Plan, vesting in the Company's discretionary non-elective contributions was over a 6 year graded schedule. Effective January 1, 2022, vesting in the Company's discretionary non-elective contributions is subject to the 2-6 year graded vesting schedule, whereby vesting begins at 20% after two years of service and increases 20% per year until 100% is reached in year six.

*Forfeited Accounts*

At the year ended December 31, 2024 and period ended December 31, 2023, forfeited nonvested accounts totaled \$0 and \$0, respectively. These accounts will be used to reduce future employer contributions or to pay administrative expenses of the Plan. In 2024 and 2023, employer contributions were reduced by \$0 and \$0, respectively, and administrative expenses were reduced by \$0 and \$0, respectively, from forfeited nonvested accounts.

*Notes Receivable From Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest between 4.25% and 9.50% which is commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest is paid ratably through payroll deductions.

*Payment of Benefits*

On termination of service, death, disability, or retirement, the participant or their beneficiary may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants may request a withdrawal of a portion of their employee contribution account balance if they can demonstrate financial hardship as defined by the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

*Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

*Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 3 for discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes realized and unrealized changes in fair value of investments bought, sold, and held during the year.

*Notes Receivable From Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

*Benefit Payments*

Benefit payments are recorded when paid.

*Plan Expenses*

The Plan's administrative expenses are paid by either the Plan or the Company as provided by the Plan document, except for certain account activity charges which are paid from the accounts of the participants that incurred the charge. Investment management fees and 12B-1 distribution fees are paid by the Plan in the form of reductions of net investment income earned by Plan participants.

NOTE 3 - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1                      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2                      Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3                      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at years ended December 31, 2024 and 2023.

*Mutual funds:* Valued using the NAV provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus the liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in the active market. The fair value of mutual funds are reflected in Level 1.

*Cash :* Valued at its face amount and is reflected in Level 1.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 - RELATED-PARTY TRANSACTIONS

From January 1, 2022 through July 10, 2023, Plan investments are managed by Principal Trust Company. Principal Trust Company is the Custodian, as defined by the Plan and, therefore, transactions in these securities are considered to be party-in-interest transactions. Fees paid by the plan for investment management services are included in net investment income.

Beginning July 11, 2023, Plan investments are managed by Matrix Trust Company. Matrix Trust Company is the Custodian, as defined by the Plan and, therefore, transactions in these securities are considered to be party-in-interest transactions. Fees paid by the plan for investment management services are included in net investment income. Human Interest, Inc. provides recordkeeping services and service as a 3(16) Plan administrator.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their account balances.

NOTE 6 - TAX STATUS

The Plan has adopted a preapproved Profit Sharing Plan with CODA and the Internal Revenue Service has determined on June 30, 2020, that the plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has not obtained an individual determination letter and has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 8 - INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

All investment information and transactions in those assets included in the accompanying financial statements and supplemental schedules at years ended December 31, 2024 and 2023 were obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the Plan's custodian. Matrix Trust Company provided a certification for the years ended December 31, 2024 and 2023.
