**NOTE A – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements follows:

1. Basis of Presentation

The accompanying financial statements of Kowalski Companies, Inc. 401(k) Plan for Union Employees (the Plan) have been prepared under the modified cash basis of accounting which is a basis of accounting other than accounting principles generally accepted in the United States of America. The cash basis of accounting has been modified to report investments at fair value.

2. Valuation of Investments

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales are recorded on the trade date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net change in fair value includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan presents, in the statement of changes in net assets available for benefits, the net change in the fair value of its investments which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments.

3. Contributions

Contributions from Plan participants and Employer contributions, if any, are recorded in the year in which the contributions are received by the Plan.

4. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when paid under the modified cash basis of accounting. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

**NOTE A – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – CONTINUED**

5. Participant Direction of Investments

Subject to the provisions of the Plan, a participant has the right to direct the investments of the balance in their accounts in the specific investment funds made available by the Plan administrator. At December 31, 2024 and 2023 all investments are participant directed.

6. Payment of Benefits

Benefits are recorded when paid.

7. Use of Estimates

The preparation of financial statements in accordance with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**NOTE B – DESCRIPTION OF THE PLAN**

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General and Eligibility

The Plan is a defined contribution plan of Kowalski Companies, Inc. (the Employer). The Plan covers certain employees under a collective bargaining agreement, as defined by the Plan. An employee is eligible for participation immediately. An eligible employee may become a participant on the next Plan entrance date, which is the beginning of the first pay period after the first 30 days of employment.

The Employer is responsible for appointing an administrator and trustee for the Plan. The trustee has discretionary powers in executing investment transactions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The costs of the Plan administration are the responsibility of the Plan.

**NOTE B – DESCRIPTION OF THE PLAN - CONTINUED**

2. Contributions

The Plan allows participants to contribute up to 80% of annual eligible compensation, as defined by the Plan, subject to limits imposed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing rollover distributions from other qualified defined benefit or contribution plans.

The Plan allows full-time employees meeting the minimum age requirement of 18 to participate in Employer contributions upon date of hire. Part-time employees are eligible to receive Employer contributions upon completion of one year of service. A year of service is defined as a consecutive 12-month period in which the employee has 1,000 or more hours of service either immediately following the date of hire, or during the Plan year following the date of hire.

Eligible participants earn Employer contributions based on each hour of service performed since the date of hire, up to 40 hours per week. The specific rate for contributions are as follows:

- Employees classified as full-time Retail Meat Cutters and Food Handlers hired before March 6, 2016 receive \$3.32 per hour of service;
- Employees classified as full-time Retail Meat Cutters and Food Handlers hired on or after March 6, 2016 receive \$1.93 per hour of service;
- Employees classified as part-time Retail Meat Cutters and Food Handlers receive \$1.43 or \$1.00 per hour of service based on employee type.

3. Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the Employer's discretionary contributions, (b) forfeitures of terminated participant non-vested accounts, and (c) investment income or loss on investments less administrative expenses. Allocations are based on participant compensation or account balances, as defined.

Changes in a participant's deferral percentage for future contributions may be made monthly during the Plan year. Reallocation of participant investment accounts among the investment options may be made at any time during the Plan year.

**NOTE B – DESCRIPTION OF THE PLAN – CONTINUED**

4. Vesting

Participants immediately vest in their employee and the Employer's qualified non-elective contributions. Participants vest in all other Employer contributions at the rate of 20% after one year of service, 20% per year and become 100% vested after five years of service, as defined by the Plan. Only whole years of service are calculated for vesting.

5. Payment of Benefits

Benefit payments are made in the form of a single lump sum following retirement, disability, death, or termination of the participant's employment. Participants with balances of \$1,000 or less are subject to involuntary lump sum distributions. Participants with account balances between \$1,000 and \$7,000 are subject to involuntary lump sum distributions to a qualified money market account.

6. Notes Receivable from Participants

Loans to participants from a participant's vested balance are permitted up to the lesser of 50 percent of the vested balance or a maximum of \$50,000 for each participant. The minimum note amount is \$1,000. The loans shall bear a reasonable rate of interest, be adequately secured, and have a definite repayment schedule, generally over a period not to exceed five years unless the loan is for the purchase of the employee's primary residence. Loans used for the purchase of the employee's personal residence may be repaid within a period of no more than 30 years. Principal and interest are paid ratably through payroll deductions.

7. Forfeited Accounts

Forfeited non-vested accounts are reallocated as additional Employer contributions. As of December 31, 2024 and 2023, the balance of unapplied forfeitures of non-vested accounts is approximately \$27,900 and \$64,500, respectively. Forfeitures reallocated as additional Employer contributions are approximately \$51,400 for the year ending December 31, 2024.

8. Risks and Uncertainties

The Plan is comprised of investments in a combination of investment securities. Investment securities are exposed to various risks, such as interest, market, and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE D – FAIR VALUE MEASUREMENTS**

Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

**NOTE D – FAIR VALUE MEASUREMENTS - CONTINUED**

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation method used for assets measured at fair value. There have been no changes in the method used at December 31, 2024 and 2023.

*Interest bearing cash:* Valued at the market value of cash held by the Plan at year end.

*Mutual funds:* Valued at the net asset value (NAV) of shares held by the Plan at year end based on quoted market prices.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE E – FEDERAL INCOME TAXES**

The Plan has adopted the Non-Standardized Pre-Approved Profit Sharing Plan With CODA, of Oak Creek Partners, LLC. The sponsor obtained its latest advisory letter dated June 30, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the advisory letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date. See Note H for reconcilable differences between the financial statements and the Form 5500 as of December 31, 2024 and 2023 and for the year ended December 31, 2024.

The Plan's policy is to evaluate the likelihood that its uncertain tax positions will prevail upon examination based on the extent to which those positions have substantial support within the Internal Revenue and Regulations, Revenue Rulings, court decisions, and other evidence. The federal income tax returns of the Plan are subject to examination by the IRS generally for three years after they were filed.

**NOTE F – PARTY-IN-INTEREST TRANSACTIONS**

Ascensus, Inc. is the record keeper of the Plan.

Ascensus Trust Company is the trustee of the Plan.

The Vanguard Group, Inc. is the custodian of the Plan.

Oak Creek Partners is the third-party administrator of the Plan.

**NOTE G – ADMINISTRATIVE EXPENSES**

The Plan pays administrative expenses that consist primarily of administrative fees to the trustee. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses. All other administrative expenses, such as professional fees, are paid by the Employer on behalf of the Plan.

**NOTE J – SECURE ACT 2.0**

On December 29, 2022, President Biden signed into law the Consolidated Appropriations Act of 2023, which includes the package of retirement provisions referred to as “SECURE Act 2.0”. SECURE Act 2.0 contains over 90 new retirement provisions continuing the reforms that began with the 2019 SECURE Act. These provisions have varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. There is no material impact to the Plan’s 2024 financial statements.

**NOTE K – SUBSEQUENT EVENTS**

The Company has evaluated subsequent events through October 7, 2025, the date which the financial statements were available to be issued.
