In performing an audit in accordance with generally accepted auditing standards, we:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### 1. Description of plan:

The following description of Blue Diamond Legacy Holdings, Inc. Employee Stock Ownership Plan (the Plan) (formerly known as the KE&G Construction, Inc. Employee Stock Ownership Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan was established on August 28, 2006, retroactively effective as of January 1, 2006. The Plan has been amended and restated effective January 1, 2024.

#### General:

The Plan Sponsor is Blue Diamond Legacy Holdings, Inc. (Sponsor or Company). The Plan is designed to comply with the appropriate sections and regulations of the Internal Revenue Code (IRC) and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by a Trustee who is appointed by the Blue Diamond Legacy Holdings, Inc. Board of Directors.

Effective January 1, 2024, the Sponsor restructured its organization under the provisions of IRC Section 368(b). The Plan exchanged 100% of its shares of KE&G Construction, Inc. for shares of Blue Diamond Legacy Holdings, Inc.

#### Eligibility and vesting:

The Plan covers substantially all employees (excluding temporary employees) of the Company who have completed 1,000 or more hours of service during a Plan year. Participants vest at 20% annually beginning with the completion of their second year in the Plan and are fully vested after six years of service or upon the normal retirement date. The Plan defines a year of service to be a Plan year (January 1 - December 31) with the participant rendering at least 1,000 hours of service. Upon death or total disability of a participant prior to retirement, the participant's account balance shall become fully vested.

#### Employer contributions:

Employer contributions are made to the Trust in such amounts as may be determined by the Company's Board of Directors, provided they do not exceed the maximum amounts deductible under the IRC. Allocations of the employer contributions are made pro-rata based upon covered compensation as defined in the Plan.

Contributions can be made in cash, shares of Company stock or a combination of both as the Company's Board of Directors may determine. Shares of Company stock are valued at their fair market value as of the end of the Plan year.

The Plan may also receive S corporation distributions any time the Company's Board of Directors declares such distributions. The Plan did not receive S corporation distributions during 2024.

### 1. Description of plan (continued):

#### Participants' accounts:

Each participant's account is credited as of the last day of each Plan year allocations of common stock at fair value, employer contributions, Plan earnings and forfeitures of other participants' non-vested account balances. Participant accounts are also credited with their pro-rata share of cash held in the Trust. Contributions and allowable forfeitures (both cash and reallocated shares) are allocated to each participant's account in the ratio of the participant's covered compensation as defined by the Plan document, relative to the total covered compensation. Plan earnings are allocated to each participant's account using a ratio of the participant's applicable beginning of the year account balance to the total applicable beginning account balance, adjusted for specific current year activity, as defined in the Plan document. The Plan does not permit participant contributions.

#### Forfeitures:

The non-vested portion of terminated participants' accounts remains in the Plan, with no additional contributions or forfeitures allocated to it. Upon the earlier of the distribution of the vested portion of the participant account or completion of a break-in-service of five or more consecutive years, the non-vested portion of the account is forfeited. The forfeited amounts are then reallocated to the accounts of remaining Plan participants at the end of the Plan year in which the forfeiture occurs, or if later, the date of the break-in service. Forfeitures are allocated to remaining active participants in the same way as Company contributions. During 2024, \$611,937 of forfeitures were allocated to eligible participant accounts. At December 31, 2024, forfeitures to be reallocated in future periods were \$1,298,011, using the assumption that all separated participants remain so throughout their respective five-year service break periods.

#### Diversification:

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of eligible service as defined in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive a cash distribution. Diversification payments made in 2024 totaled \$276,844. These payments are included in benefits paid to participants in the financial statements.

#### Payment of benefits:

No distributions from the Plan, other than diversification, are made until a participant retires, dies, is disabled, or otherwise terminates employment with the Company. Normal retirement age is 65. Distributions can be made in cash, or at the discretion of the Plan Administrator, in stock which must be immediately sold to the Company at fair value. The participant shall not have any right to receive shares of the Company's stock.

Payment of benefits (continued):

Distributions for reasons of death or disability shall commence as soon as practical after the close of the Plan year in which the event occurs. Distributions for retirement will commence in the year after the participant reaches normal retirement age. Distributions for any other reason, except diversification, shall commence no later than the sixth Plan year following the Plan year in which the distributable event occurs. Distributions for any reason, for a participant with an account balance less than \$10,000 will commence in the year after termination.

Benefit payments will be made in lump sum amounts up to predetermined thresholds depending on the distributable event. Retirement and disability distributions will be paid in lump sum amounts up to \$20,000, death distributions will be paid in lump sum amounts up to \$50,000 and termination of employment distributions will be paid in lump sum amounts up to \$10,000. If account balances are above the noted thresholds, amounts are distributable in up to five installments. Each installment shall be the greater of (1) the account balance as of the last valuation date divided by the remaining number of installments, (2) the noted threshold amounts or (3) the remaining account balance if it is less than the noted thresholds. In all cases, the participant whose account balance exceeds \$7,000 must consent in writing to receive a distribution. If a participant's account balance is less than \$7,000, consent is not required for a distribution.

For those balances exceeding \$1,380,000, the five-year payout period will be extended by an additional year, but not more than five additional years, for each \$275,000 or fraction thereof by which the balance exceeds \$1,380,000, based on current statutory limits determined annually and prescribed by the Internal Revenue Service (IRS).

Voting rights:

The Trustee normally votes the Plan's shares. However, under certain circumstances prescribed by the Plan document and regulation, each participant is entitled to exercise voting rights attributable to the shares allocated to their account and is notified by the Trustee prior to the time that such rights are to be exercised. The Trustee will vote any share for which instructions have not been given by a participant.

Put option:

In the event that a participant receives a distribution in Company stock which is not required to be immediately repurchased by the Company, the stock will be subject to a put option. The put option grants the participant the right for a sixty-day period after the stock is distributed to require the Company to purchase the distributed Company stock at fair market value. If the put option is not exercised within the first sixty days, the participant will have an additional sixty days in the following plan year. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

### 2. Summary of significant accounting policies:

#### Basis of accounting:

The financial statements of the Plan are prepared using the accrual method of accounting.

#### Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Trustee to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Investment valuation and income recognition:

The Plan's investments are reported at fair value. The common shares of the Company are valued at fair value on December 31, 2024 and 2023 as determined by annual independent appraisals.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Net appreciation in the fair value of investments includes both realized and unrealized gains and losses on investments bought and sold as well as held during the year.

#### Payments of benefits:

Benefits paid to participants are recorded when paid.

#### Expenses:

Certain expenses of maintaining the Plan are paid by the Plan unless otherwise paid for by the Company.

#### Subsequent events:

The Plan has evaluated the events that have occurred subsequent to December 31, 2024 through October 8, 2025, the date that the financial statements were available to be issued. The Plan has no responsibility to update these financial statements for events and circumstances occurring after this date.

### 3. Federal income tax status:

The IRS has determined and informed the Plan by a letter dated June 23, 2015, that the Plan and related Trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the determination letter. However, the Trustee and the Plan Sponsor believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified, and the related trust is tax-exempt as of the financial statement date.

3. Federal income tax status (continued):

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets or active markets that the Plan does not have access to;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Interest-bearing cash: Consists of highly liquid instruments that generate interest income. The carrying value of interest-bearing cash is its fair value.

Company common stock: Investments are valued on an annual basis by an independent valuation analyst using generally accepted valuation approaches and level 3 inputs. The value of this asset was measured using a blend of market, cost and income approaches, consistent with prior years.

The valuation process involves the selection of an appraiser under an annual contract. Plan management accumulates the data for the appraiser from historical and projected financial information of the Company. The appraiser prepares a preliminary report that plan management, along with the ESOP Trustee, reviews in detail, discusses, and approves.

4. Fair value measurements (continued):

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Administration of plan assets:

The Plan's assets, which consist primarily of Blue Diamond Legacy Holdings, Inc. common shares, are held by the Plan's Trustee. All of the Plan's assets are nonparticipant directed. Contributions are held and managed by the Trustee, who deposits cash and makes distributions to participants.

6. Related party and party in interest transactions:

The Plan invests in common stock of the Sponsor. The Plan paid certain expenses to Principal Life Insurance Company, the third-party administrator, and other services providers during 2024 related to the Plan administration. These transactions qualify as exempt party in interest transactions under ERISA.

Expenses that are paid directly by the Sponsor are excluded from these financial statements. Employees of the Sponsor perform certain accounting and administrative functions for the Plan, however, no employee receives compensation from the Plan.

7. Plan termination:

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions and to terminate the Plan at any time, subject to the provisions of ERISA. Upon such termination, the interest of each participant will be distributed to them or their beneficiary at the time prescribed by the Plan terms and the applicable regulations. Upon termination of the Plan, participants become 100% vested and the Trustee shall direct the Plan Administrator to pay all liabilities and expenses of the trust fund.

8. Risks and uncertainties:

The Plan is invested primarily in the common stock of a single entity, and as a result, is exposed to risks such as interest rate, market conditions, and other credit risks, as well as valuation assumptions based on earnings, cash flows, and other such techniques. Due to the level of risk associated with this type of investment and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of the investment will occur in the near term and that such change could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.

9. Reconciliation of financial statements to the Form 5500:

At December 31, 2024, the Form 5500 presents benefit payment checks outstanding as a liability. The financial statements have offset the liability against noninterest-bearing cash.
