## **Note 1 – Plan Description and Basis of Presentation**

The following description of the LinkUs Holdings, Inc. Employee Stock Ownership Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Agreement for complete information regarding all Plan issues related herein.

**General** – LinkUs Enterprises, Inc. established the LinkUs Enterprises, Inc. Employee Stock Ownership Plan effective as of January 1, 2012. In April 2013, the Plan and Trust was amended and restated to change the name of the company to LinkUs Holdings, Inc (the “Company”) and to change the name of the Plan to LinkUs Holdings, Inc. Employee Stock Ownership Plan. The Plan operates as a leveraged employee stock ownership plan, is designed to comply with Sections 401(a), 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (“Code”), and subsequent legislation up to and including the Community Renewal Tax Relief Act of 2000, and is subject to the applicable provisions of the Employee Retirement Security Act of 1974, as amended (“ERISA”). The Plan is administered by a Board of Trustees composed of individuals appointed by the unanimous consent of the Board of Directors.

During the year ended December 31, 2013, the Plan purchased the Company’s issued and outstanding shares in exchange for a promissory note (Note 7). The Plan holds the Company’s shares in a trust established under the Plan. The promissory note is to be repaid over a period of twenty years by fully deductible Company contributions to the trust fund. As the Plan makes each annual payment of principal and interest on the promissory note, an appropriate percentage of common stock will be allocated to eligible employees’ accounts in accordance with applicable regulations under the Code.

The promissory note is collateralized by the unallocated shares of common stock. The Company as lender has no rights against shares once they are allocated under the ESOP. Accordingly, the financial statements of the Plan as of December 31, 2024 and 2023 and for the year ended December 31, 2024 present separately the assets and liabilities and changes therein pertaining to:

1. the accounts of employees with rights in allocated common stock (allocated), and
2. common stock not yet allocated to employees (unallocated).

**Eligibility** – Employees of the Company become eligible to participate in the Plan after completing 12 consecutive months of service, in which they are credited with a minimum of 1,000 hours of service, and the employee has attained age twenty one (21). Employees become participants in the Plan on January 1 or July 1 of the plan year in which they satisfy these requirements.

Participants who are not age 21, have not completed the required minimum hours of service during such Plan year, are not employed on the last working day of a Plan year, employees who are covered by a collective bargaining agreement, or leased employees are generally not eligible for an allocation of Company contributions for such year. Participants who do not have at least 1,000 hours of service during such Plan year or are not employed on the last day of the Plan year are generally not eligible for an allocation of Company contributions for such year.

### **Note 1 – Plan Description and Basis of Presentation (Continued)**

**Employer Contributions** – The Company is obligated to make contributions in cash to the Plan which, when aggregated with the Plan's dividends and interest earnings, equal the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its term loan.

**Payment of Benefits** – The Plan provides for the payment of benefits to participants (or, if applicable, the beneficiary) as soon as administratively feasible in which the participant separates from service by reason of reaching normal retirement date, disability, death, or the sixth year following the plan year in which the participant otherwise separates from service. Distributions are generally in substantially equal installments over a period of five years following the fifth plan year. Distributions are made in cash or, if a participant elects, in the form of Company common shares plus cash for any fractional shares, except that any distribution of shares so long as the Company is an S Corporation will be immediately repurchased by the Company. The methods of distributing benefits are defined in the Plan agreement.

**Voting Rights** – Each participant is entitled to exercise limited voting rights attributable to the shares allocated to his or her account and is notified by the Trustee prior to the time that such rights are to be exercised. The trustee shall vote any unallocated shares held by the trust as well as the allocated shares for which instructions have not been given by a participant.

**Plan Termination** – The Company reserves the right to amend or terminate the Plan at any time, subject to Plan provisions. Upon termination of the Plan, the interest of each participant in the trust fund shall immediately become fully vested and will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the Code. Upon termination of the Plan, the Administration Committee shall direct the Trustee to pay all liabilities and expenses of the trust and to sell shares of financed stock held in the loan suspense account to the extent it determines such sale to be necessary in order to repay the note.

**Participant Accounts** – The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of an allocation date with an allocation of employer contributions, shares of the Company's common stock released by the Trustee from the unallocated account and forfeitures of terminated participants' non-vested accounts. Only those participants who are eligible employees of the Company as of the allocation date will receive an allocation. Allocations are based on a participant's eligible compensation relative to total eligible compensation for the allocation period. Plan earnings are allocated to each participant's account based on the ratio of the participant's account balance.

**Vesting** – If a participant's employment with the Company ends for any reason other than retirement, permanent disability or death, he or she will vest in the balances in his or her account based on years of service with the Company. Participants will vest 0% until the first two years of service are completed, and an additional 20% each year until fully vested in the sixth year.

### **Note 1 – Plan Description and Basis of Presentation (Continued)**

**Put Option** – Under Federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option available in various situations as defined in the agreement. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

**Diversification** – Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least 55 years of age with at least ten years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six year period. In each of the first five years, a participant may diversify up to 25 percent of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50 percent.

**Forfeitures** – No forfeiture shall occur on non-vested account balances until either the earlier of a distribution of the entire vested portion of the participant account or until the Plan year in which a participant incurs five consecutive one-year breaks-in-service. Forfeitures will be added to the employer contributions for the Plan year and allocated in the same manner as employer contributions are allocated for the Plan year. Forfeitures of terminated non-vested account balances allocated to remaining participants at December 31, 2024 totaled approximately \$27,000. Plan earnings are allocated to each participant based on the ratio of the participant's beginning of the year account balance to all participants' beginning of the year account balances.

**Administrative Expenses** – As provided in the Plan Agreement, administrative expenses may be paid either by the Plan or by the Company. The Company has historically paid the majority of the operating expenses for the Plan.

### **Note 2 – Summary of Significant Accounting Policies**

**Basis of Accounting** – The financial statements of the Plan are prepared using the accrual method of accounting.

**Estimates** – The preparation of financial statements in accordance with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** – The common shares of the Company are valued at estimated fair value on December 31, 2024 and 2023. Fair value is determined by annual independent appraisals (Note 6). Increases and decreases are recognized annually.

**Investment Valuation and Income Recognition (Continued)** – Dividend income is accrued on the ex-dividend date.

Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported on the average cost method. Net appreciation includes the Plan's gain and losses on investments bought and sold, as well as held during the year.

**Risks and Uncertainties** – The Plan investments consist primarily of the Company's common stock, which is exposed to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows and/or other such techniques. Due to the level of risk associated with the investment in common stock and to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in the value of common stock will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets (deficit) available for benefits.

**Payment of Benefits** – Benefits are recorded when paid.

### **Note 3 – Tax Status**

The Plan has not obtained an Internal Revenue Service determination letter; however, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, they believe that the Plan is qualified and the trust established under the Plan is tax-exempt, under the appropriate sections of the Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 4 – Administration of Plan Assets**

The Plan's assets, which principally consist of the LinkUs Holdings, Inc. common stock, are held by the Trustee of the Plan. Company contributions are held and managed by the Trustee, which invests cash received, interest, and dividend income and makes distributions to participants.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Administrative expenses for the Trustee's fees are paid directly by the Company.

## **Note 6 – Fair Value Measurements**

The accounting standards regarding fair value measurements define fair value, establish a framework for measuring fair value, and provide for enhanced disclosures about fair value measurements. Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

The standard describes three levels of inputs that may be used to measure fair value:

- Level 1 Valuation is based upon quoted prices in active markets for identical securities.
- Level 2 Valuation is based upon other observable inputs (including quoted prices for similar securities, interest rates, prepayment speeds, credit risk, etc.).
- Level 3 Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. There have been no changes in methodologies used at December 31, 2024 and 2023.

### *Cash and Cash Equivalents*

The carrying value is believed to be representative of the fair value.

The valuation process involves Plan management's selection of an independent appraiser subject to concurrence by the Trustee. Plan management accumulates the data for the appraiser from the audited financial statements of the Company. The appraiser prepares a preliminary report which Plan management, along with the Plan's Trustee, reviews in detail, discusses and approves.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **Note 7 – Note Payable**

On April 30, 2013, the Plan entered into a promissory note with the Company totaling \$34,222,111 for the purchase of 1,769,499 shares of the Company's common stock. Unallocated shares are collateral for the loan. The loan agreement provides for the note to be repaid in twenty years. The note bears interest at 3.00%, with principal and interest payable in annual installments of \$2,300,263.

### **Note 8 – Related Party and Party-in-Interest Transactions**

The Plan invests in Company common stock and has indebtedness to the Company. These are related party and party-in-interest transactions. As described in (Notes 1 and 4), the Plan has a number of service providers. Such parties are parties-in-interest under ERISA.

### **Note 9 – Legal Contingency**

At December 31, 2023, the Company, ESOP Administrative Committee, and former trustee are involved in a class action lawsuit pending in California. The plaintiffs assert to a breach of fiduciary duty and engaging in or causing prohibited transactions as it relates to the annual independent appraisal of the Company's common stock for the Plan years ended December 31, 2013 through 2018. Counsel is unable to express an opinion as to the likelihood of an unfavorable outcome or to estimate a potential range of loss to the Plan. As such, the Plan did not accrue a potential loss for the years ended December 31, 2024 and 2023.

### **Note 10 – Subsequent Events**

The Plan has evaluated subsequent events through October 6, 2025, the date which the financial statements were available to be issued. No events have occurred through this date requiring additional disclosure.
