## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Participants  
Specialty Construction Supply Retirement Plan  
Meridian, Idaho

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Specialty Construction Supply Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Specialty Construction Supply Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### Opinion

### **NOTES TO FINANCIAL STATEMENTS**

---

#### **Note A – Description of Plan**

The following description of Specialty Construction Supply Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

##### *General*

The Plan is a defined contribution plan covering all employees of Specialty Construction Supply, LLC (the Company) who have completed one year of service and are age 18 or older. It is subject to the provisions of the Employee Retirement Income Security Act (ERISA). The Company pays the administrative costs of the Plan, except certain maintenance and transaction fees charged by Charles Schwab Bank.

##### *Contributions*

Participants may elect to defer up to 100% of eligible compensation and contribute these amounts to the Plan. In addition, participants over age 50 before the close of the Plan year are eligible to defer additional catch-up contributions. The Company may, at their discretion, contribute match and/ or profit sharing contributions to active employees in the Plan. There have been no such contributions to the Plan to date.

The Company makes prevailing wage contributions to the Plan. The amount of the contribution will be based on the hourly contribution rate required under the applicable prevailing wage law for the employee’s employment classification for each construction project they perform prevailing wage services. Employees will become a participant in the Plan for prevailing wage purposes on the first day they receive payment from the Company for performing prevailing wage services. Participants’ vested interest in prevailing wage contributions is 100% at the time of contribution.

Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

##### *Participant Accounts*

Each participant’s account is credited with the participant’s contribution and allocations of the Company’s contribution and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### **Note A – Description of Plan (Continued)**

##### *Vesting*

Participants are vested immediately in their contributions and prevailing wage contributions plus actual earnings thereon. Vesting in the Company's contribution of their account is based on years of continuous service. A participant is 100% vested after six years of credited service for matching or profit sharing contributions.

##### *Payment of Benefits*

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account, or installments over a period of time. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution.

The Plan has a mandatory Cash-Out of Benefits limit of \$5,000. Participants may elect to have a lump sum payment provided directly to them or in the form of a rollover to a qualified retirement plan or individual retirement plan (IRA). If no election is made for accounts with balances between \$1,000 and \$5,000, an IRA will be established for the participant at a qualified financial institution.

##### *Forfeitures*

At December 31, 2024 and 2023 there were no forfeitures held by the Plan. These amounts would be used to pay administrative expenses or reduce future employer contributions to the Plan. No amounts were used to pay plan expenses for the year ended December 31, 2024.

##### *Administrative Expenses*

The majority of plan administration expenses are paid directly by the Plan. Some expenses of administering the Plan are paid by the Plan Sponsor on behalf of the Plan and will not be reimbursed. Investment and termination related expenses are the responsibility of the participant and deducted from the individual participant accounts.

#### **Note B – Summary of Accounting Policies**

##### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment contracts held by a defined-contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. The Plan invests in investment contracts through an annuity contract offered by the trustee. Contract value for this investment is based on the net asset value of the contract, as reported by the trustee.

##### *Use of Estimates*

The preparation of financial statements, in conformity with U.S. generally accepted accounting principles, requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

##### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Capital gain distributions are included in the dividend income. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### *Payment of Benefits*

Benefits are recorded when paid.

##### *Subsequent Events*

The Plan has evaluated subsequent events through August 27, 2025, which is the date the financial statements were available to be issued.

#### **Note C – Fair Value Measurements**

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The Plan's investments are held in pooled separate accounts and an annuity contract. The investment insurance contract is valued at contract value and is not included in the fair value table. All pooled separate account funds are valued based on unit values to perform daily account valuation. The unit value is Charles Schwab's method for valuing accounts and receives a daily price from each fund house after the close of the stock market. The figure includes the NAV and any dividends and capital gains declared. These inputs are used to arrive at the unit value of the investment.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note D – Fully Benefit Responsive Investment Contract**

The Plan invests in a fully benefit responsive investment contract with Standard Insurance Company. Standard Insurance Company maintains the contributions in its general account, which is subject to the claims of Standard Insurance Company's general creditors. There are no particular segregated or identifiable assets of Standard Insurance Company ascribed to the insurance contract.

#### **Note D – Fully Benefit Responsive Investment Contract (Continued)**

The account is credited with interest at the rate declared for a period of time that it determines and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by Charles Schwab Bank. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or other withdrawal restrictions may apply. The Plan sponsor may choose to pay the market value adjustment directly, if applicable, so that participants' contract values are not affected. Daily liquidity is available for participant contributions and withdrawals at contract value regardless of market conditions. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$165,118 and \$132,904, respectively. The crediting interest rate is based on a formula agreed upon with the issuer.

The Standard Insurance Company believes that the average yield earned by the entire fund and the actual interest rate credited to participants are the same. When considering the insurance contract's crediting rate, the yield earned on assets in Standard Insurance Company's general account is not relevant. The crediting rate is part of Standard Insurance Company's obligation to the Plan, no matter how The Standard Insurance Company's assets perform. There are no particular segregated or identifiable assets ascribed to the Plan's insurance contract.

#### **Note E – Related Party Transactions**

The Plan invests in pooled separate accounts offered by Charles Schwab Bank, who is the trustee of the Plan. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. During 2024, fees paid to Charles Schwab Bank totaled \$15,524.

#### **Note F – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the account of each participant shall become 100% vested in their employer contributions.

#### **Note G – Income Tax Status**

The Plan is intended to be a qualified plan under Section 401(a) of the Internal Revenue Code, and the Plan is interpreted, applied and administered consistent with the intent to qualify. The Plan was established through a prototype plan of Charles Schwab Bank, who had received a letter from the Internal Revenue Service indicating the Plan is acceptable. The Plan has been subsequently amended; however, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

#### **Note H – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

#### **Note I – Nonexempt Party-In-Interest Transactions**

It was noted that various participant contributions of \$134 were submitted later than required by Department of Labor (DOL) Regulation 2510.3-102 during the current year. All of the delinquent contributions for the prior years have been remitted to the Plan. The Plan Sponsor plans to credit participant accounts with the amount of investment income that would have been earned had the participant contributions been remitted on a timely basis. The lost earnings are immaterial to the Plan therefore no receivable has been recorded.
