Basis for Opinion

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

The following is a brief description of the DISH Network Corporation 401(k) Plan (the Plan) provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan and subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. On July 27, 2022, the Plan was restated effective January 1, 2022. On June 30, 2020, the IRS advised the prototype plan sponsor that the form of the prototype plan, as then designed, was acceptable under Section 401(k) of the IRC and therefore exempt from federal income taxes under the provisions of Section 501(a) of the IRC. There were no significant changes made to the Plan provisions with this restatement.

Merger

On December 31, 2023, DISH Network Corporation (DISH, the Company, and Plan Sponsor), merged with EchoStar Corporation (EchoStar). As a result of this merger, 4,379,995 shares of DISH Class A common stock held in the Plan were exchanged for 1,536,840 shares of EchoStar Class A common stock on January 2, 2024.

On December 31, 2024, the EchoStar 401(k) Plan was merged into the Plan. All assets from the EchoStar 401(k) Plan totaling \$741,823,647 were transferred to the Plan on this date.

Effective January 1, 2025, the Plan was renamed the "EchoStar Corporation 401(k) Plan."

Eligibility

Employees of DISH and its subsidiaries become eligible to participate on the first day of the next month on or after completing 90 days of service and attaining the age of 19. Employees covered by a collective bargaining agreement, leased employees, non-resident aliens, or employees of foreign affiliated employers are not eligible to participate in the Plan.

Contributions

Participants may contribute on a before-tax or after-tax (Roth) basis 1% to 75% of their pay, as defined, subject to Internal Revenue Service limitations. Participants can change their contribution percentages each month.

Employees may make rollover contributions from other qualified plans if certain criteria are met as outlined in the Plan document.

Participants are offered various investment options in which they may invest their contributions. Participants are not allowed to invest their contributions in either the DISH or EchoStar Class A common stock and they may divest of such stock resulting from employer contributions in their account at any time subject to securities laws.

An employee hired on or after January 1, 2008, who has met the Plan's eligibility requirements, is automatically enrolled to contribute 3% of compensation into the age-appropriate Fidelity target date Freedom Fund. Employees can elect to not participate in the automatic enrollment program.

1. DESCRIPTION OF THE PLAN (Continued)

Contributions (Continued)

The Company may make a discretionary matching contribution to all eligible employees that are active employees on the last day of each calendar quarter. In 2024 and 2023, DISH employees and their subsidiary employees' matching contribution was an amount equal to \$.50 for each \$1.00 contributed by an employee. In 2024, the maximum employer contribution was \$5,000. In 2023, the maximum employer contribution was \$2,500.

The Company may also make a discretionary profit sharing contribution to all active employees on the last day of the Plan year to be determined by the Company's board of directors. The discretionary profit sharing contributions are included in employer contributions (net of forfeitures). In 2024, The Company made a discretionary profit sharing contribution of EchoStar Class A common stock valued at \$22.90 per share (price at December 31, 2024) equal to 2% of eligible 2024 earnings up to a maximum of \$2,000 for each eligible employee. In 2023, the Company did not make a discretionary profit sharing contribution.

Below is a summary of employer contributions made in cash and offset by forfeitures for the years ended December 31, 2024 and 2023. When the Company stock contributions are received into the participants' accounts, it becomes participant directed as there are no restrictions on participants transferring such contributions:

Vesting

Participants are automatically 100% vested in their before-tax, Roth, and rollover contributions. Vesting in the Company's contributions is based on years of service. For matching and discretionary profit sharing contributions, a participant becomes 20% vested after one year of service, 40% vested after two years of service, 60% vested after three years of service, 80% vested after four years of service, and 100% vested after five years of service. However, if an active participant dies or becomes disabled prior to attaining normal retirement age, the participant's account becomes 100% vested.

Forfeitures

Upon reaching the break-in-service requirement, as defined in the Plan document, forfeitures generated are added to the forfeiture account balance. During 2024 and 2023, \$600,532 and \$625,573, respectively, of forfeitures were used to pay Plan expenses. Unused forfeitures of \$1,281,038 and \$1,091,670 at December 31, 2024 and 2023, respectively, are or were available to offset Company contributions or pay Plan expenses, which would otherwise be payable by the Company, in accordance with the Plan document.

Administrative Expenses

Investment fees are paid by the Plan. Administrative expenses not paid by the Plan are paid by the Company.

1. DESCRIPTION OF THE PLAN (Continued)

Notes Receivable from Participants

Participants may borrow 50% of their vested account balance, with a minimum of \$1,000 and up to a maximum of \$50,000. All general loans must be repaid within 5 years, and all home loans must be repaid within 15 years. The loans are secured by the balance in the participant's account and bear a reasonable rate of interest as defined (3.25% to 9.50% as of December 31, 2024, and 2023) which is fixed for the term of the note. The loan interest rate for new loans will be reset at the beginning of each calendar year. Principal and interest are paid ratably through payroll deductions. No more than one general and one home loan (two total loans) may be outstanding to a participant at any time.

Payment of Benefits

On termination of service for any reason or upon death or disability, a participant may elect to receive a lump-sum amount equal to the value of the vested portion of their account or may elect a direct rollover into another qualified plan or individual retirement account (IRA). Participants may also make hardship and age 59 ½ in-service withdrawals if certain criteria are met. Plan participants may receive an in-service withdrawal from the rollover source at any time.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue contributions to the Plan or terminate the Plan subject to the provisions of ERISA. Upon a complete discontinuance of contributions, termination, or partial termination of the Plan, the accounts of all affected participants shall become fully vested.

Participant Accounts

Each participant's account is credited with the participant's contribution and (a) an allocation of Company matching and discretionary profit sharing contributions, (b) plan earnings or losses, and (c) administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants can change their investment options at any time.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan prepares its financial statements on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Valuation of Investments

Investments are reported at fair value, except for fully benefit-response investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under terms of the plans. The Plan investments in an investment contract measured at contract value through the guaranteed interest funds. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded when received. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold or held during the year.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Notes Receivable from Plan Participants

Notes receivable from Plan participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Income Taxes

The Plan uses a non-standardized pre-approved profit sharing plan with CODA sponsored by Donohue Feiman Retirement Plan Services Inc. Donohue Feiman Retirement Plan Services Inc received an advisory letter from the Internal Revenue Service dated June 30, 2020, stating that the non-standardized pre-approved Plan and related Trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Estimates

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan's assets include various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to the value of such investments, changes in the values of investments will occur and such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Payment of Benefits

Benefits are recorded when paid.

Excess Contributions Payable

Amounts payable for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

3. FINANCIAL CERTIFICATION

The following financial information relating to the Plan's assets at December 31, 2024 and 2023, as well as investment income and investment transactions for the years then ended, has been derived from information provided by Fidelity Management Trust Company, the Trustee of the Plan, and has been certified by them as complete and accurate.

4. FAIR VALUE MEASUREMENT AND DISCLOSURES

The Plan uses various valuation techniques in determining fair value. ASC Section 820 established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

4. FAIR VALUE MEASUREMENT AND DISCLOSURES (Continued)

Mutual funds and common stock – These investments consist of various publicly traded mutual funds and common stock and are valued at the daily closing price as reported by the fund. Mutual funds are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The investments held by the Plan are deemed to be actively traded.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: Values are determined based on quoted market prices in active markets.

Common stocks: Valued at quoted market prices.

Common collective trusts: Valued at the net asset value (NAV) of units of the collective trust, using independent pricing services approved by the trustee. The net asset value is based on the fair value of the underlying investments held by the fund. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. There are no unfunded commitments or redemption restrictions.

5. GUARANTEED INTEREST FUND

The Plan allows participants to direct their contributions into an investment contract with Prudential Retirement Insurance and Annuity Company. Prudential maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The Guaranteed Interest Fund is a general account product. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest crediting rate is reset quarterly. The contract is included in the financial statement at contract value as reported to the Plan by Prudential. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

As described in Note 2, because the investment contract is fully benefit-responsible, contract value is the relevant measurement attribute for that portion of net assets available for benefits attributable to the fully benefit-responsible investment contract.

Certain events limit the Plan's ability to transact at contract value. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring. The investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

6. INCOME TAX STATUS

The Company had adopted a prototype plan document. On June 30, 2020, the IRS advised the prototype plan sponsor that the form of the prototype plan, as then designed, was acceptable under Section 401 of the IRC and therefore exempt from federal income taxes under the provisions of Section 501(a) of the IRC. The Plan has been amended; however, the Company believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC, thus no provision for income taxes has been provided for in the accompanying financial statements.

On July 27, 2022, the Company adopted the amended and restated prototype plan document (see Note 1 - General).

U.S. generally accepted accounting principles requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. ADMINISTRATIVE EXPENSES

All expenses lawfully payable from the assets of the Plan may be paid from such assets. Such expenses include recordkeeping, trustee, and administrative fees. Investment management fees are also payable out of the Plan's assets along with brokerage fees, transfer taxes, and other incidental security transaction fees. During 2024 and 2023, the Plan paid for investment management, investment review, recordkeeping, and trustee expenses. During 2024 and 2023, Plan expenses were offset by \$600,532 and \$625,573 respectively, from forfeited nonvested accounts. During the years ended December 31, 2024, and 2023, revenue sharing, which mutual fund companies would normally pay to an investment broker, were rebated to the Plan to defray administrative costs totaled \$4,068 and \$738,837, respectively. All non-trustee expenses related to the Plan are paid out of the participants' accounts unless paid by the Company. In addition, certain investment related expenses reduced investment income presented in the accompanying statements of changes in net assets available for benefits. All other expenses are paid by the Company and are excluded from these financial statements.

8. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Plan assets include investments in funds managed by Fidelity Management Trust Company. As such, these transactions qualify as party-in-interest transactions.

The Plan's investments also include common stock of the Company which qualifies both as related parties and parties-in-interest. At December 31, 2024, the Plan held 2,491,005 shares of EchoStar Class A common stock valued at \$57,048,162. At December 31, 2023, the Plan held 4,379,995 shares of DISH Class A common stock with a fair value of \$25,275,540 and 244,265 shares of EchoStar Class A common stock with a fair value of \$4,048,517. During the years ended December 31, 2024 and 2023, purchase of shares by the Plan totaled \$0 and \$15,045,161, respectively, and sales of shares by the Plan totaled \$5,134,563 and \$5,494,215, respectively.

Notes receivable from participants of \$21,223,836 and \$18,588,821 as of December 31, 2024 and 2023, respectively, with interest rates ranging from 3.25% to 9.50% qualify as party-in-interest.

8. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS (Continued)

Personnel and facilities of the Company have been used to perform administrative functions for the Plan at no charge to the Plan.

9. CONCENTRATIONS, RISKS, AND UNCERTAINTIES

The Plan has significant concentration of DISH Class A common stock. A change in the value of the DISH Class A common stock can cause the value of the Plan's net assets to change significantly due to this concentration.

As of December 31, 2024 and 2023, there was one investment that individually represented over 10% of investments held.

The Plan provides for various investments in corporate common stock and mutual funds. Investments, in general, are exposed to various risks, such as significant world events, interest rate, credit, and overall market volatility risk. The Plan allows for participants to invest in mutual funds, which may in turn invest in securities with contractual cash flows, such as asset-backed securities, collateralized mortgage obligations, and commercial mortgage-backed securities, including securities backed by subprime mortgage loans. The value, liquidity, and related income of those securities are sensitive to changes in economic conditions, including real estate value, delinquencies or defaults, or both, and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

10. RECONCILIATION TO FORM 5500

Certain items have been classified differently between the financial statements and Form 5500. Net assets available for benefits and changes in net assets available for benefits per the financial statements have been agreed to Form 5500 in total as of and for the years ended December 31, 2024 and 2023.

11. SUBSEQUENT EVENTS

The plan administrator has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued and determined there were no material subsequent events that required recognition or additional disclosure in these financial statements.
