Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Hattori Hanzo Shears, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Hattori Hanzo Shears, Inc. 401(k) Profit Sharing Plan Notes to Financial Statements

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Hattori Hanzo Shears, Inc. 401(k) Profit Sharing Plan, (the Plan) provides only general information. Participants should refer to the Plan agreement, as amended, for a more complete description of the Plan's provisions.

General – The Plan is a 401(k) salary deferral and profit sharing plan covering substantially all employees of Hattori Hanzo Shears, Inc., and is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Hattori Hanzo Shears, Inc. (the Company), is the Plan's sponsor and serves as Plan administrator.

Eligibility – Employees of the Company are eligible to participate in the Plan upon completing at least one hour of service in the first three months of employment or one year of service, if earlier, defined as 1,000 hours during the plan year.

Contributions

Participant contributions – Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants may also elect to make Roth contributions utilizing after-tax contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

Employer safe harbor matching contribution – The Company elects to make safe harbor matching contributions up to 4% of the participant's eligible compensation contributed to the Plan, regardless of the employee's hours of service or employment on the last day of the plan year.

Employer matching and profit sharing contributions – The Company may also elect to make discretionary matching and profit sharing contributions to the Plan, which are allocated to participants in the same proportion as a participant's compensation bears to the total of all participants' compensation. Participants must complete at least 1,000 hours of service during the plan year and be employed as of the last day of the plan year to be eligible to receive any employer paid discretionary matching and profit sharing contributions. There were no such contributions for the year ended December 31, 2024.

Contributions are subject to regulatory limitations.

Participant accounts – Each participant's account is credited with the participant's contributions and employer safe harbor matching contributions, as well as allocations of the Company's discretionary contributions, if any, and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account into various investment options offered by the Plan.

Hattori Hanzo Shears, Inc. 401(k) Profit Sharing Plan Notes to Financial Statements

Vesting – Participants are vested immediately in their contributions plus actual earnings thereon. Furthermore, participants are immediately vested in any employer safe harbor matching contribution made on their behalf. Vesting in the Company's discretionary contribution portion of their accounts is based on years of continuous service. Participants vest in the Company's discretionary contributions based on the following schedule:

Notes receivable from participants – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balance in the participant's account. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case, the loan must be repaid within a reasonable period of time not to exceed ten years. Under the terms of the Plan agreement, interest on the loan will be based on the prime rate plus 1%. Principal and interest is paid ratably through monthly payroll deductions. As of December 31, 2024, the rates of interest on outstanding loans are in the range from 4.25% to 9.50%, with various maturities through June 2034.

Payment of benefits – On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over period of not more than the participant's or beneficiary's assumed life expectancy. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeitures – Forfeitures are the nonvested portion of a participant's account that is lost upon termination of employment. Forfeitures are retained in the Plan and may be used to pay administrative expense or to reduce employer contributions, at the discretion of the Plan administrator. The Plan has unallocated funds at \$25,074 at December 31, 2024 and 2023.

Plan termination – Although it has not expressed any intent to do so, the Company has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. If the Plan is terminated, amounts allocated to a participant's account become fully vested.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America, using the accrual method of accounting.

Use of estimates – The preparation of financial statements in conformity with generally accepted accounting principles requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment valuation – The investments are reported at fair value. John Hancock Life Insurance Company (U.S.A.) (John Hancock) certifies the fair market value of investments held by them as of December 31, 2024 and 2023. U.S. Bank National Association (U.S. Bank N.A.) certifies the fair market value of investments held by them in self-directed brokerage accounts as of December 31, 2023.

If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. The net appreciation or depreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Notes receivable from participants – Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan agreement.

Payment of benefits – Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Several of the investment options are subject to investment and administrative fees based on a percentage of invested assets, as disclosed in the investment's prospectus. All such fees are charged directly against the investment performance; thus, they are not separately disclosed in the accompanying financial statements.

Administrative expenses paid by the Plan may include notes receivable and distribution fees charged to participants' accounts and administrative fees. Such fees are separately disclosed in the financial statements, net of any revenue sharing credits earned and received by the Plan (see Note 6).

Subsequent events – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through October 6, 2025, which is the date the financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Self-directed brokerage accounts – Accounts primarily consist of domestic and foreign common stocks, which are valued on the basis of readily determinable market prices, and interest-bearing cash deposit accounts.

Pooled separate accounts – Units held in sub-accounts of the John Hancock Separate Account B are valued using the net asset value practical expedient (NAV practical expedient) of the sub-account as reported by the account managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the sub-account, minus its liabilities, and then divided by the number of units outstanding. There are no unfunded commitments, redemption frequency restrictions, redemption notice periods, or any redemption restrictions, except restrictions that may be imposed to minimize short-term trading activity.

The Plan currently invests in the following sub-accounts of the John Hancock Separate Account B (other insignificant sub-accounts are not disclosed here):

- T Rowe Price Retirement 2065, T Rowe Price Retirement 2060, T Rowe Price Retirement 2055, T Rowe Price Retirement 2050, T Rowe Price Retirement 2045, T Rowe Price Retirement 2040, T Rowe Price Retirement 2035, and T Rowe Price Retirement 2030 (target date funds) seek high total return over time consistent with an emphasis on both capital and growth income.
- 500 Index Fund seeks to approximate the aggregate total return of a broad-based U.S. domestic equity market index.
- Money Market Fund seeks to achieve maximum current income consistent with preservation of principal and liquidity.
- High Yield Fund seeks current income with capital appreciation as a secondary goal by investing in U.S. and foreign high yield bonds rated BB/Ba or lower and their unrated equivalents.
- Vanguard High Dividend Yield Index seeks the performance of the FTSE High Dividend Yield Index which consists of common stocks of companies that pay higher than average dividends by replicating the index by investing its assets the stocks that make up the index at the same proportion as its weighting in the index.
- DFA International Value seeks long-term capital appreciation.
- Real Estate Securities Fund seeks to achieve a combination of long-term capital appreciation and current income.
- American Funds New Perspective seeks to take advantage of evolving global trade patterns by predominantly investing in multinational companies that have strong growth prospects.
- Fidelity Contra Fund seeks capital appreciation by investing in securities of companies whose value Fidelity Management & Research Company (FMR) believes is not fully recognized by the public. The Fund invests in either "growth" stocks or "value" stocks or both.
- Vanguard Mid-Cap Growth ETF seeks to track the performance of the CRSP U.S. Mid Cap Growth Index. The Fund invests in all of its assets in stocks that make up the Index, holding each stock in the same proportion as its weighting in the Index.
- Mid Cap Index Fund seeks to approximate the aggregate total return of a mid cap U.S. domestic equity market index.

- Vanguard Growth Index Fund seeks to track the performance of the CRSP US Large Cap Growth Index, a broadly diversified index of growth stocks of predominantly large U.S. companies. The Fund invests all or substantially all of its assets in the stocks that make up the index.

The valuation methodologies used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 – TAX STATUS

The Plan document is a pre-approved non-standardized defined contribution plan that received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020, which stated that the plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Plan has a recordkeeping agreement with John Hancock Life Insurance Company (U.S.A), the recordkeeper, which requires the recordkeeper to share revenue it receives from certain fund companies attributable to the Plan's investments based on a specified formula. During 2024, the Plan received \$3,998 under such agreement, which was recorded as a reduction to the Plan's administrative expenses in the accompanying statement of changes in net assets available for benefits.

NOTE 7 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statement of net assets available for benefits.
