### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of General Assembly 401(k) Plan (the "Plan"), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 Code of Federal Regulations (CFR) 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

**Note 1. Description of the Plan**

The following description of the Plan is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions. The Plan was adopted by General Assembly Space, Inc. (Company).

**General**

The Plan is a defined contribution plan which became effective May 1, 2012, and was amended and restated on February 18, 2022. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). The Plan generally covers all employees of the Company with the exception of leased employees and nonresident aliens, and there is no service or age requirement. Participation in the Plan is effective on the first day of the calendar month following the date of hire.

**Contributions**

Each year, participants may elect to contribute up to 100% of their pretax annual compensation, as defined, to their tax deferred account or Roth after-tax account, not to exceed amounts prescribed by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to amounts prescribed by the IRS. Participants may also contribute amounts representing distributions from other qualified defined contribution or defined benefit plans. Participants direct the investment of their contributions and the Company’s discretionary contributions into various investment options offered by the Plan.

The Company may elect to make discretionary matching contributions equal to a uniform percentage to be determined by the Company. The Company’s discretionary matching contribution is made for all eligible participants on a pay period basis. The Company may also elect to make a discretionary contribution based on employee compensation. In order to be eligible for the discretionary contribution, participants must have been employed on the last day of the Plan year except in the case of death, disability, and retirement, as defined in the Plan document. For the year ended December 31, 2024, the Company elected not to make matching or discretionary contributions.

**Participant Accounts**

Each participant’s account is credited with the participant’s contributions, the Company’s discretionary matching contribution and discretionary profit-sharing contribution, as well as an allocation of plan earnings. Participant accounts are charged with an allocation of administrative expenses, if applicable. Allocation of the Company’s discretionary contributions is based on participant compensation, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in Company contributions and earnings thereon will be vested as follows:

***Forfeitures***

There were no balances in forfeited non-vested accounts as of December 31, 2024 and 2023.

***Benefits***

Participants are immediately vested in their contributions plus actual earnings thereon. Participants become fully vested in their Company contributions in accordance with the vesting schedule provided in the adoption agreement, upon attainment of age 65 (normal retirement age) or termination of service due to death and disability. On termination of service due to any other reason, a participant receives an amount equal to the value of the participant's vested interest in his or her account. Participants attaining the age of 59½ may request a withdrawal of all or part of the vested portion of their accounts. Hardship withdrawals are permitted as described in the Plan document. Distribution payments may be made as lump-sum or annuity payments.

***Notes Receivable From Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at an annual rate from 5.25% to 10.50%. Repayment of a loan may be made through payroll deductions or by check (in the event of prepayment), within a maximum term of five years. If the loan is used to purchase a primary residence, a longer repayment term is permitted.

***Administrative Expenses and Other Income***

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the respective participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States (GAAP).

***Use of Estimates***

The preparation of financial statements in accordance with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

***Investment Valuation and Income Recognition***

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year, and interest and dividend income.

***Payment of Benefits***

Benefits are recorded when paid.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions, based on the terms of the Plan document. For the year ended December 31, 2024, notes bear interest between a rate of 5.25% and 10.50%.

**Note 3. Certification of Plan Trustee**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedules is complete and accurate:

- Investments and notes receivables from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA required supplemental schedules.

**Note 4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2** Inputs to the valuation methodology include: (a) quoted market prices of investments for similar assets or liabilities in active markets; (b) quoted prices for the identified or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies of these items held at December 31, 2024 and 2023:

**Mutual Funds** – Mutual funds are valued at the daily closing price, as reported by the fund. The mutual funds held by the Plan are actively traded.

Common Collective Trusts – The common collective trusts (CCTs) are stated at fair value using the net asset value (NAV) practical expedient. The NAV of the CCTs is determined using the market price of the underlying securities and the contract value of investment contracts held by the CCTs, as determined by the trustee of the CCTs. There are no restrictions on the redemption of these investments and no unfunded commitments.

Self-Directed Brokerage Account – The plan allows for the participants to invest in mutual funds, exchange-traded funds (ETFs), individual equities, and fixed income investments. These investments are valued at unadjusted quoted market prices.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **Note 5. Related-Party and Party-in-Interest Transactions**

Certain Plan investments are managed by Principal and Principal Global. Principal and Principal Global are the custodians as defined by the Plan, and, therefore, transactions in such investments qualify as party-in-interest transactions. Fees totaling \$ 60,534 were paid directly to the custodians from the Plan during the Plan year. Other fees and expenses such as investment fees and Plan administration fees may be deducted directly from investment returns in accordance with the applicable investment option selected by the participant.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

### **Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

### **Note 7. Tax Status**

The Plan is based on a prototype plan of Principal Financial Group, the record keeper of the Plan, which received a determination letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the prototype plan was designed in accordance with the provisions of the Internal Revenue Code (IRC). The IRS determination letter precludes the necessity for the Plan to file for an individual letter of determination with the IRS. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor or IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Management believes it is no longer subject to income tax examinations for years prior to 2021.

### **Note 8. Risks and Uncertainties**

The Plan invests in various investment options that are exposed to various risks such as interest rate, market, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 9. ERISA Fidelity Bond**

ERISA Section 412 requires all persons who handle funds or other property of an employee benefit plan to be bonded. This requirement protects plans against losses sustained due to acts of fraud or dishonesty by those persons whose positions require them to come in direct contact with or exercise discretion over plan assets. From June 1, 2024 to December 31, 2024, the Plan Sponsor did not have a fidelity bond in place, which constitutes a reportable noncompliance. Effective January 1, 2025, the Plan has been included under The Adecco Group's fiduciary bond coverage.

**Note 10. Delinquent Participant Contributions**

During 2024, the Company did not remit to the Plan's Trustee certain participant contributions totaling \$5,853 within the period prescribed by the Department of Labor's rules and regulations. Delays in remitting the contributions to the custodian were due to administrative errors. The Company has made a contribution to the Plan to compensate for lost earnings resulting from the late payment and filed the required forms with the Department of Labor.

Subsequent events have been evaluated through October 1, 2025, which is the date the financial statements were available to be issued.
