## Independent Auditors' Report

### The Plan Administrator and Participants of 403(b) Thrift Plan for Employees of New York Road Runners, Inc.

#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the 403(b) Thrift Plan for Employees of New York Road Runners, Inc. **1. Description of Plan**

Effective December 1, 1983, New York Road Runners, Inc. (the “Employer”) adopted the 403(b) Thrift Plan for Employees of New York Road Runners, Inc. The following brief description of the Plan and summary of major Plan provisions provides only general information about the Plan. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

In 2025, the Plan transferred its assets from Mutual of America Life Insurance Company to Empower Trust Company, LLC and Empower Annuity Life Insurance Company of New York (collectively “Empower”).

***General and Eligibility***

The Plan is a defined contribution plan established by the Employer and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan excludes non-resident aliens and any employee under the age of 21. The Employer is the sponsor of the Plan and the insurance company is Mutual of America Life Insurance Company (“MOA”). The insurance company manages the investments of the Plan. Employees are eligible to participate in the Plan on their date of hire.

***Contributions***

Each participant may elect to have a percentage of their eligible compensation, as defined by the Plan document, deducted on a pre-tax or Roth basis. A participant may elect to increase, decrease or suspend their contributions according to procedures established by the Employer. There is an annual dollar limit as to the amount that can be contributed on a pre-tax basis into the Plan which is determined by the Internal Revenue Service (“IRS”). Participants who have attained age 50 before the Plan year end are eligible to make catch-up contributions up to the statutorily permitted amounts. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Effective November 1, 2019, the Employer amended the Plan to provide for an Employer discretionary non-elective contribution which is allocated to each participant based on their eligible compensation (as defined in the Plan document) not to exceed the Internal Revenue Code (“IRC”) annual limit. Effective January 1, 2024, participants must be full-time employees or part-time employees who work 20 or more hours per week throughout the year, attain age 21 and be employed on the last day of the Plan year to be eligible to receive an Employer non-elective contribution. Contributions are subject to certain limitations as specified in the Plan document. During 2024, the Employer elected to contribute a discretionary non-elective contribution to the Plan of 6% based on 2023 salaries.

***Participant Accounts***

Each participant’s account is credited with contributions and the investment earnings thereon. The contributions are allocated among the investment options according to the participant’s instructions. Allocations are based on participant earnings, account balances, or specific participant transactions. Participant accounts are charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

***Vesting***

Each participant is fully vested in his or her own contributions and earnings at all times. A participant is fully vested in Employer contributions after completing three years of vesting service with no partial vesting. A participant is also fully vested upon attainment of age 65, upon death or if they become totally and permanently disabled.

***Forfeitures***

In the event that a participant terminates before becoming fully vested in his or her account balance, the non-vested portion of the participant's account balance will be forfeited as of the termination date. Any forfeiture not restored may be used by the Plan first to pay certain Plan expenses and any amount remaining will be used to reduce future Employer contributions. If a participant is reemployed before incurring five consecutive one year breaks-in-service, the forfeited portion of his accounts, determined as of the date the accounts were distributed shall be restored from the forfeitures.

At December 31, 2024 and 2023, forfeited account balances held in nonparticipant directed accounts were \$47,632 and \$21,970, respectively. No amounts were used to pay Plan expenses and \$11,450 was used to reduce Employer contributions during 2024.

***Loans to a Participant/Collateralized Assets***

A participant may elect to take out a loan subject to the rules and limitations of the Plan and the terms of the applicable contract. Loans are based on the vested value of the participant's individual account. Defaults in loans shall be treated as distributions at the time of default.

The Plan offers a loan feature whereby a participant ("borrower") enrolled in the Plan may borrow a minimum of \$1,000 up to a maximum of 50% of his/her vested balance or \$50,000 (whichever is less). Loans to the participant are made directly from MOA. The participant's account is not reduced by the loan amount, but serves as security for the loan. The loan must be repaid directly to MOA within a five year period in substantially equal payments (not less frequently than quarterly). The five year repayment period does not apply to a loan that is used to acquire a principal residence of the borrower in which case the loan is repayable over a period not to exceed ten years.

If the borrower does not repay the loan and related interest due in accordance with the schedule set forth in the promissory note or other writing permitted by applicable law representing the loan, their loan will be deemed in default.

At December 31, 2024 and 2023, there were 14 and 11 loans outstanding, respectively, with total principal balance due of \$205,792 and \$194,650, respectively. No loan balances were in default as of December 31, 2024 and 2023. Interest rates on these loans are between 4.60% and 5.85% with maturities through 2032.

***Payment of Benefits***

Upon termination of service due to death, disability, retirement, age 59 1/2 or other reasons, a participant is entitled to receive a distribution in the amount equal to the total value of the participant's vested account balance.

Hardship withdrawals are allowed, but cannot exceed the amount of the immediate need, including amounts necessary to pay any federal, state or local income taxes or penalties reasonably anticipated to result from the withdrawal.

**2. Summary of Significant Accounting Policies**

***Basis of Presentation***

The accounts of the Plan are maintained, and the accompanying financial statements have been prepared, on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America ("U.S. GAAP"). Under this basis, contributions and investment income are recognized when received and expenses are recognized when paid, except for investments and the related gains or losses which are measured at fair value. Management has determined that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances.

***Use of Estimates***

Management makes estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on Fair Value Measurements which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

**2. Summary of Significant Accounting Policies (*continued*)**

***Investment Valuation and Income Recognition***

All of the Plan's investment are stated at fair value. Separate accounts are reported at fair value as reported to the Plan by the insurance company, which represents the fair value of the underlying investments comprising the accounts. The investment in the insurance company general account is reported at fair value, which is based on the contract value as reported by the insurance company. Contract value represents contributions made under the contract, plus interest credited, less benefits paid and expenses. Because the investment is not actively traded and relies on valuation inputs provided by the insurance company, it is considered an estimate of fair value. Interest income is recorded when received. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Payment of Benefits***

Benefits are recorded when paid.

***Administrative Expenses***

Certain expenses of maintaining the Plan are paid by the Employer and are excluded from these financial statements. Administrative expenses paid by the Plan include contract fees. Investment related expenses are included in net appreciation in fair value of investments.

***Reclassifications***

Certain amounts in the 2023 financial statements have been reclassified to conform to the 2024 presentation. Such reclassifications had no impact on the Plan's net assets or changes in net assets.

***Subsequent Events Evaluation***

The Plan administrator has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 7, 2025.

**3. Information Certified (Unaudited)**

Certain information related to investments in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Mutual of America Life Insurance Company, a qualified institution.

***Insurance Company General Account***

Amounts placed in the Mutual of America Interest Accumulation Account are credited with interest at a rate determined by Mutual of America Life Insurance Company. Mutual of America Life Insurance Company guarantees to credit interest for the life of the contract to amounts in the Interest Accumulation Account of their general account at a rate of at least equal to the greater of: (1) any contractual minimum guarantee provided by the contract; or (2) the minimum rate required by applicable state law or, if no state law minimum rate is applicable to a contract, the minimum guaranteed credited interest rate will be set pursuant to National Association of Insurance Commissioners (“NAIC”) standard non-forfeiture law. The NAIC minimum rate is determined in accordance with a formula, and cannot be less than 1.00% or more than 3.00% in any event. Mutual of America Life Insurance Company determines whether the application of the formula will change the minimum guaranteed rate each November, and any change is effective the following January 1 for that calendar year.

The Mutual of America Interest Accumulation Account is not a fully benefit-responsive investment contract and may be subject to withdrawal or transfer restrictions under certain plan or contract provisions.

The interest rate under that contract will not go below that amount regardless of the minimum rate that is set for a calendar year. In Mutual of America Life Insurance Company’s sole discretion, they may credit a higher rate of interest to a participant’s contract in the general account, although they are not obligated to credit interest in excess of the minimum guaranteed rate. Mutual of America Life Insurance Company compounds interest daily on the contract amounts in the general account to produce an effective annual yield that is equal to the stated interest rate.

The Mutual of America Interest Accumulation Account represents 13% and 14% of the Plan’s net assets available for benefits at December 31, 2024 and 2023.

***Separate Accounts***

The Plan offers various separate accounts as investment options under the Plan. The separate accounts have different investment objectives, investment policies, and risks. The name of each separate account corresponds to the name of the underlying fund in which it invests. When contributions or transfers are made to a separate account, the separate account purchases shares in the appropriate underlying fund. The Plan’s separate accounts include various asset classes which are: equity funds, fixed income funds, growth funds, money market funds, balanced funds, bond funds, asset allocation funds, and retirement funds.

**5. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participant accounts will become 100% vested in any unvested Employer contributions allocated to their accounts.

**6. Tax Status**

The Employer has adopted an IRS approved volume submitter plan that received an IRS opinion letter dated March 31, 2017. The Plan administrator believes that the Plan, as amended, is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

**7. Party-in-Interest**

All investments of the Plan are managed by MOA, the custodian and record-keeper of the Plan. Therefore, these transactions qualified as exempt party-in-interest transactions under ERISA.

Certain employees of the Employer perform administrative services related to the Plan; the Employer pays the salaries of these individuals, and no costs are charged to the Plan.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.
