NOTE 1 - DESCRIPTION OF PLAN

The following brief description of the Retirement Plan for Employees of Fermi Research Alliance, LLC (the Plan) is provided for general informational purposes only. Participants should refer to the Plan's description in the plan document, as amended, for more complete information of the Plan's provisions.

General: The Plan is a defined contribution money purchase plan established on March 1, 1989 under Section 401(a) of the Internal Revenue Code (IRC) to cover eligible employees Fermi Research Alliance, LLC (Alliance), the prime contractor for Fermi National Accelerator Laboratory (Fermilab).

Effective January 1, 2025, management and operation of Fermilab was assumed by Fermi Forward Discovery Group, LLC (FFDG) as the Employer and, accordingly, Plan sponsorship was transferred to FFDG. The Plan was further amended effective January 1, 2025, to rename the Plan to Retirement Plan for Employees of Fermi Forward Discovery Group, LLC.

Plan Administration: The Plan is administered by the Retirement Plans Committee (Plan Administrator). Assets of the Plan are held by Fidelity Management Trust Company (Fidelity) and Teachers Insurance and Annuity Association (TIAA) and College Retirement Equities Fund (CREF) (collectively, TIAA-CREF). Fidelity and TIAA-CREF are the Custodians and Recordkeepers.

On February 2, 2015, Fidelity became the Custodian and Recordkeeper for all future contributions to the Plan. The participants had the option to either retain their TIAA and CREF accounts at TIAA-CREF or transfer them to an investment at Fidelity. For the amounts not transferred to Fidelity, TIAA-CREF is the Custodian and Recordkeeper for those Plan assets.

Participants and Contributions: To be eligible as a participant in the Plan, an employee must be 21 years of age and have completed two years of service (one year of service is defined as 1,000 hours worked within a 12-month period). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Alliance makes weekly or monthly contributions to the Plan in an aggregate amount equal to 10% of the base compensation of all participants for such plan year. The Alliance's contributions are intended not to exceed the maximum deduction allowable under the provisions of the IRC. Participants are not subject to federal income tax on any Alliance contributions or on any earnings or growth credited to their account until such time as the funds are distributed from their accounts. Employee contributions are prohibited under the Plan.

Participant Accounts: A separate account is maintained for each participant to account for the participant's share of contributions plus income and gains or losses from investment of such contributions. Participants may invest their allocation of Alliance contributions in various funds sponsored by Fidelity Investments or into a self-directed brokerage account through Fidelity, in any proportion resulting in a whole percentage.

Vesting: A participant's portion of contributions, plus income and gains or losses from investment of such contributions, is fully vested and non-forfeitable at all times.

NOTE 1 - DESCRIPTION OF PLAN (Continued)

Payment of Benefits: Participants may receive all or a portion of their vested Fidelity account balance upon reaching 59½ years of age or termination of employment. Participants who terminate employment prior to retirement may elect to leave their accumulations in the funding vehicles or have their balance distributed in a lump sum or transferred to an individual retirement account or another employer's qualified plan. Generally, participants must begin taking minimum distributions upon April 1 following, the later of, reaching 73 years of age or retirement. Death benefits are paid according to the benefits election in effect at the time of death.

Upon normal retirement, death, disability, or termination, participants, former participants, or beneficiaries may elect to receive either lump-sum amounts equal to the present value of their TIAA-CREF account balance or in monthly, quarterly, semiannual, or annual installments. Lump-sum amounts are not available to participants upon disability or termination if the annuity contract exceeds \$4,000.

Plan Termination: Although the Alliance, prior to January 1, 2025, nor FFDG after December 31, 2024, has not expressed any intent to terminate the Plan, it is free to do so at any time, subject to the provisions of ERISA. In the event of termination, the plan agreement requires that the net assets of the Plan be distributed to the participants according to their individual account balances.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The accompanying financial statements have been prepared on the accrual basis of accounting.

Contributions: Contributions from the Alliance are accrued in the period in which they become obligations of the Alliance.

Investment Valuation and Income Recognition: The Plan's investments, other than fully benefit responsive contracts, are reported at fair value, as further described in Note 6.

The unit values of the Plan's holdings in fully benefit-responsive New York Life Guaranteed Interest Accounts are reported at contract value, which equals the accumulated cash contributions and interest credited to the Plan's contracts, less any withdrawals. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contracts because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions, as further described in Note 3.

Net realized and unrealized appreciation or depreciation in fair value of investments represents the Plan's gains and losses on investments bought and sold as well as held during the year, net of certain expenses. Purchases and sales of investment securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis as earned. Dividend income is recorded on the ex-dividend date.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties: The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market, liquidity, credit risks, and risks related global events. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and changes in net assets available for benefits.

Payment of Benefits: Benefits are recorded when paid.

Administrative Expenses: Service fees necessary for the operation of the Custodians and Recordkeepers, including the rendering of investment advice, the administration of funds, and the distribution of annuity certificates, are deducted quarterly from the net assets of the funds, thereby reducing the value of a participant's account. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan. The Plan Sponsor provides the Plan with certain other administrative services without charge and pays various other miscellaneous expenses on behalf of the Plan. In 2024 and 2023, the Plan incurred and paid administrative expenses related to professional services.

Subsequent Events: The Plan has evaluated subsequent events through September 30, 2025, the date the financial statements were available to be issued.

NOTE 3 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

The plan holds fully benefit-responsive investment contracts. These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value.

Participants in fully benefit-responsive contracts may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan holds a direct interest in fully benefit-responsive contracts through the New York Life Guaranteed Interest Account ("GIA"). The Plan held \$6,728,579 and \$8,588,978 in fully benefit-responsive investment contracts as of December 31, 2024 and 2023, respectively, through its investment holdings in the GIA.

The traditional investment contracts held by the Plan are guaranteed investment contracts. New York Life Insurance Company ("NYLIC") is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the issuer. The crediting rate is reviewed periodically for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on NYLIC's ability to meet its financial obligations. NYLIC's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with NYLIC. These events may be different under each contract. Examples of such events include the following:

- The Plan's failure to qualify under Section 401(a) of the IRC or the failure of the Plan to be tax-exempt under section 501(a) of the IRC
- Premature termination of the contracts
- Plan termination or merger
- Changes to the Plan's prohibition on competing investment options
- Bankruptcy of the plan sponsor or other plan sponsor events that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with NYLIC and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow NYLIC to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

- An uncured violation of the Plan's investment guidelines
- A breach of a material obligation under the contract
- A material misrepresentation
- A material amendment to the agreements without the consent of the issuer

NOTE 4 - NEW YORK LIFE GUARANTEED INTEREST ACCOUNT

The GIA is a group annuity contract available as an investment option to plan participants. The GIA consists of a broadly diversified fixed income portfolio within NYLIC's general account and is intended to provide a stable crediting rate consistent with preservation of principal. Interest is accrued daily and credited monthly to the GIA and reflects the crediting rate declared in advance and guaranteed by NYLIC.

The key factors that impact the crediting rate under the group annuity contract are the timing and magnitude of the cash flows in and out of the general account as well as prevailing market rates on fixed income assets available for investment by the general account. The interest crediting rate may not be reset more frequently than semi-annually after the first contract year. The crediting rate is subject to a minimum rate provision as provided in the group annuity contract but may never fall below 1% after deduction for any expenses.

The group annuity contract provides that, subject to certain limitations, withdrawals for benefit payments at death, retirement, disability, termination of employment, and for loans, hardship withdrawals or in-service withdrawals as permitted by the Plan are completed at contract value. Certain distributions, including but not limited to distributions resulting from employer-initiated events such as Plan termination, merger, spin-off, and early retirement incentives may be completed subject to a market value adjustment, however the Plan Administrator deems these employer-initiated events are not probable to occur.

The group annuity contract may be terminated by the contract holder at any time, provided written notice of termination is received by NYLIC at least 30 days but not more than 60 days prior to the intended termination date. At contract termination, the participant may elect to receive either an immediate lump sum distribution subject to a market value adjustment or receive a contract value distribution in 6 annual installments over a period of 5 years.

NOTE 5 - TIAA TRADITIONAL ACCOUNT

The TIAA Traditional Account is a guaranteed fixed annuity contract available as an investment option to plan participants. Each contract is fully and unconditionally guaranteed by TIAA. The TIAA Traditional Individual Fixed Annuity Contracts are offered through a variety of contract types, including Retirement Annuities (RA) and Group Retirement Annuities (GRA). The type of contract through which a participant invests in the TIAA Traditional Account determines the applicability of certain account features, such as the guaranteed minimum interest rate, additional interest declarations, the degree of liquidity of the participant's account, and the options for receiving income upon retirement.

The RA contract does not allow lump-sum cash withdrawals. With the GRA contract, lump-sum cash withdrawals are available within 120 days of termination of employment and are subject to a 2.50% surrender charge. All other withdrawals and transfers from RA and GRA contracts must be spread over 10 annual installments (five annual installments for withdrawals after termination of employment). As a result of these restrictions over withdrawals, holdings in these contracts are not considered fully benefit-responsive. When a participant's accumulation in the TIAA Traditional Annuity is converted to a lifetime payout annuity, the present value of the stream of payments is equal to the accumulated balance, and the entire amount is recorded as a distribution in the statements of changes in assets available for benefits.

All investment contracts through the TIAA Traditional Account are directly between TIAA and the participants. The contracts do not provide any provisions that would allow TIAA to terminate the contracts between TIAA and the participants.

When participants choose to allocate a portion of their retirement savings to the TIAA Traditional Account during the accumulation phase of the contract, their contributions purchase a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. The participant's principal, plus a specified minimum rate of interest, is guaranteed by TIAA's claims-paying ability and maintained by TIAA in its general account. Based upon recent credit ratings for TIAA, management believes no adjustment to contract value is required related to credit quality.

The TIAA Traditional Annuity also provides the potential for additional interest if declared by TIAA's Board of Trustees. Additional interest, when declared, remains in effect for the declaration year, which begins each March 1 for accumulating annuities, and January 1 for lifetime payout annuities. Additional interest is not guaranteed for future years. Together, the guaranteed minimum and additional amounts make up the crediting interest rate. The crediting rates are based on an agreed-upon formula with the issuer, as defined in the contract agreement. The guaranteed annual interest rate is 3.00% for all premiums remitted since 1979 under the RA and GRA contracts. Such interest rates are reviewed on a periodic basis and may from time to time have a new rate substituted for the one in the current certificate.

NOTE 6 - FAIR VALUE MEASUREMENTS

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (and exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Accounting Standards Codification (ASC) 820, Fair Value Measurements, provides a framework for measuring fair value, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the assets or liabilities
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: The fair values of mutual funds are based on the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price (Level 1).

Self-directed brokerage account: The self-directed brokerage account consist primarily of mutual funds that are valued on the basis of readily determinable market prices (Level 1).

Variable annuities and pooled separate account: The fair values of the Plan's interest in the CREF variable annuities and the TIAA Real Estate Account (a variable annuity pooled separate account) are determined by obtaining quoted prices on the NASDAQ Stock Market (Level 1).

TIAA Traditional Annuity: Investments in non-fully benefit-responsive TIAA Traditional Annuity contracts are reported at contract value, which has been determined to be the most reasonable estimate of fair value. As these investments are contract-based, observable prices for identical or similar investments do not exist and, accordingly, these investments are valued using unobservable inputs (Level 3). The contract value equals the accumulated cash contributions and interest credited to the contract, less any withdrawals. Liquidity restrictions apply to certain types of contracts that could impact the value realized upon exiting the contract. See also Note 5 for discussion of the TIAA Traditional Annuity contracts.

Collective trust funds: The fair values of investments in collective trust funds are valued as determined by the custodian based on their net asset values. Each collective trust funds provides for daily redemption by the Plan at reported net asset values per share, with no advance notice requirement.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values and recent transaction prices. While plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 7 – CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments and interest and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company and TIAA-CREF.

NOTE 8 - PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the plan, any party rendering service to the plan, the employer, and certain others. Plan investments are variable annuity contracts, investment contracts, and mutual funds managed by Fidelity and TIAA-CREF. Fidelity and TIAA-CREF are the Custodians and Recordkeepers for the Plan; therefore, these transactions qualify as party-in-interest transactions. The Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party in interest transactions under ERISA.

NOTE 9 - INCOME TAX STATUS

The Internal Revenue Service has determined and informed the Alliance by a letter dated May 2, 2016 that the Plan is qualified under Section 401(a) of the IRC and is exempt from federal income taxes under Section 501(a) of the IRC. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Alliance has indicated that it will take the necessary steps, if any, to maintain the Plan's qualified status. The Alliance is relying on the above-mentioned determination.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.
