NOTE 1 – DESCRIPTION OF PLAN

The following description of the Oceans Healthcare 401k Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

GENERAL

Oceans Acquisition, Inc. is a member of a controlled group of employers with similar ownership. Members of the controlled group who elected to participate in the Plan are considered “participating employers”. Oceans Acquisition, Inc. and all participating employers are, collectively, hereinafter referred to as the “Company”.

The Plan is a defined contribution plan covering full-time and part-time employees of the Company. The Company adopted a new Plan document effective July 15, 2022. Prior to July 15, 2022, employees of the Company were eligible to participate by making employee deferrals in the Plan on the next entry date after completing 6 months of service and attainment of age 18. Effective July 15, 2022, employees of the Company are eligible to participate by making employee deferrals at age 18 and after completing 3 months of service. Entry dates are the first day of the month coinciding with or following the date requirements are met. Eligible participating employees can receive Company contributions after completing one year of service and attainment of age eighteen. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator and Plan management are responsible for the oversight of the Plan and appropriateness of the Plan’s investment offerings.

CONTRIBUTIONS

Participants may elect to contribute pre-tax and Roth deferrals up to the maximum amount allowed by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have deferral set at 3 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Plan also includes an escalation at the beginning of each plan year of the automatic deferral amount by 1 percent of compensation up to a maximum of 10 percent.

The Company may make contributions equal to a discretionary percentage of the participants’ elective deferrals, to be determined by the Company. Participants must be employed on the last day of the Plan year to receive a Company contribution. For the year ended December 31, 2024, Company matching contributions totaled \$8,282.

The Company may also make a discretionary profit-sharing contribution to be determined by the Company. The profit-sharing contribution, if any, is allocated based on the participant’s compensation. For the year ended December 31, 2024, no discretionary profit-sharing contributions were made.

PARTICIPANT ACCOUNTS

Each participant’s account is credited with the participant’s contribution, the Company employer contributions and Plan earnings. Allocations of plan earnings and administrative expenses are based on participant account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

NOTES RECEIVABLE FROM PARTICIPANTS

Participant loans are not allowed by the Plan.

NOTE 1 – DESCRIPTION OF PLAN – CONTINUED

VESTING

Participants are immediately vested in their contributions and rollover contributions, plus actual earnings thereon. Vesting in Company contributions, plus earnings thereon are based on years of service. Effective January 1, 2019 through July 15, 2022, vesting occurred ratably based on the following schedule:

PAYMENT OF BENEFITS

On termination of service, death or disability, a participant may elect to receive their vested benefit in a lump sum payment, substantially equal installments or partial withdrawals. Further, participants may elect to receive said benefit either in cash or in the form of rollover to another tax-qualified plan. Hardship distributions are permitted only from pre-tax or Roth elective deferrals subject to limitations.

FORFEITURES

Forfeitures may be used to reduce employer contributions or pay administrative fees of the Plan. At December 31, 2024 and 2023, forfeited amounts totaled \$138 and \$139, respectively. During the year ended December 31, 2024, forfeitures totaling \$17,910 were used to pay plan expenses.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING

The financial statements of the Plan are prepared on the accrual basis of accounting.

USE OF ESTIMATES

The preparation of financial statements in conformity with U.S. generally accepted accounting principles (GAAP) requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by investment advisors, custodians and insurance company. See Note 3 for discussion of fair value measurements. See Note 4 for further discussion of the fully benefit-responsive contracts.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – CONTINUED

PAYMENT OF BENEFITS

Benefits are recorded when paid.

PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

OPERATING EXPENSES

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of distributions are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	<p>Inputs to the valuation methodology include:</p> <ul style="list-style-type: none"> • Quoted prices for similar assets or liabilities in active markets; • Quoted prices for identical or similar assets or liabilities in inactive markets; • Inputs other than quoted prices that are observable for the asset or liability; • Inputs that are derived principally from or corroborated by observable market data by correlation or other means. <p>If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.</p>
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level with the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. During 2024, Plan management determined that Common Collective Trusts that had been included as Level 1 investments in the fair value hierarchy previously were investments whose fair value was determined using net asset value as a practical expedient. As a result of this analysis, the 2023 investments have been reclassified to conform with the new fair value measurement.

Mutual funds:

Valued at the daily closing price, as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds registered with the SEC. These funds are required to publish their daily net asset value and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 3 – FAIR VALUE MEASUREMENTS – CONTINUED

Common collective trusts:

Valued at the net asset value (NAV) of units of a bank collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Redemptions normally settle on trade date plus one business day. There is no standard redemption notice period, but significant cash flow policies may apply. Common collective trusts were previously reported at level 1 and have been reclassified to be reported at NAV.

Pooled separate accounts:

The fair value of pooled separate accounts is valued at net asset value (NAV) of shares held by the Plan at year end. Units of pooled separate accounts are valued at NAV daily using publicly available quoted market prices as published by Principal on their website. The NAV serves as a practical expedient to estimate fair value. The redemption frequency and notice periods of each of these pooled separate accounts is daily, and there are no redemption restrictions on unfunded commitments.

NOTE 4 – CONTRACT WITH PRINCIPAL TRUST COMPANY

In 2022, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Principal Trust Company (Principal). Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. The net crediting rate at December 31, 2024 and 2023 was 4.85% and 4.65%, respectively. The crediting rate is reviewed on a semiannual basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options of delegation of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

The Plan’s independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to related information included in the financial statements.

NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer and certain others. As such, Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal), the custodian, is considered a party-in-interest. The Plan holds certain a traditional fully benefit-responsive guaranteed investment contract and pooled separate accounts issued, held or managed by the custodian. Therefore, these investments qualify as party-in-interest transactions. Fees paid to the custodian and other service providers are party-in-interest transactions and are included in administrative expenses or net appreciation of fair value of investments in the statement of changes in net assets available for benefits. All such party-in-interest transactions are covered by an exemption from the "prohibited transactions" provisions of ERISA and the IRC.

NOTE 7 – TAX STATUS

The Plan has adopted a non-standardized pre-approved profit-sharing with the Internal Revenue Code (IRC) Section 401(k) Cash or Deferred Arrangement (CODA) which received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, which states that the form of the plan is acceptable for use by employers for the benefit of their employees. The Plan Administrator and tax counsel believe that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in a variety of investment funds. Investment securities are exposed to various risks, such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 – SUBSEQUENT EVENTS

On December 31, 2024, the Company purchased Haven Behavioral Healthcare Inc. and approved a merger of the Haven Behavioral Healthcare Inc. 401(k) Plan effective May 15, 2015. Assets totaling \$13,941,622 were transferred into the Plan on June 5, 2025.

The plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued, and no additional events have been identified.
