### 1. BASIS OF ACCOUNTING AND SIGNIFICANT ACCOUNTING POLICIES

The financial statements are prepared on the modified cash basis which is a basis of accounting other than accounting principles generally accepted in the United States of America (US GAAP). Under this basis, revenue and related assets are recognized when received rather than when earned and expenses are recognized when paid rather than when incurred, except for investments which are valued at fair value. Management has determined that the modified cash basis of accounting as described above is an acceptable basis for the preparation of the financial statements in the circumstances.

Money market investments are stated at cost plus accrued interest, which equals current value. Investments in pooled and separate equity funds are stated at current value based on quoted market values. Current value is the amount that the Plan can reasonably expect to receive for the investment in a current sale. Purchases and sales of securities are recorded on a trade date basis.

The preparation of financial statements in conformity with the modified cash method of accounting requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from these estimates.

### 2. DESCRIPTION OF THE PLAN

KEH Inc. Profit Sharing Plan and Trust is a defined contribution plan covering all employees of KEH Inc. who have met certain minimum service requirements and are over 21 years of age. The Plan was established in 2010, as amended in 2023, and qualifies under Section 401 of the Internal Revenue Code of 1986. It satisfies the requirements of Section 401(k) and the provisions of the Employee Retirement Income Security Act of 1974. The Plan allows salary reductions (401(k) deductions) up to the limits prescribed by law. The Company will match 100% of the employee contribution, up to a maximum of 3% of an employee's annual compensation. The Company pays significant portions of the plans operating expenses. The participants have a choice of 39 investment programs for their account balances. The funds representing 5% or more of the Plan's net assets at the beginning of the 2024 plan year are as follows:

#### 2. DESCRIPTION OF THE PLAN (Continued)

The Company has the right to discontinue contributions at any time and terminate the Plan. In the event the Plan terminates, the net assets of the Plan shall be used, subject to the payment of expenses and taxes, for the benefit of participants and beneficiaries. Each participant's account shall be fully vested and thereafter non-forfeitable.

Each participant's account is credited with the following:

- (a) Participant's salary reduction contributions
- (b) Company's matching contribution
- (c) Additional contributions by the Company (if any)
- (d) Plan earnings

The Plan provides for withdrawals by Plan participants in the event of death, retirement, disability and other specified circumstances. All employee contributions vest immediately; employer contributions vest at a rate of 33% per year and are fully vested after 3 years of 1000 hour annual service time. Forfeitures may be used to pay plan expenses or as employer contributions.

Participants may borrow from their fund accounts up to fifty percent (50%) of their vested account balance, not to exceed \$50,000. The loans are secured by the balance in the participant's account and bear interest based on a fair rate as determined by Plan administration based on prevailing interest rates. Principal and interest is paid ratably through payroll deductions.

#### 3. TAX STATUS

The Plan filed with the Internal Revenue Service information necessary for it to rule on the Plan's qualification pursuant to Section 401 of the Internal Revenue Code of 1986. The Plan received a favorable determination letter dated 2010 and it is required to operate in conformity with the Internal Revenue Code to maintain its qualification. The qualification means the Plan is not subject to tax under present income tax law. The Trustees do not believe that amendments made since the determination letter, or any other events that have occurred, will adversely affect the Plan's qualification. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2020.

#### 4. TRANSACTIONS WITH PARTIES-IN-INTEREST

There were no transactions with parties-in-interest during the year other than with fiduciary.

6. FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB Statement No. 157 are described below:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include: Quoted prices for similar assets or liabilities in active markets; Quoted prices for identical or similar assets or liabilities in inactive markets; Inputs other than quoted prices that are observable for the asset or liability; Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Fair value estimates are made as of a specific point in time, based on available market information and judgments about the financial instrument. Such estimates do not consider the tax impact of the realization of unrealized gains or losses. In addition, the disclosed fair values may not be realized in the immediate settlement of the financial instrument.

*Mutual Funds* – The mutual funds are held as individual plan assets. The mutual funds have publicly available prices that are quoted daily in active markets. Lifecycle funds are managed based on a target date. Due to similar valuation techniques, they are classified as mutual funds.

*Money Market Fund* – The money market fund is held as an individual plan asset, has a principal value of \$1 per unit and has an available price quoted daily in an active market.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

As of December 31, 2024 and 2023, plan management evaluated the funds and determined, based on the underlying assets of mid to large cap stock, that these funds should be classified as Level 1. Guaranteed accounts, if any, are also classified as Level 1 because they do not meet the criteria for Level 2. The Plan investments at fair value classified within Level 3 were nil as of December 31, 2024 and 2023.
