Our Responsibility under Generally Accepted Auditing Standards

Our responsibility under generally accepted auditing standards has been described in our engagement letter dated June 23, 2025. As described in that letter, our responsibilities under generally accepted auditing standards and the ERISA Section 103(a)(3)(C) Election include forming and expressing an opinion on whether the form and content of the information included in the Plan's financial statements and supplemental schedule, other than that derived from the information certified by the trustee and custodian, are presented in compliance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. We considered internal control over financial reporting in order to design audit procedures that were appropriate in the circumstances for the purpose of expressing our opinion on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control over financial reporting. Accordingly, we do not express an opinion on the effectiveness of the Plan's internal control over financial reporting.

Significant Accounting Policies

The Plan's significant accounting policies are set forth in Note 2 to the Plan's 2024 financial statements. We are not aware of any significant changes in previously adopted accounting policies or their application during the year ended December 31, 2024.

We have evaluated the significant qualitative aspects of the Plan's accounting practices, including accounting policies, accounting estimates, and financial statement disclosures and concluded that the policies are appropriate, adequately disclosed, and consistently applied by management.

Accounting Estimates

Accounting estimates are an integral part of the financial statements prepared by Plan management and are based on management's current judgments. Those judgments are ordinarily based on knowledge and experience about past and current events and on assumptions about future events. Significant accounting estimates reflected in the Plan's 2024 financial statements include the valuation of investments.

During the year ended December 31, 2024, we are not aware of any significant changes in accounting estimates or in Plan management's judgments relating to such estimates.

Uncorrected Misstatements

Except with respect to the investment information certified by the trustee and custodian, our ERISA Section 103(a)(3)(C) audit of the financial statements was designed to obtain reasonable, rather than absolute, assurance about whether the financial statements are free of material misstatement, whether caused by error or fraud. There were no uncorrected misstatements or disclosure items passed identified during our ERISA Section 103(a)(3)(C) audit.

Material Corrected Misstatements

There were no material misstatements that were brought to the attention of Plan management as a result of our ERISA Section 103(a)(3)(C) audit procedures.

Form 5500

In accordance with generally accepted auditing standards, we obtained and read a draft of the Plan's Form 5500 that is substantially complete (the "draft Form 5500") prior to the dating of our auditor's report. We read the Plan's draft Form 5500 to identify material inconsistencies, if any, with the audited financial statements. We did not note any material inconsistencies or obtain knowledge of a material misstatement of fact in the other information.

Disagreements with Plan Management

We have not had any disagreements with Plan management related to matters that are material to the Plan's 2024 financial statements.

Our Views about Significant Matters That Were the Subject of Consultation with Other Accountants

We are not aware of any consultations that Plan management may have had with other accountants about auditing and accounting matters during 2024.

Significant Findings or Issues Arising from the Audit Discussed, or Subject of Correspondence, with Plan Management

Throughout the year, routine discussions were held, or were the subject of correspondence, with Plan management. In our judgment, such discussions or correspondence did not involve significant findings or issues requiring communication to the Audit Committee.

Significant Difficulties Encountered in Performing the ERISA Section 103(a)(3)(C) Audit

In our judgment, we received the full cooperation of the Plan's management and staff and had unrestricted access to the Plan's senior management in the performance of our ERISA Section 103(a)(3)(C) audit.

Management's Representations

We have made specific inquiries of the Plan's management about the representations embodied in the financial statements. In addition, we have requested that Plan management provide to us the written representations the Plan is required to provide to its independent auditors under generally accepted auditing standards. We have attached to this letter, as Appendix A, a copy of the representation letter we obtained from Plan management.

Control-Related Matters

We have previously communicated a certain matter noted during our ERISA Section 103(a)(3)(C) audit of the financial statements of the Plan for the year ended December 31, 2014, which we considered to be a material weakness, in our report to Plan management and those charged with governance. As of the date of this report, we believe the Plan has not remediated the material weakness. We have outlined in the attached Appendix B the previously reported matter that we believe have not yet been remediated.

The definitions of a deficiency and a material weakness, are also set forth in Appendix B.

We have identified, and included in Appendix B, certain matters involving the Plan's internal control over financial reporting that we consider to be a material weakness under generally accepted auditing standards.

Although we have included Plan management's written response to our comment in Appendix B, such response has not been subjected to the auditing procedures applied in our ERISA Section 103(a)(3)(C) audit of the financial statements and, accordingly, we do not express an opinion or provide any form of assurance on the appropriateness of the responses or the effectiveness of any corrective actions described therein.

Modifications to Our Opinion

In addition to the disclaimer of opinion as a result of the ERISA Section 103(a)(3)(C) Election, our report also notes that (i) the Plan has not maintained sufficient accounting records and supporting documents relating to certain contracts and custodial accounts issued to current and former employees prior to January 1, 2009 and accordingly, we were unable to apply auditing procedures sufficient to determine the extent of which the financial statements may have been affected by these conditions and (ii) the Plan has excluded from investments in the statement of net assets available for benefits, certain contracts and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the Department of Labor, but accounting principles generally accepted in the United States of America require that these accounts and the related income and distributions be included in the financial statements. The effects of these excluded contracts and custodial accounts and the related income and distributions on the financial statements are not reasonably determinable. As a result, we have disclaimed an opinion on the financial statements.

Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of Baptist Health Thrift Plan. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

As described in Note 2 to the financial statements, the Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

As described in Note 2 to the financial statements, the Plan has excluded from investments in the accompanying statement of net assets available for benefits certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have also been excluded in the accompanying statement of changes in net assets available for benefits. Accounting principles generally accepted in the United States of America require that

these accounts and the related income and distributions be included in the accompanying financial statements. The effects of these excluded contracts and custodial accounts and the related income and distributions are not reasonably determinable.

We are providing this letter in connection with your audits of the statements of net assets available for benefits of Baptist Health Thrift Plan, (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes (collectively referred to as the "financial statements").

We elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor (DOL)'s Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). We acknowledge that the audits did not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance company, that is regulated, supervised and subject to periodic examination by a state or federal agency, a qualified institution, that prepared and certified the investment information in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. We have determined that an ERISA Section 103(a)(3)(C) audit is permissible under the circumstances. We have also determined that the investment information is prepared and certified by qualified institutions as described by 29 CFR 2520.103-8, that the certifications meet the requirements in 29 CFR 2520.103-5, and that the certified investment information is appropriately measured, presented, and disclosed in accordance with accounting principles generally accepted in the United States of America (GAAP).

The purpose of an ERISA Section 103(a)(3)(C) audit is to express an opinion as to whether the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America and that the assets held by and certified to by qualified institutions agree to, or is derived from, in all material respects, the certified investment information.

However, we understand that, because the Plan has not maintained sufficient accounting records and supporting documents relating to certain contracts and custodial accounts issued to current and former employees prior to January 1, 2009, you were unable to apply auditing procedures sufficient to determine the extent to which the financial statements and supplemental schedule may have been affected by these conditions. Because of the significance of the investment information that you did not audit and because you were unable to apply auditing procedures to satisfy yourselves as to the appropriateness and completeness of the Plan's net assets available for benefits and changes in net assets available for benefits, we understand that you will not be able to express, and will not express, an opinion on the financial statements or supplemental schedule taken as a whole.

We confirm that we are responsible for the following:

- a. The preparation and fair presentation in the Plan's financial statements of net assets and changes in net assets in conformity with GAAP.
- b. The fair presentation of the applicable supplemental schedule in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- c. Administering the Plan and determining that the Plan's transactions that are presented and disclosed in the ERISA plan financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants to determine the benefits due or which may become due to such participants.
- d. The design, implementation, and maintenance of internal control:
 - Relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.
 - To prevent and detect fraud.

Certain representations in this letter are described as being limited to matters that are material. Items are considered material, regardless of size, if they involve an omission or misstatement of accounting information that, in light of surrounding circumstances, makes it probable that the judgment of a reasonable person relying on the information would be changed or influenced by the omission or misstatement.

We confirm, to the best of our knowledge and belief, the following representations made to you during your ERISA Section 103(a)(3)(C) audits.

1. Except to the extent the aforementioned financial statements and supplemental schedule may have been affected by the conditions described in the introductory paragraphs, the financial statements referred to above are fairly presented in conformity with GAAP and the notes include all disclosures required by laws and regulations to which the Plan is subject. The accompanying supplemental schedule is fairly presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
2. Plan management has provided to you all relevant information and access as agreed in the terms of the audit engagement letter.
3. Plan management has made available to you:
 - a. All financial records and related data except as described in item 1, including the names of all related parties and parties-in-interest and all relationships and transactions with related parties and parties-in-interest.
 - b. All minutes of the meetings of Baptist Healthcare System Inc.'s (the "Plan Sponsor") Benefit committee pertinent to the operation of the Plan or summaries of actions of recent meetings for which minutes have not yet been prepared. All significant board and committee actions are included in the summaries.

- c. The most current plan document for the audit period, including amendments made to the plan document, the trust agreement, or insurance contracts (if applicable) during the year, including amendments to comply with applicable laws.
 - d. A draft of Form 5500, *Annual Return/Report of Employee Benefit Plan*, that is substantially complete.
4. There have been no communications with regulatory agencies concerning noncompliance with or deficiencies in financial reporting practices or administrative practices.
5. The Plan has disclosed to you the results of Plan management's risk assessment, including the assessment of the risk that the financial statements may be materially misstated as a result of fraud.
6. We have no knowledge of any fraud or suspected fraud affecting the Plan involving:
 - a. Management.
 - b. Employees who have significant roles in the Plan's internal control.
 - c. Others, where the fraud could have a material effect on the financial statements.
7. We have no knowledge of any allegations of fraud or suspected fraud affecting the Plan's financial statements communicated by employees, former employees, plan participants, regulators, beneficiaries, service providers, third-party administrators, or others.
8. The methods, significant assumptions, and the data used by us in making the accounting estimates and the related disclosures are appropriate to achieve recognition, measurement, or disclosure that is in conformity with GAAP.
9. We have complied with the July 2007 Internal Revenue Service regulations for 403(b) plans requiring the Plan Sponsor to have a written plan document in place.
10. The Plan, as written and applied, meets the requirements of the applicable sections of the Internal Revenue Code, and the trust established under the Plan qualifies for exemption under the applicable sections of the Internal Revenue Code. The Plan Sponsor has operated the Plan and trust in a manner that did not jeopardize this tax status.
11. We have performed the relevant Internal Revenue Code compliance tests, including, but not limited to, nondiscrimination testing.
12. The Plan has complied with the fidelity bonding requirements of ERISA.
13. There are no matters (e.g., breach of fiduciary responsibilities, nonexempt party-in-interest transactions, loans or leases in default, events that may jeopardize the Plan's tax qualification status) that legal counsel has advised us that must be disclosed in accordance with the DOL's Rules and Regulations for Reporting and Disclosure, Internal Revenue Code, or ERISA.
14. There were no reviews or inquiries by the DOL, Internal Revenue Service, or other regulatory agency of the Plan's activities or filings since our last audit.

15. We are not aware of any intention on the part of the Plan Sponsor to terminate the Plan or take any other action that could result in an effective termination for the Plan. We are not aware of any occurrences that could result in the termination of the Plan.
16. There have been no unusual or infrequent events or transactions, including Plan amendments, occurring after the latest benefit information date but before issuance of the Plan's financial statements that might affect the usefulness of the Plan's financial statements when assessing the Plan's present and future ability to pay benefits.
17. The Plan's investment in guaranteed investment contract meets all of the conditions of the definition of fully benefit responsive as defined by FASB ASC 962, *Plan Accounting — Defined Contribution Pension Plans*, as amended, as follows:
 - a. The investment contract is affected directly between the Plan and the issuer and prohibits the Plan from assigning or selling the contract or its proceeds to another party without the consent of the issuer.
 - b. The repayment of principal and interest credited to participants in the Plan is a financial obligation of the issuer of the investment contract.
 - c. The terms of the investment contract require all permitted participant-initiated transactions with the Plan to occur at contract value with no conditions, limits, or restrictions.
 - d. An event that limits the ability of the Plan to transact at contract value with the issuer (for example, premature termination of the contracts by the Plan, plant closings, layoffs, Plan termination, bankruptcy, mergers, and early retirement incentives) and that also limits the ability of the Plan to transact at contract value with the participants in the Plan is probable of not occurring.
 - e. The Plan allows participants reasonable access to their funds.
18. The Plan has complied with the DOL's regulations concerning the timely remittance of contributions to trusts containing assets for the Plan
19. The Plan's forfeiture application policy meets the requirements of the Internal Revenue Code and also conforms to the plan document requirements.
20. We have made a "good faith" effort to transition the plan to ERISA's generally applicable annual reporting requirements for 403(b) plans. We believe that the conditions of the DOL Field Assistance Bulletin 2009-02, *Annual Reporting Requirements for 403(b) plans*, to not treat annuity contracts and custodial accounts as part of the Plan assets for purposes of ERISA's annual reporting requirements have been satisfied with respect to excluded contracts (if any).
21. As of December 31, 2024 and December 31, 2023 we have implemented internal controls to keep and maintain sufficient records going forward. In addition, under ERISA, we are required as the Plan Administrator (Sponsor) to retain records necessary to verify or support information included in the Plan's Form 5500 annual report for six years from the date the annual report was filed (ERISA §107), and also to maintain for as long as necessary records that are sufficient to determine the benefits due

or that may become due under the Plan (ERISA §209). We have established controls and procedures to comply with these requirements going forward.

22. The current and former vendors and/or insurance companies that we have identified that hold annuity contracts and custodial accounts of the Plan include Lincoln Financial Group (“Lincoln”) and Fidelity Management Trust Company (“Fidelity”). We are not aware of any additional current or former vendors and/or insurance companies that hold such annuity contracts or custodial accounts. All annuity contracts and custodial accounts that we have identified have been reported in the statements of net assets available for benefits as of December 31, 2024 and 2023 .
23. Plan management has taken the necessary steps to perform an appropriate fair value measurement analysis to determine that the fair value of the certified plan assets does not vary from the carrying value that is certified by Fidelity Management Trust Company and Lincoln National Life Insurance Company.
24. Form 5500 instructions indicate that the report of an Independent Qualified Public Accountant consists of an Accountant's Opinion, Financial Statements, Notes to the Financial Statements, and Supplemental Schedules. We will attach the audited financial statements and your auditor's report thereon in its entirety to Form 5500.
25. Plan management has provided to you:
 - a. A corporate entity tree that identifies the legal names of the Plan's affiliates, including affiliates as defined in AICPA Interpretation 1.224.010, *Client Affiliates* together with the ownership relationship among such entities.
26. We have complied with all applicable provisions of the Foreign Corrupt Practices Act.
27. We have disclosed to you all significant cyber security incidents and/or breaches in which an actual or potentially adverse effect on an information system, network, or the information residing therein occurred or there was a loss of assets. We considered the cyber incident or breach to be significant if such incident or breach merited the attention of those charged with governance.

Except where otherwise stated below, immaterial matters less than \$6,800,000 collectively are not considered to be exceptions that require disclosure for the purpose of the following representations. This amount is not necessarily indicative of amounts that would require adjustment to, or disclosure in, the financial statements.

28. Except as described in the introductory paragraphs there are no transactions that have not been properly recorded and reflected in the financial statements.
29. The Plan has no plans or intentions that may affect the carrying value or classification of the Plan's assets and liabilities, nor are we aware of any such plans or intentions on the part of the Plan Sponsor.
30. The following, to the extent applicable, have been appropriately identified, properly accounted for, and disclosed in the financial statements, or if applicable, the supplemental schedule:

- a. Transactions with parties-in-interest, as defined in ERISA Section 3(14) and regulations thereunder, including those transactions set forth in Sections 406 and 407(a) of ERISA and Section 4975(c) of the Internal Revenue Code.
 - b. Other related parties and all the related-party relationships and transactions of which Plan management is aware, including sales, purchases, loans, transfers, leasing arrangements, and guarantees (written or oral).
 - c. Reportable transactions as defined under ERISA Section 103(b)(3)(H) and regulations thereunder.
 - d. Amendments to the plan document, including any amendments impacting the usefulness of the financial statements through the date the financial statements were available to be issued.
 - e. All derivative financial instruments (e.g., futures, options, swaps), including outstanding commitments to purchase or sell securities under forward placement and standby commitments.
 - f. Securities lending, including securities on loan, collateral held under securities lending agreements, and the liability to return collateral held under securities lending agreements.
31. In preparing the financial statements in conformity with GAAP, Plan management uses estimates. All estimates have been disclosed in the financial statements for which known information available prior to the issuance of the financial statements indicates that both of the following criteria are met:
- a. It is reasonably possible that the estimate of the effect on the financial statements of a condition, situation, or set of circumstances that existed at the date of the financial statements will change in the near term due to one or more future confirming events.
 - b. The effect of the change would be material to the financial statements.
32. There are no:
- a. Instances of identified or suspected noncompliance with laws and regulations whose effects should be considered when preparing the financial statements
 - b. Known actual or possible litigation and claims whose effects should be considered when preparing the financial statements that have not been disclosed to you and accounted for and disclosed in accordance with GAAP.

The Plan has satisfactory title to all owned assets, and there are no liens or encumbrances on such assets, nor has any asset been pledged as collateral .


33. The Plan has complied with all aspects of contractual agreements that may affect the financial statements.
34. Regarding supplemental information:

- a. We are responsible for the preparation and fair presentation of the supplemental information in conformity with DOL Rules and Regulations for Reporting and Disclosure under ERISA.
 - b. We believe the supplemental information, including its form and content, is fairly stated in all material respects.
 - c. The methods of measurement and presentation of the supplemental information has not changed from those used in the prior period.

We have identified the following significant assumptions and factors affecting securities: The Plan invests in registered mutual funds which are stated at fair market value based upon quoted market prices. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. The factors are reflective of management's intent and ability to carry out specific courses of action and the significant assumptions used are consistent with the Plan's plans and past experience. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the financial statements..
37. With regard to the fair value measurements and disclosures of certain assets and liabilities, such as investments:
- a. The measurement methods, including the related assumptions, used in determining fair value were appropriate, consistent with market participant assumptions where available without undue cost and effort, and were consistently applied in accordance with GAAP.
 - b. The completeness and adequacy of the disclosures related to fair values are in accordance with GAAP.
 - c. No events have occurred after December 31, 2024 but before the date the financial statements were available to be issued that require adjustment to the fair value measurements and disclosures included in the financial statements.
38. Investments, loans, or leases that are in default or that are considered to be uncollectible have been properly recorded and disclosed in the financial statements.
39. Financial instruments with significant individual or group concentration of credit risk have been appropriately identified, properly recorded, and disclosed in the financial statements.
40. In accordance with the provisions of the Coronavirus Aid, Relief, and Economic Security Act (the "CARES Act") and The Setting Every Community Up for Retirement Enhancement Act (the "SECURE Act"), we made changes in plan operations related to certain provisions in the Act. These changes

were made immediately without formally amending the plan document. We will formally amend the plan document on or before the last day of the 2025 plan year.

APPENDIX B

Matters Related to Internal Control over Financial Reporting

Section I — Material Weakness Identified in a Previous ERISA Section 103(a)(3)(C) Audit That Has Not Yet Been Remediated

We identified and previously communicated the following deficiency that was considered to be a material weakness in the Plan's internal control over financial reporting during our ERISA Section 103(a)(3)(C) audit of the financial statements of the Plan for the year ended December 31, 2014. As of the date of this report, we believe this deficiency has not yet been remediated by the Plan:

Material Weakness

Plan Records Management

In December 2007, the Department of Labor (DOL) issued amended regulations eliminating an exemption granted to 403(b) plans for the annual Form 5500 reporting, disclosure, and audit requirements under Part 1 of Subtitle I of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The removal of this exemption subjected ERISA-covered 403(b) plans to the same Form 5500 reporting and audit requirements as 401(k) plans, effective with their 2009 Form 5500 filing.

In complying with the new ERISA annual reporting requirements, many plan administrators have been faced with considerable challenges related to the plan's records management. Historically, many plan sponsors did not consider 403(b) annuity contracts and custodial accounts to be plan assets for which they were responsible to monitor. Accordingly, in many instances, sufficient plan records were not maintained or proper governance controls established over the recording and maintenance of plan data. Also, vendors used by the Plan may not be able to, or refuse to, provide such data prior to 2009. Many plan administrators have, therefore, found it costly and, in some cases, impossible to identify and gather all of the plan's records necessary for the fair presentation of the plan's annual financial statements that accompany the Form 5500.

Nevertheless, under ERISA there are two basic record retention provisions that were required prior to the elimination of the exemption referred to above. Section 107 of ERISA requires anyone subject to a requirement to file any report (even if subject to an exemption of simplified reporting requirements) to maintain records on the matters of which disclosures are required, which will provide in sufficient detail the necessary basic information and data from which the documents thus required may be verified, explained, or clarified and checked for accuracy and completeness for a period of not less than six years. Section 209 of ERISA requires every employer to maintain records necessary to determine the benefits due or that may become due to each of its employees.

The Plan faced similar records management challenges, and therefore, the Plan's records relating to certain contracts and custodial accounts issued to current and former employees prior to January 1, 2009 are insufficient for the Plan's administrator to prepare and fairly present, in all material respects, the Plan's annual financial statements in accordance with accounting principles generally accepted in the United States of America. Accordingly, there is a reasonable possibility that such financial statements are

materially misstated due to a deficiency in the design of the Plan's related governance controls over recording and maintaining Plan records. We consider this deficiency to be a material weakness.

Field Assistance Bulletin 2010-01, Annual Reporting and ERISA Coverage for 403(b) Plans, issued by the DOL provides some enforcement relief for plans that make "good faith efforts" to transition to ERISA's new annual reporting requirements. Such efforts would generally require the implementation of controls to keep and maintain sufficient records on a going forward basis. Appropriate controls should be established to monitor services outsourced to vendors who maintain contracts and custodial accounts. Monthly, quarterly, and annual reports should be obtained from each of these vendors and reconciled to the Plan sponsors' internal records so that Plan financial statements can be prepared.

Additionally, appropriate records should be maintained to comply with ERISA's record retention provisions.

Management Response

No action is necessary by management. During 2007, the Department of Labor (DOL) amended the regulations which previously exempted 403(b) plans from the requirement to file a Form 5500. As a result, beginning in 2009 (effective date of amendment), all 403(b) plans were required to file a Form 5500 which then triggered the requirement for a plan audit. Given the exemption that previously existed, records were not maintained so both the record keepers of the Plan and Plan management were unable to sufficiently establish that all records required to be certified for audit purposes were accurate and complete. As a result, this finding will continue for the foreseeable future, or until the DOL or ERISA amends the current regulations related to the Form 5500 and/or audit requirements.

Section II — Definitions

The definitions of a deficiency, a material weakness, and a significant deficiency are as follows:

A *deficiency* in internal control over financial reporting exists when the design or operation of a control does not allow Plan management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct misstatements on a timely basis. A deficiency in design exists when (a) a control necessary to meet the control objective is missing or (b) an existing control is not properly designed so that, even if the control operates as designed, the control objective would not be met. A deficiency in operation exists when a properly designed control does not operate as designed or the person performing the control does not possess the necessary authority or competence to perform the control effectively.

A *material weakness* is a deficiency, or a combination of deficiencies, in internal control over financial reporting, such that there is a reasonable possibility that a material misstatement of the plan's financial statements will not be prevented, or detected and corrected on a timely basis.

A *significant deficiency* is a deficiency, or a combination of deficiencies, in internal control over financial reporting that is less severe than a material weakness yet important enough to merit attention by those responsible for oversight of the Plan's financial reporting.

INDEPENDENT AUDITOR'S REPORT

The Plan Administrator of the Baptist Health Thrift Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We were engaged to perform audits of the financial statements of Baptist Health Thrift Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of Baptist Health Thrift Plan. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion

As described in Note 2 to the financial statements, the Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

As described in Note 2 to the financial statements, the Plan has excluded from investments in the accompanying statement of net assets available for benefits certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have also been excluded in the

accompanying statement of changes in net assets available for benefits. Accounting principles generally accepted in the United States of America require that these accounts and the related income and distributions be included in the accompanying financial statements. The effects of these excluded contracts and custodial accounts and the related income and distributions are not reasonably determinable.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.


Auditor's Responsibilities for the Audit of the Financial Statements

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, it is inappropriate to and we do not express an opinion on the supplemental schedule referred to above.

NOTES TO FINANCIAL STATEMENTS

AS OF DECEMBER 31, 2024 AND 2023, AND FOR THE YEAR ENDED DECEMBER 31, 2024

1. DESCRIPTION OF THE PLAN

The following description of the Baptist Health Thrift Plan is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's information, which is available from the plan administrator.

General—The Plan is a defined contribution plan covering substantially all employees of Baptist Healthcare System, Inc. (the "Company"). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Fidelity Management Trust Company ("Fidelity") serves as Plan trustee and recordkeeper, and The Lincoln National Life Insurance Company ("Lincoln") serves as the custodian of the investment contract. Effective January 1, 2022, the Plan was amended to no longer accept participant contributions and employer matching contributions to the Plan and participant and employer contributions were directed to another Company sponsored defined contribution plan. Employees were eligible to receive employer contributions after completing 1,000 hours of service within a Plan year.

Participant Accounts—Individual accounts are maintained for each participant of the Plan. Each participant's account is credited with nonelective contributions, if any, and Plan earnings. Participant accounts are also charged with withdrawals and an allocation of plan losses and administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments—Participants may direct the investment of their account balances into various investment options offered by the Plan and may change investments and transfer amounts between funds daily. The Plan offers mutual funds, a traditional investment contract, and a self-directed brokerage account as investment options. Participants may direct their investments through a trustee-sponsored brokerage account, which offers the option to invest in a variety of common stocks, mutual funds, exchange traded funds, fixed income securities (including government bonds and CDs), and interest-bearing cash investments.

Vesting— Participants are immediately fully vested in their voluntary contributions, plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts, plus earnings thereon, is based on years of service. A participant is fully vested in Company-matching contributions after five years of service, or after reaching age 65, whichever occurs first.

Notes Receivable from Participants—Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of one-half of the vested account balance or \$50,000. The loans are secured by an assignment of a participant's vested interest in the Plan, and bear interest at a rate commensurate with local prevailing rates at the time funds are borrowed as determined by the Plan administrator. Principal and interest are paid ratably through direct payments to the recordkeeper, or as a lump sum for the outstanding loan balance. Loans may be repaid over a period not to exceed 60 months (120 months for the purchase of a primary residence). As of December 31, 2024, participant loans have maturities through 2034 at interest rates ranging from 4.25% to 10.5%.

Payment of Benefits—On termination of service with the Company (including termination of service due to death, disability, or retirement), a participant may generally elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account; a lifetime income annuity; or monthly, quarterly, or annual installments over a fixed period of time.

Participants are also eligible to make hardship withdrawals from their deferred contributions in the event of certain financial hardships.

Forfeited Accounts—When certain terminations of participation in the Plan occur, the nonvested portion of the participant’s account, as defined by the Plan, represents a forfeiture. The Plan document permits the use of forfeitures to pay administrative expenses. However, if a participant is reemployed and fulfills certain requirements, as defined in the Plan document, the account will be reinstated. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$3,656,358 and \$3,093,608, respectively. During the year ended December 31, 2024, approximately \$105,000 of forfeited nonvested accounts were used to pay plan administrative expenses.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting—The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

GAAP Departure—The Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. The Plan has excluded from investments in the accompanying statements of net assets available for plan benefits, certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the Department of Labor’s Field Assistance Bulletin No. 2009-02, “Annual Reporting Requirements for 403(b) Plans”. The investment income and distributions related to such accounts have also been excluded in the accompanying statement of changes in net assets available for plan benefits. GAAP requires that these accounts and the related income and distributions be included in the accompanying financial statements. The effects of these excluded contracts and custodial accounts and the related income and distributions are not reasonably determinable.

Use of Estimates—The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties—The Plan provides various investment options to its participants. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the value of the participants’ account balances and the amounts reported in the financial statements.

Investment Valuation and Income Recognition—The Plan’s investments in mutual funds are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s investment in a fully benefit-responsive investment contract is recorded at contract value. Contract value is the amount Plan participants would receive if they were to initiate permitted

transaction under the terms of the Plan (see Note 5). See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants—Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

Administrative Expenses—Administrative expenses of the Plan are paid by the Plan or the Company, at the Company's discretion, as permitted in the Plan document. Participants pay administrative costs for loans, distributions and qualified domestic relation orders. All investment management and transaction fees directly related to the Plan investments are paid by the Plan. Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investment in the statement of changes in net assets available for benefits.

Payment of Benefits—Benefit payments to participants are recorded upon distribution. There were no amounts allocated to accounts of persons who had elected to withdraw from the Plan, but had not yet been paid at December 31, 2024 and 2023.

Subsequent Events—No events have occurred after December 31, 2024, but before September 5, 2025, the date the financial statements were available to be issued that require consideration as adjustments to or disclosures in the Plan's financial statements.

3. INFORMATION CERTIFIED BY THE TRUSTEE

The following is a summary of the certified investment information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedule, that was prepared by or derived from information prepared by Fidelity, the trustee of the Plan, and Lincoln, the custodian of certain assets of the Plan,

and furnished to the Plan administrator. The Plan administrator has obtained certifications from the trustee and custodian that such information is complete and accurate.

4. FAIR VALUE MEASUREMENTS

Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows: Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Asset Valuation Techniques—Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds—Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-Directed Brokerage Accounts— Includes a variety of mutual funds, common stocks, exchange-traded funds, and U.S. government securities, all of which are valued at quoted market prices in active

markets and are classified as Level 1 within the fair value hierarchy. Interest-bearing cash accounts are valued at cost, which approximates fair value, and are also classified as Level 1.

The following tables set forth by level, within the fair value hierarchy a summary of the Plan's investments measured at fair value on a recurring basis at December 31, 2024 and 2023.

Transfers between Levels—The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

The significance of transfers between levels is evaluated based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers between levels.

5. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan holds an investment in a traditional investment contract. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant

withdrawals, and administrative expenses. The contract value of the traditional investment contract held by the Plan was \$35,153,946 and \$42,236,540 at December 31, 2024 and 2023, respectively.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a quarterly basis for resetting. The contract can be terminated with 90 days notice, subject to various repayment options.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include the following:

1. The Plan ceases to meet the requirements of the Internal Revenue Code
2. Premature termination of the contract
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. Termination of the recordkeeping agreement with the issuer.
5. A material amendment to the agreements without the consent of the issuer.

6. PLAN TERMINATION

While it has not expressed any intention to terminate the Plan, the Company has ceased contributions as discussed in Note 1. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

7. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Fidelity. Fidelity is the trustee as defined by the Plan. Therefore, transactions with Fidelity qualify as party-in-interest transactions. Fees paid to Fidelity for administrative expenses amounted to \$1,015,918 for the year ended December 31, 2024. In addition, fees paid for Fidelity's investment management services were included as a reduction of the return earned on each fund. The Plan also invests in an investment contract with Lincoln, a custodian of the Plan. Therefore, transactions with Lincoln also qualify as exempt party-in-interest transactions. Fees

paid for Lincoln's investment management services were included as a reduction of the return earned on the investment contract. The Company provides certain administrative services at no cost to the Plan. The Plan issues loans to participants, which are secured by the vested balances in the participants' accounts.

8. FEDERAL INCOME TAX STATUS

In 2009, the Company amended the Plan to incorporate appropriate amendments to be compliant with the Internal Revenue Code (IRC). The Plan uses a Fidelity pre-approved 403(b) Volume Submitter plan. Fidelity received an opinion letter from the Internal Revenue Service (IRS), dated August 7, 2017, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.
