**INDEPENDENT AUDITORS' REPORT**

To the Administrators of  
Simplex Industries, Inc. 401(K) Plan

***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Simplex Industries, Inc. 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Simplex Industries, Inc. 401(K) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year then ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## ***Basis for Opinion***

1. DESCRIPTION OF PLAN

The following description of the Simplex Industries, Inc. (the "Company") 401(K) Plan, which also includes the employees of Simplex Construction Co., Inc., and Cornerstone Construction Services, Inc., provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions. The Plan's initial effective date was January 1, 1996. The Plan was amended and restated effective February 18, 2022 to incorporate changes listed in the 2017 Cumulative List of Notice 2017-37, 2017-29 Internal Revenue Bulletin (IRS) 89 and to adopt the provisions of the CARES and SECURE ACTS.

A. General:

The Plan is a defined contribution plan covering all full-time employees of Simplex Industries, Inc., Simplex Construction Co., Inc. and Cornerstone Construction Services, Inc. who have six months of service and are age nineteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

B. Contributions:

Each year, participants may contribute any percentage of pre-tax or after-tax (Roth) annual compensation defined as wages, tips and other compensation on form W-2, up to the current year's elective deferral limit. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may be automatically enrolled into the Plan at a contribution rate of three percent, unless they opt out of participation. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may make matching contributions equal to a discretionary percentage that may be different for each participating business unit as determined by the Company. During 2024, the Company contributed twenty-five percent of the first six percent of a participant's compensation. The Company may make additional discretionary matching contributions to participants that completed at least 1,000 hours of service and are employed on the last day of the Plan year. No additional discretionary matching contributions were made in 2024. Contributions are remitted to the Plan on a weekly basis. Contributions are subject to certain limitations.

C. Participant Accounts:

Each participant's account is credited with the participant's contribution and the Company's matching contribution, and allocation of the (a) company's discretionary matching contributions and (b) plan earnings. Participant accounts are charged with benefit payments, transaction fees related to notes receivable from participants and distributions, and an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

D. Vesting:

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the company's contribution portion of their accounts is based on years of continuous service. The vesting schedule for participants in the plan is:

0%	After One Year of Vesting Service
20%	After Two Years of Vesting Service
40%	After Three Years of Vesting Service
60%	After Four Years of Vesting Service
80%	After Five Years of Vesting Service
100%	After Six Years of Vesting Service

E. Notes Receivable from Participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from 1-5 years or up to 25 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear a reasonable rate of interest based on the prime interest rate plus 2%. At December 31, 2024, interest rates range from 5.25% to 10.50%. Principal and interest is paid ratably through weekly payroll deductions. Participants may only have one loan outstanding at a time.

F. Payment of Benefits:

On termination of service due to death, disability, retirement or other reasons a participant may receive a lump-sum distribution in an amount up to the value of the participant's vested interest in his or her account. A participant may withdraw all or part of his/her fully vested pre-tax elective deferral account in the event of undue financial hardship. A participant that is 59½ years of age may take an in service withdrawal of his/her fully vested funds. The Plan allows automatic lump sum distributions if the value of the participants vested account balance is less than \$7,000. The participant must consent to distributions in excess of \$7,000. Accounts with a value of \$1,000 or less are distributed as a lump sum cash payment. If accounts are valued greater than \$1,000 but less than \$7,000, and the participant does not elect a rollover account, the Plan Administrator will transfer the funds to an individual retirement account designated by the Plan Administrator.

G. Forfeited Accounts:

There may be forfeitures related to the Company's matching contributions. At December 31, 2024 and 2023 forfeited nonvested accounts totaled \$0 and \$0, respectively. These accounts will be used to reduce employer contributions or pay administrative expenses. In 2024, there were \$8,749 in additional forfeitures and earnings, \$934 was used to pay administrative expenses and \$7,815 was used to reduce employer contributions during 2024.

H. Plan Amendments:

Effective January 2024, the Plan adopted certain requirements of Setting Every Community Up for Retirement Enhancement 2.0 (SECURE 2.0) Act which changed required minimum distribution age from 72 to 73. The Plan has until 2026 to formally amend the Plan.

Effective January 2024, the Plan adopted certain requirements of Setting Every Community Up for Retirement Enhancement 2.0 (SECURE 2.0) Act which increased the cash-out limit from \$5,000 to \$7,000. The Plan has until 2026 to formally amend the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of Accounting:

The financial statements of the Plan are prepared using the accrual basis of accounting, and are presented in the format prescribed by the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 ("Department of Labor"). The prescribed format differs from accounting principles generally accepted in the United States of America in that they do not require interest and dividends earned within mutual funds, pooled separate accounts, or bank collective trusts, etc., to be reported separately from the change in fair value (e.g. net appreciation/depreciation).

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement for the portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

B. Use of Estimates:

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

C. Investment Valuation and Income Recognition:

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Contributions are recorded in the period earned. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year and may include interest and dividends earned in pooled separate accounts as allowed by the Department of Labor.

D. Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases employment all loans become due and payable at the severance date. If not repaid or directly rolled over to a new employer's Plan the Plan administrator will deem the participant loan to be in default and the participant loan balance will be reduced and a benefit payment will be recorded.

E. Payment of Benefits:

Benefits are recorded when paid.

F. Administrative Expenses:

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

G. Date of Management Review:

Subsequent events were evaluated through October 9, 2025, which is the date the financial statements were available to be issued.

3. INFORMATION CERTIFIED TO BY THE PLAN CUSTODIAN

The Plan administrator has elected the method of compliance in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following investment information was certified in accordance with 29 CFR 2520.103-5 of the DOL Rules and Regulations for Reporting and Disclosure under ERISA as complete and accurate by the custodian, Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal Trust Company) and was not subjected to any auditing procedures performed by the independent auditors.

#### 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

##### Level 1:

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

##### Level 2:

Input to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3:

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled Separate Accounts:*

Valued at the net asset value (NAV) of units of pooled separate accounts at Principal Trust Company, the Plan custodian. The NAV, as provided by Principal Trust Company, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

*Common/Collective Trusts:*

Valued at the net asset value (NAV) of units of a bank collective trust at Principal Trust Company, the Plan custodian. The NAV, as provided by the Plan custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

*Registered Investment Companies:*

Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

**5. GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY**

Principal Trust Company on behalf of the Plan entered into two benefit-responsive investment contracts with Principal Life Insurance Company reported as the Principal Fixed Income Guaranteed Option and Principal Guaranteed Option. Principal Life maintains the contributions in a general account. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The guaranteed investment contracts meet the fully benefit-responsive criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third party to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

The crediting interest rates are established on the first day of semi-monthly, and are credited on a daily basis, based on the beginning daily balance of the fund. The interest rate is the daily equivalent of the effective annual rate of interest applicable for each month. At December 31, 2024, the interest rate for Principal Fixed Income Guaranteed Option and Principal Guaranteed Option was 1.55% and 4.85% respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such an event includes the transfer of all or part of a participant's funds to a competing fixed fund within the Plan. Plan management believes that the occurrence of an event that would limit the Plan's ability to transact at contract value with participants is not probable.

The investment contract has no stated maturity.

#### 6. PARTY-IN-INTEREST

The Plan investments included shares of common/collective trusts, pooled separate accounts and registered investment companies managed by Principal Trust Company, the custodian as defined by the Plan and, therefore, these transactions qualify as party in interest. Fees incurred by the Plan for investment management services from Principal Trust Company are included in net appreciation in fair value of the investment as they are paid through revenue sharing, rather than a direct payment.

During 2024, the custodian charged \$5,221 in distribution and loan fees directly to applicable participants and allocated \$59,372 in administrative and advisory fees to participants.

The Plan sponsor pays the administrative and audit fees for the Plan.

#### 7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in employer discretionary matching contributions.

8. TAX STATUS

On June 30, 2020, the IRS stated that the prototype plan adopted by the Plan, as then designed, qualifies under Internal Revenue Code (IRC) Section 401(a). Although the Plan has been amended since receiving the June 30, 2020 letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt. Therefore, no provision for income taxes have been included in the Plan's financial statements.

Plan management is required to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and amounts reported in the statement of net assets available for benefits.
