NOTES TO THE FINANCIAL STATEMENTS

December 31, 2024

**NOTE 1 – Description of Plan**

The following description of Longwood Management Corporation 401(k) Savings Plan (the Plan) is provided for general information only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** – The Plan is qualified in accordance with Internal Revenue Code 401(k). It is a defined contribution plan covering all employees under Longwood Management Corporation 401(k) Plan that have 3 months of service. The Plan is funded through a trust fund, which receives employee elective deferrals and Company matching contributions, invests in Plan assets and disburses pension benefits in accordance with the Trust Agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was adopted January 1, 1999.

**Contributions** – Participants may contribute up to certain limits of their annual compensation to the Plan, either as a pre-tax contribution or as a Roth contribution. Participants age 50 and over are eligible to make additional catch-up contributions. The Company may elect to contribute a "Matching Contribution." The Matching Contribution, if made, will be a percentage of the deferral made by the employees. During year ended December 31, 2024, the matching contributions made by the employer were in the amount equal to 25% of the employee elective deferral for participants with elective deferrals up to 10% and 2.5% of the employee eligible compensation for participants with elective deferrals in excess of 10%. A participant is also eligible for a discretionary nonelective employer contribution for a Plan year if the participant is active and earns at least 501 hours of service during the Plan year. The Plan permits rollover contributions from other qualified defined benefit and defined contribution plans. Annual contributions are limited to a maximum permissible amount, as set forth in Internal Revenue Code (IRC) Section 415.

**Investment Options** – Participants direct the investment of their accounts into various investment options offered by the Plan. The Plan currently offers registered investment company funds, a money market fund and a guaranteed interest account.

**Participant Accounts** – Each participant's account is credited with the participant's deferral and rollover contributions, any employer matching contributions and an allocation of plan earnings. Investment earnings are allocated based on a ratio of the participant's account balance to the total of the investment balance. Asset management fees are deducted directly from various funds in each participant's account. The benefit to which a participant is entitled is the vested amount in their individual account.

**Vesting** – Participants are immediately vested in their elective deferral contributions and rollover contributions, plus actual earnings thereon. Participants become vested in the employer matching and discretionary non-elective contributions portion of their account according to a graded vesting scale based on eligible years of service. If a participant terminates employment prior to normal retirement age (65) for reasons other than death or disability, the portion of the matching contribution is vested based on years of eligible service.

**Vesting** (continued) – Under this method, vesting service is measured on a plan year basis from the date of hire through the severance date according to the following scale:

**Payment of Benefits** – Upon termination of employment or termination of service due to death, disability, or retirement, participants may elect to receive an amount equal to the value of the participant’s vested interest in his or her account as a single lump sum payment. The Plan allows automatic distribution in cash of vested benefits totaling less than \$1,000. If the participant’s vested account balance is less than \$5,000, the Plan has the option of transferring the funds to an Individual Retirement Account through a direct rollover, unless the participant elects to receive a lump sum payment. Benefits are recorded when paid.

**Hardship Withdrawals** – The Plan allows for hardship withdrawals subject to a \$500 minimum, limited to the participant’s elective deferral account balance and vested matching and non-elective account balances.

**Administration of Plan Assets** – The Sponsor is also the Plan administrator. Effective December 1, 2013, the administrator entered into a contract with Fidelity Management Trust Company (Fidelity). Under the terms of the contract, Fidelity is the Trustee of the Plan and holds the Plan’s investment assets and executes investment transactions. As permitted by Department of Labor regulations, Fidelity certified certain financial information contained in the statements of net assets available for benefits and the statement of changes in net assets available for benefits to be complete and accurate.

**Forfeitures** – Forfeitures are the non-vested portion of a participant’s account that the participant loses upon termination of employment. Forfeitures can be used to restore forfeitures, reduce matching contributions or to pay Plan expenses. As of December 31, 2024 and 2023, there was \$2,597 and \$17,080 in available forfeitures, respectively. During the Plan year ended December 31, 2024, \$149,679 in forfeitures were used to reduce matching contributions.

**NOTE 2 – Summary of Significant Accounting Policies**

**Basis of Accounting** – The financial statements and supplemental schedule have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investments held by a defined contribution plan are required to be reported fair value except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

The statements of net assets available for benefits present the contract value of fully benefit-responsive investment contracts. The statement of changes in net assets available for benefits is prepared on a fair value basis for investment contracts that are not deemed to be fully benefit-responsive.

**Investment Valuation** – Investments are stated at fair value and contract value. The Plan's trustee, Fidelity Management Trust Company, certifies the contract value of the fully-benefit responsive investment contract and the fair value of the registered investment company funds. If available, quoted market prices are used to value investments. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net investment appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (i.e. the "exit price") in an orderly transaction between market participants at the measurement date. Contract value is the relevant measurement for assets invested in fully-benefit responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

**Notes Receivable from Participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**Administrative Expenses** – The Plan's administrative expenses are paid by either the Plan or the Sponsor, as provided by the Plan document. Administrative expenses that are paid by the Sponsor are not included in the accompanying financial statements. Certain administrative functions are performed by employees of the Sponsor. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions (notes receivable from participants and distributions) are charged directly to the participants' accounts.

**NOTE 3 – Estimates**

The presentation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**NOTE 4 – Information Certified by Trustee of the Plan**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, the Trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown on the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment activity and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information included in the footnotes and supplemental schedule of assets (held at end of year) as of December 31, 2024 and 2023.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**NOTE 5 – Fair Value Measurements**

The Plan has adopted the requirements of the Fair Value Measurements and Disclosure Topic of the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC). This Topic defines fair value and requires enhanced disclosure about assets and liabilities carried at fair value. These additional disclosures are required only for financial assets and liabilities measured at fair value and for nonfinancial assets and liabilities measured at fair value on a recurring basis. The Defined Contribution Pension Plans Topic of the FASB ASC exempts defined contribution plans from other requirements of this topic.

NOTES TO THE FINANCIAL STATEMENTS

December 31, 2024

(Continued)

**NOTE 5 – Fair Value Measurements (continued)**

This Topic requires that a fair value measurement reflect the assumptions market participants would use in pricing an asset or liability based on the best available information. These assumptions include risks inherent in a particular valuation technique (such as a pricing model) and the risks inherent in the inputs to the model. It also specifies that transaction costs should not be considered in the determination of fair value. According to this Topic, fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (exit price).

This Topic establishes a fair value hierarchy that prioritizes the inputs used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of the fair value hierarchy defined by this Topic are as follows:

Level 1 – Quoted prices are available in active markets for identical assets or liabilities as of the reporting date. Active markets are those in which transactions for the asset or liability occur in sufficient frequency and volume to provide pricing information on an ongoing basis.

Level 2 – Pricing inputs are observable, either directly or indirectly, but are not quoted prices included within Level 1. Level 2 includes those financial instruments that are valued using external inputs with models or other valuation methodologies.

Level 3 – Pricing inputs include significant inputs that are generally less observable from objective sources. These inputs may be used with internally developed methodologies that result in management's best estimate of fair value. Level 3 instruments include those that may be more structured or otherwise tailored to customers' needs.

As required by this Topic, financial assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

*Registered investment companies and interest bearing cash* – are valued at the closing price reported on the active market on which the individual securities are traded.

Financial assets valued using Level 1 inputs are based on unadjusted quoted market prices within active markets. There were no assets valued at fair value Level 2 or Level 3 inputs.

NOTE 6 – Notes Receivable from Participants

The Plan allows loans to participants based on their vested account balance. Participants may borrow from their fund accounts up to an aggregate maximum of \$50,000 or 50% of their vested account balance. Loans must be repaid within five years, unless the loan is used to acquire a principal residence, in which the maximum loan term amount is 10 years. Monthly installment payments through payroll deductions or level payments on at least a quarterly basis are required. A participant may only have two outstanding loans at any given time. Interest rates on loans outstanding at December 31, 2024, ranged from 4.25% - 9.50%. Loans are secured by the vested account balance of the participant.

**NOTE 7 – Investment Contract with Insurance Company**

In 2013, the Plan entered into a fully benefit-responsive investment contract with New York Life Insurance Company (“NYL”). NYL maintains the contributions in the Guaranteed Interest Account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by NYL. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuers or otherwise. Under the terms of the existing contract, the crediting interest rate is based on a formula agreed upon with the issuer. The crediting rate is currently reset on a six-month basis and will not be less than the guaranteed minimum interest rate of 1% or higher than 3%.

Certain events may limit the ability of the Plan to transact at contract value with NYL. Such events including, but not limited to, are total or partial plan termination, mergers, spin-offs, lay-offs, early retirement incentive programs, sales or closings of all or part of the Plan Sponsor’s operations, bankruptcy or receivership, and amendments to the plan document that could have an adverse financial, legal, or administrative impact. Upon occurrence of any of these events, a market value adjustment or other withdrawal restrictions may apply. The Plan sponsor may choose to pay the market value adjustment directly, if applicable, so that participants’ contract values are not affected. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan’s ability to transact at contract value with participants, is probable.

The contract may be terminated by the contract holder or New York Life Insurance Company as of any business day provided that 30 days written notice has been provided prior to the intended termination date. Effective February 25, 2025, the contract was terminated, with the book value of the investments to be paid in 6 annual installments over a 5-year period with the first installment being paid on the termination date and the following installments to be paid annually on the anniversary of the first installment. The fixed interest rate credited to the remaining Guaranteed Interest Account balance during the installment period is the effective annual interest rate in effect as of the date of termination minus 1.5%.

**NOTE 8 – Plan Termination**

Although they have not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

**NOTE 9 – Income Tax Status**

The Plan has adopted a non-standardized pre-approved profit-sharing plan with CODA, sponsored by FMR LLC. The Plan obtained a determination letter in June 2020 in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

In accordance with the guidance on accounting for uncertainty in income taxes, the Plan administrator evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure in or adjustment to the financial statements. The Plan is subject to routine audits by tax jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 10 – Separated Participants with Deferred Vested Benefits**

Included in net assets available for benefits are amounts due to participants who have withdrawn from the Plan but still have vested benefits in the Plan's net assets. For the Plan years ended December 31, 2024 and 2023, these benefits were \$20,203,573 and \$14,697,325 respectively.

**NOTE 11 – Related Party and Party-in-Interest Transactions**

Certain investment advisory fees were paid out of the Plan to Fidelity for fiduciary services. Fees paid to Fidelity Investment Institutional for recordkeeping services amounted to \$203,600 for the year ended December 31, 2024. Advisory fees paid to Fidelity Experts, LLC amounted to \$65,000, for the year ended December 31, 2024. These transactions qualify as party-in-interest transactions.

**NOTE 12 – Corrective Refunds Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as corrective refunds payable in the accompanying statements of net assets available for benefits. As of December 31, 2024 and 2023, corrective refunds payable was \$215,786 and \$225,025, respectively. Excess aggregate contributions were returned on January 23, 2025 and January 16, 2024 in order to comply with the actual deferral percentage (ADP) under Code Section 401(k) and the annual deferred limit under Code Section 402(g) for the 2024 and 2023 Plan years, respectively.

**NOTE 13 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Plan has a concentration of investments in T. Rowe Price Capital Appreciation Fund. A change in the value of the T. Rowe Price Capital Appreciation Fund could cause the value of the Plan's net assets available for benefits to change due to this concentration. In addition, as a result of funds being selected by participants, certain other funds may individually represent a concentration of greater than 10% of the Plan's investments, at fair value in the statements of net assets available for benefits. Although these individual funds maintain a level of diversification by investing in multiple equity, debt or other instruments, there may be a concentration of risk because the funds are invested at the direction of a single fund manager. At December 31, 2024, T. Rowe Price Capital Appreciation Fund individually represented greater than 10% of the Plan's investments, at fair value.
