NOTES TO THE FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Memphis Obstetrics & Gynecological Association, P.C. 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Document for more complete information.

General

The Plan is a defined contribution 401(k) retirement plan available to all employees of Memphis Obstetrics & Gynecological Association, P.C. (the “Company”) who are twenty-one (21) years of age or older and have completed twelve (12) consecutive months of service to qualify for employee deferrals, Company safe harbor contributions and discretionary profit-sharing contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Participants may elect to defer any percentage of their eligible annual compensation either as pre-tax 401(k) deferrals or Roth 401(k) deferrals, subject to Internal Revenue Service (IRS) limitations. Participants who have attained age fifty (50) before the end of the plan year are eligible to make catch-up contributions. The Company makes a safe harbor contribution equal to three percent (3%) of eligible compensation. The Company may also make discretionary profit-sharing contributions to the Plan in amounts determined by the Company. The Company made discretionary profit-sharing contributions of \$383,601 for 2024.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and allocations of (a) the Company’s contributions and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant’s account. Upon enrollment in the Plan, a participant may direct all contributions to any of the Plan’s fund options.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by the excess of the highest outstanding balance of the loans from the Plan to the Participant during the one-year period ending on the day before the date the loan is made or 50% of their account balance. The loans are secured by the balance in the participants account and bear interest at 1% above the prime rate. Principal and interest are paid ratably through payroll deductions.

Vesting

Participants are immediately vested in their voluntary contributions, rollover accounts, and safe harbor contributions, plus actual earnings thereon.

Vesting in the Company's profit-sharing contributions is based on years of service as follows:

Participants are 100% vested after normal retirement, death, disability, plan termination, or when normal retirement age of 65 is reached.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lumpsum amount equal to the value of the participant's vested interest in his or her account or annual installments over a period of time as defined in the plan document. For terminations of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. Withdrawals by a participant while employed are limited to those requested due to events of financial hardship as defined by the plan document or upon the attainment of age 59½.

Forfeitures

Forfeited non-vested accounts can be used first to reinstate participant account balances, then to reduce administrative expenses of the Plan, then any remaining forfeitures shall be applied to reduce future Company safe harbor matching or profit-sharing contributions as defined by the plan document. As of December 31, 2024 and 2023, there were no amounts in forfeited non-vested accounts, respectively.

Administrative Expenses

Certain expenses of the Plan are paid by the Company and are not included in the statements of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants and distributions to participants are charged directly to the respective participant's account. Certain investment related expenses are included in net appreciation of fair value of investments.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The financial statements of the Plan are prepared using the accrual method of accounting.

Investments are stated at fair market value (except for the fully benefit-responsive investment contract which is reported at contract value), as defined by generally accepted accounting principles. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as deemed loan distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Contributions receivable is recorded at the estimated net realizable value. An allowance for credit losses is recorded based upon management's estimate of expected credit losses, determined by using subsequent collections. Management has determined that an allowance for credit losses is not considered necessary as of December 31, 2024.

The Plan presents in the statement of changes in net assets available for benefits the net appreciation (depreciation) in the fair value of its investments, which consists of investment income, realized gains (losses), and the unrealized appreciation (depreciation) on investments.

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the period. Actual results could differ from those estimates.

Benefits are recorded when paid.

Date of Management's Review

The plan sponsor evaluated the Plan's December 31, 2024 financial statements for subsequent events through October 12, 2025, the date the financial statements were issued. The plan sponsor is not aware of any subsequent events which would require recognition or disclosure in the financial statements.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under generally accepted accounting principles are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the net asset value of shares held by the Plan at year end.

Self-directed accounts: Consists of common stocks, which are valued at the closing price reported on the active market on which the individual securities are traded.

NOTE 4 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan has a benefit-responsive guaranteed investment contract with Empower Annuity Insurance Company that maintains the contributions in a general account. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by the participants if they were to initiate permitted transactions under the terms of the Plan. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal interest at a specified interest rate that is guaranteed by the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0 percent. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory development.

Generally, there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or contract value paid overtime. There are no events that allow the issuer to terminate the contract and which require the plan sponsor to settle at an amount different than contract value paid either within 90 days or over time.

NOTE 5 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts and Plan assets will be used solely to provide benefits for participants.

NOTE 6 – RISKS AND UNCERTANTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statements of net assets available for benefits.

NOTE 7 – TAX STATUS

The IRS has determined that the volume submitter profit sharing plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC) and has stated such in a letter dated June 30, 2020. The plan administrator and the plan's tax counsel believe the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. The Plan administrator believes that the Plan has not generated any taxable income and no federal or state income tax returns have been filed. Federal and state taxing authorities could request an examination of the financial records of the Plan to ascertain if any such taxable income exists, but no such examination has occurred or is pending.
