INDEPENDENT AUDITORS' REPORT

To the Management of
Access XP Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying 2024 financial statements of Access XP Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The 2024 financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Access XP Retirement Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024, and for the year then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion for the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section—

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion for the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of Access XP Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Report on Compiled 2023 Financial Statement

Plan management is responsible for the accompanying financial statement of the Plan, which comprises the statement of net assets available for benefits as of December 31, 2023. We have performed a compilation engagement in accordance with Statements on Standards for Accounting and Review Services promulgated by the Accounting and Review Services Committee of the AICPA. We did not audit or review the financial statement nor were we required to perform any procedures to verify the accuracy or completeness of the information provided by Plan management. Accordingly, we do not express an opinion, a conclusion, nor provide any form of assurance on the financial statement.

Other Matter - 2024 Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule H, Line 4(i) - Schedule of Assets (Held at Year End) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. NOTE 1 – PLAN DESCRIPTION

The following description of Access XP Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a type of defined contribution plan adopted by Access XP, LLC (the "Company or "Employer") on September 4, 2013, which was restated on July 1, 2023 and August 20, 2024. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan's custodian is Capital Bank and Trust Company; the third-party administrator is Farmer & Betts, Inc.; the recordkeeper is American Funds Service Company; and the investment advisor is CDP Financial Group, LLC.

Participant Contributions

Participants may contribute, and therefore defer for income tax purposes, a portion of their annual compensation not to exceed the maximum contribution allowable under the Internal Revenue Code ("IRC"). The maximum annual contribution allowed by the Internal Revenue Service ("IRS") for each participant was \$23,000 in 2024 (\$30,500 for those attaining age 50 during the calendar year). Contributions are made through authorized payroll withholdings, subject to statutory limits, of up to 100% of compensation per pay period, as designated by each participant.

Rollover Contributions

The Plan allows for participants in a former employer's qualified plan to contribute direct rollovers to the Plan.

Employer Safe Harbor Matching Contributions

The Plan allows for the Employer to make safe harbor matching contributions. Participants are eligible to participate in safe harbor matching contributions after completing one year of eligible service of 1,000 hours. During the year ended December 31, 2024, the Employer contributed safe harbor matching contributions equal to one dollar for each dollar that a participant elected to defer, up to 4% of eligible compensation on a per pay period basis. Employer safe harbor matching contributions made to the Plan for the year ended December 31, 2024 totaled \$761,568.

Employer Discretionary and Matching Contributions

The Plan also allows for the Employer to make discretionary and matching contributions. The Employer can make a contribution based on discretionary percentage of each participant's annual compensation. Participants are eligible to participate in discretionary and matching contributions after completing one year of eligible service and are employed on the last day of the Plan year. There were no discretionary and matching contributions made to the Plan for the year ended December 31, 2024.

NOTE 1 – PLAN DESCRIPTION (CONTINUED)

Corrective Contribution

In 2024, the Company determined that certain employees did not receive timely notification of eligibility and therefore had a delayed Plan entry date. The Plan corrected the missed contributions by making a corrective contribution totaling \$7,952 as a qualified non-elective contribution (“QNEC”) in June 2024 and is included in employer contributions on the statement of changes in net assets.

Participant Accounts

Each participant’s account is credited with participant’s contributions, Employer contributions and allocations of Plan earnings or losses and charged with an allocation of administrative expenses. Allocations are based on participant earnings or losses or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants direct the investment of their contributions into various investment options offered by the Plan.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Participants are immediately 100% vested in all Employer matching contributions and safe harbor matching contributions. Vesting in the Employer’s discretionary contribution portion of their account is based on years of continuous service. The participant vesting schedule for the Employer’s discretionary contributions are as follows:

Participants become 100% vesting in Employer discretionary contributions upon reaching retirement age, death or disability.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years or up to 30 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. The interest rates on outstanding participant loans were 5.00% to 9.00% and 5.00% to 8.50% at December 31, 2024 and 2023, respectively. Principal and interest are paid ratably through payroll deductions.

NOTE 1 – PLAN DESCRIPTION (CONTINUED)

Payment of Benefits

Upon disability, retirement, termination, death, or hardship, participants may elect to receive a distribution of their account (as defined) in lump sum or defer distribution if the account exceeds \$5,000. However, if a participant's vested account balance is less than \$5,000, the Plan administrator may roll the balance into an individual retirement account, unless the participant elects otherwise. Also, at its discretion, the Plan administrator may elect to distribute vested account balances.

SECURE 2.0 Act of 2022

The Plan has implemented certain requirements of the SECURE 2.0 Act of 2022 ("SECURE 2.0"). The provisions implemented in 2024 include, among others, an increase in the required minimum distribution age from 72 to 73, reduced service requirements for long-term, part-time employees to participate in the plan, and remove the pre-death required minimum distribution requirement for Roth accounts. Future provisions will be adopted at later dates, as necessary, to comply with the requirements of SECURE 2.0.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Mutual funds are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends (if declared) are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold during the year as well as held at year end.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Payment of Benefits

Benefits are recorded when paid. As of December 31, 2024 and 2023, there were no benefit distributions payable.

Administrative Expenses

The Company pays expenses incurred for the administration and operation of the Plan. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Other administrative fees associated with distributions and loans are paid by the participants. For the year ended December 31, 2024, administrative expenses paid by the Plan were \$24,755.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses have been recorded. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

NOTE 3 – FAIR VALUE MEASUREMENTS

The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

- Level 1 - Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.
- Level 2 - Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:
 - Quoted prices for similar assets and liabilities in active markets.
 - Quoted prices for identical or similar assets or liabilities in markets that are not active.
 - Observable inputs other than quoted prices that are used in the valuation of the asset or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals).
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

NOTE 3 – FAIR VALUE MEASUREMENTS (CONTINUED)

- Level 3 - Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include managements own assumptions about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies and approaches used for assets measured at fair value. There have been no significant changes in methodologies used at December 31, 2024, as compared to December 31, 2023.

- Mutual Funds – The fair values of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement.

NOTE 4 – INFORMATION CERTIFIED BY THE CUSTODIAN

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulation for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, Capital Bank and Trust Company (the “Custodian”) has certified to the Plan administrator the completeness and accuracy of:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024;
- Net appreciation (depreciation) in fair value investments and dividend and interest income reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024; and
- Investments reflected on the supplemental schedule of assets (held at end of year).

NOTE 5 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. In the event the Plan is terminated, the participants’ account balances fully vest, and they would be distributed.

NOTE 6 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan’s Custodian, investment advisor (CDP Financial Group, LLC), recordkeeper (American Funds Service Company), and third-party administrator (Farmer & Betts, Inc.) are identified as parties-in-interest due to their relationship with the Plan and investments, and, therefore, these transactions qualify as party-in-interest transactions for which a statutory exemption exists. Fees paid to CDP Financial Group by the Plan were \$17,358 for the year ended December 31, 2024 and are included in administrative expenses.

NOTE 7 – RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 – TAX STATUS

The Plan utilizes a Non-Standardized Pre-Approved Profit-Sharing Plan of a third-party administrator. The third-party administrator obtained its latest advisory letter on June 30, 2020, in which the IRS stated that the document is designed and in compliance with the applicable requirements of the Code.

NOTE 8 – TAX STATUS (CONTINUED)

Although the document has been amended and restated since receiving this determination letter, the Plan administrator, the Plan's custodian and third-party administrator believe the Plan is designed and currently operating in compliance with the applicable requirements of the Code; and therefore, believe that the Plan is qualified and the related trust is tax-exempt. Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 9 – SUBSEQUENT EVENTS

The Plan was restated effective May 15, 2025. This restatement represents an amendment and restatement of the basic plan document previously executed by the Employer. Upon termination of employment, individuals with vested account balances of \$7,000 or less will be eligible to receive a distribution of their entire vested account. If the individual does not consent to the distribution, their vested benefit will be automatically rolled over to an IRA selected by the Plan Administrator. If an individual's total vested account balance exceeds \$7,000, no distribution will be made from the Plan without their consent.

The Plan administrator has evaluated subsequent events, as defined by Financial Accounting Standards Board Accounting Standards Codification 855, *Subsequent Events*, through the date the financial statements were available to be issued on October 10, 2025.



