Scope and nature of the ERISA Section 103(a)(3)(C) audit

We have performed audits of the financial statements of Hunterdon Healthcare 403(b) Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Hunterdon Healthcare 403(b) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 403(b) plan covering all eligible employees of the Hunterdon Healthcare System (the System), except certain nonresident aliens and enrolled students. Employees are auto enrolled into the Plan. Employees have 90 days to opt out of the Plan. Employees who have attained age 21 and have completed one year of service, except employees under a collective bargaining agreement and physician residents, are eligible for employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Finance and Investment Committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Board of Directors.

Contributions

Participants may contribute an amount up to 100% of eligible pay, subject to certain limits of the Internal Revenue Code (IRC). The Plan may also receive rollover contributions on behalf of a participant at the discretion of the administrator. The System will make a matching contribution in an amount equal to 50% of the first 4% of pay that is deferred to the Plan as long as the participant is employed on the last day of the plan year and has completed one year of service and at least 1,000 hours. The System will also make a nondiscretionary contribution at a percentage based on years of service as long as the participant is employed on the last day of the plan year and has completed one year of service and at least 1,000 hours. Participants direct all contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of the System's contributions, as well as allocations of plan earnings and administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the System's contribution portion of their accounts is 100% if the participant attains normal retirement age, incurs a disability while in the service of the System or dies while in service of the System. In all other situations, the System contributions are 100% vested upon completion of three years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. The maximum number of loans a participant may have outstanding at any one time is two. The notes are secured by the balance in the participant's vested account and bear a commercially reasonable interest rate established by the Plan administrator. The interest rates on outstanding notes ranged from 3.25% to 8.5% at December 31, 2024 and 2023. Terms range from one to five years or up to twenty-five years for the purchase of a primary residence.

Payment of Benefits

Upon termination of service, for any reason, a participant is eligible to receive a distribution of his or her vested account balance in the form of a lump sum distribution, an annuity or a combination of both. Vested account balances under \$5,000 are in the form of a lump sum distribution. The Plan also allows for the early withdrawal of the amounts credited to a participant's account when a participant attains the age of 59½, subject to certain limitations. Additionally, hardship withdrawals from fully vested accounts may also be granted to participants, as defined in the Plan document. Per IRS regulations, participants are required to take a minimum required distribution by April 1 of the year following the year they reach age 73.

Forfeited Accounts

When certain terminations in the Plan occur, the nonvested portion of the participant's account represents a forfeiture. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$35,241 and \$27,696, respectively. These accounts are to be used to reduce future system contributions and plan expenses. In 2024, \$35,241 was used to reduce the employer contribution receivable, which was paid in 2025 and in 2023, \$27,696 was used to reduce the employer contribution receivable, which was paid in 2024.

Plan Termination

Although it has not expressed any intent to do so, the System has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their System contributions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Finance & Investment Committee determines the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the System. Expenses that are paid by the System are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Payment of Benefits

Benefits are recorded when paid.

NOTE 3 - INFORMATION CERTIFIED BY CUSTODIAN

The Plan Sponsor has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Hand Benefits & Trust Company, the custodian, has certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment income and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent accountants obtained and read the certification, compared the certified investment information with the related information presented and disclosed in the financial statements, and read the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual funds: These assets are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate account: This is a stable value fund valued using net asset value. The net asset value for this fund is quoted in a private market, and is based on the fair value of the underlying assets owned, which is a diversified portfolio of fixed income securities (primarily intermediate-term bonds and commercial mortgages). These investments are redeemable at contract value under the fund's terms of operation. Generally, participants may not directly transfer amounts from this fund to a competing fund. A transfer out of this investment must be directed to and remain in a non-competing fund for a period of 90 days before it can be invested in a competing fund. Competing funds are generally short-term fixed income investments, money market fund or stable value investments that may be available in the Plan. There are no unfunded commitments.

Brokerage account: This asset category represents a separate brokerage account that permits participants to invest vested account balance in other investment options such as U.S. equities, ETFs, U.S. Treasury securities and mutual funds not offered by the Plan. The fair value of the investments (stocks, mutual funds, and interest-bearing accounts) is based on the closing price or NAV of shares held at year end.

Gains and losses (realized and unrealized) included in changes in net assets for the period above are reported in net appreciation in fair value of investments in the statement of changes in net assets available for benefits.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

NOTE 5 - RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS

Certain of the Plan's investments are managed by the custodian and, therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment manager services are included in net appreciation (depreciation) in fair value of the investments, as they are paid through revenue

sharing, rather than a direct payment. Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the System. No such officer or employee receives compensation from the Plan.

NOTE 6 - TAX STATUS

The underlying standardized prototype Plan has received an opinion letter from the IRS dated March 31, 2017 stating that the written form of the underlying prototype document is qualified under Section 403(b) of the Internal Revenue Code (the "Code"). Any employer adopting this form of the Plan is considered to have a plan qualified under Section 403(b) of the Code. Therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The Plan administrator believes the Plan, as amended, is being operated in compliance with the applicable requirements of the Code and therefore believes the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 - ADMINISTRATION OF PLAN ASSETS

The Plan's assets are administered under a contract with Hand Benefits & Trust Company, the custodian of the Plan. The custodian invests funds received from contributions, investment sales, interest and dividend income and makes distribution payments to participants.

NOTE 9 - SUBSEQUENT EVENTS

The Plan evaluated its December 31, 2024 financial statements for subsequent events through September 30, 2025, the date the financial statements were available to be issued. The Plan is not aware of any subsequent events which would require recognition or disclosure in the financial statements.
