## Independent Auditors' Report

To the Plan Administrator and Participants of the  
CAES 401(k) Plan  
Concord, California

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of the CAES 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years then ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists.

The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

***Other Matter – Supplemental Schedule Required by ERISA***

The supplemental schedule of assets (held at end of year) for the year ended December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

# CAES 401(k) Plan

## *Notes to Financial Statements*

### 1. Description of Plan

The following brief description of the CAES 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General**– The Plan, subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), is a pre-approved defined contribution plan sponsored by Cobham Benefits Holding, LLC (the “Plan Sponsor”), and covers substantially all employees of the Plan Sponsor’s participating business units who have attained the age of 18. In accordance with the Plan agreement, the following classes of employees are excluded from eligibility:

- Residents of Puerto Rico;
- Employees covered by a collective bargaining agreement;
- Leased employees; and
- Non-resident aliens.

The Basic Plan Document, Summary Plan Description and Adoption Agreement were restated effective January 1, 2023 primarily to include a change in Plan Sponsor from Cobham Advanced Electronic Solutions (“CAES”) to CAES Systems LLC (“CAES Systems”). In addition to the change in plan sponsor, the Plan was officially renamed CAES 401(k) Plan, effective January 1, 2023.

Effective April 3, 2023, several units within the Plan were divested and assets attributed to participating employees within these units were transferred out of the Plan. Participation of these units within the Plan ceased pursuant to the asset transfer. As a result of the sale and divestiture of these units, the Plan became a multiple employer plan for a portion of 2023.

Effective April 2, 2024, one unit within the Plan was sold and assets attributed to participating employees within the unit were transferred out of the Plan. Participation of the unit within the Plan ceased pursuant to the asset transfer.

Effective September 4, 2024, Honeywell International Inc. completed the acquisition of CAES System Holdings LLC. Prior to the transaction, sponsorship of the Plan was transferred from CAES System Holdings LLC to Cobham Benefits Holding LLC (the “Plan Sponsor”), a newly formed entity established to serve in this capacity. The Plan Sponsor appointed a formal committee with the authority to oversee the administration and operation of the Plan. Upon the closing of the sale, all other participating employers were removed from the Plan, with Cobham Satcom continuing as the sole participating employer.

## **CAES 401(k) Plan**

*Notes to Financial Statements (continued)*

### **1. Description of the Plan (continued)**

Effective February 6, 2025, the Basic Plan Document, Summary Plan Description, and Adoption Agreement were restated primarily to reflect the change in Plan Sponsor from CAES Systems LLC to Cobham Benefits Holding LLC. In connection with the restatement, the Plan was officially renamed the Cobham SeaTel 401(k) Plan, effective the same date.

**Contributions** – Participants may elect to contribute up to 85% of their annual compensation (as defined in the Plan) as pre-tax or Roth after-tax contributions, limited to the amount imposed by law. Additionally, participants age 50 or older may elect to make a catch-up contribution limited to the amount imposed by law. For the years ended December 31, 2024 and 2023, the participating business units matched 100% of pre-tax and Roth after-tax employee contributions up to the first 4% of a participant's eligible compensation, and 50% of pre-tax and Roth after-tax employee contributions up to the next 2% of eligible compensation. A participant is eligible to receive employer-matching contributions immediately upon hiring provided they have attained the age of 18. The participating business units are allowed to make additional discretionary contributions to the Plan. A participant is eligible to receive discretionary contributions if he or she is actively employed by any business unit of the Plan Sponsor on the last day of the Plan year. There were no discretionary contributions during the years ended December 31, 2024 and 2023.

**Vesting** – Effective January 1, 2019, generally all participants are immediately vested in employee and plan sponsor contributions, rollovers and actual earnings thereon. Employees of the Colorado Engineering, Inc. participating business unit who were terminated prior to April 4, 2022 and have not worked for the Plan Sponsor are subject to a special vesting schedule. Such employees vest in Plan Sponsor contributions and actual earnings thereon based on years of service. These participants are 20% vested after one of service and vest ratably at 20% per year thereafter. Accordingly, participants are fully vested in Plan Sponsor contributions after five years of service.

**Payment of Benefits** – Upon termination of service, death, disability or retirement, a participant may elect to receive a lump-sum distribution equal to the value of his or her vested account. The Plan permits in-service distributions for participants older than age 59½. Hardship withdrawals as defined by the Internal Revenue Code (the "Code") are available to participants only from the vested portion of their account and must be at least \$500.

A plan amendment was adopted effective March 28, 2022 to permit systematic and partial withdrawals of distributable vested interest in a participant's account balance.

## **CAES 401(k) Plan**

*Notes to Financial Statements (continued)*

### **1. Description of the Plan (continued)**

***Notes Receivable from Participants*** – In accordance with Plan provisions, participants are permitted to borrow a maximum amount equal to the lesser of \$50,000, reduced by the highest outstanding note during the one-year period ending on the day before the note is made, or 50% of their vested account balance. The notes are secured by the balance in the participant’s account and bear interest at a rate commensurate with rates available for similar notes from commercial lending institutions. Repayment terms may not exceed five years, with the exception of a note used to purchase a primary residence in which case the note must be payable within ten years from the date of the note.

Also, certain provisions of the Plan allow for the suspension of the repayment of a note in the event of certain military service which can extend the note term beyond the five- and ten-year maximums.

Principal and interest is paid ratably through each payroll deduction. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

***Transfers of Plan Assets*** – Effective December 30, 2023, one unit was merged into the Plan and became a participating employer in the Plan beginning January 1, 2024, with employees beginning participation in the Plan on this date. An aggregate of \$2,818 and \$25,533,888 were transferred into the Plan during the years ended December 31, 2024 and 2023, respectively.

Effective May 2, 2024, a unit within the Plan was divested, and the assets attributed to participating employees within this unit were transferred out of the Plan. Effective August 16, 2024, upon the closing of Honeywell International Inc.’s acquisition of CAES System Holdings LLC, all related units were divested, and the assets attributed to participating employees within these units were transferred out of the Plan. Effective April 3, 2023, several units within the Plan were divested, and the assets attributed to participating employees within these units were transferred out of the Plan. Aggregate transfers out of the Plan totaled \$5,802,754 and \$135,118,266 for the years ended December 31, 2024 and 2023, respectively.

***Income Taxes*** – The Plan Sponsor most recently obtained a letter dated June 30, 2020, in which the Internal Revenue Service (“IRS”) stated that the form of the pre-approved plan sponsored by Fidelity Management & Research Company (“Fidelity” or the “Trustee”) is qualified under Section 401(a) of the Code. The Plan Administrator believes that the Plan is operating in compliance with the requirements of the Code and, therefore, believes that the Plan is qualified and the related trust is tax exempt. Accordingly, no provision for income taxes has been included in the accompanying financial statements.

### *Notes to Financial Statements (continued)*

#### **1. Description of the Plan (continued)**

***Plan Termination*** – The Plan Sponsor has elected to terminate the Plan. In accordance with applicable provisions of the Internal Revenue Code and ERISA, all participants became fully vested in their account balances as of the termination date. The Plan will continue to operate solely for the purpose of winding up its affairs, including the liquidation of assets and distribution of benefits to participants and beneficiaries. See Note 2 for additional information.

#### **2. Summary of Significant Accounting Policies**

***Basis of Accounting*** – The accompanying financial statements are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

***Investment Valuation and Income Recognition*** – The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

The Plan presents in the accompanying statements of changes in net assets available for benefits the net appreciation (depreciation) in the fair value of its investments, which includes both realized gains (losses) and unrealized net appreciation (depreciation) in the fair value of investments. Realized gains (losses) on disposition of investments were based upon actual costs and selling prices.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

***Notes Receivable from Participants*** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. In the event of a default or death, the entire outstanding principal and accrued interest shall be immediately due and payable. Any unpaid balance will be deemed a taxable distribution from the Plan.

***Benefits Paid to Participants*** – Benefits are recorded when paid.

***Plan Expenses*** – Accounting and administrative expenses, as well as expenses relating to investment activity, are paid by the Plan. Each year, the Plan is awarded revenue credits payable to the Plan from the Trustee that can either be used for eligible Plan expenses or allocated to participant accounts. The Plan received credits as part of this program totaling \$262,500 and \$437,500 for the years ended December 31, 2024 and 2023, respectively. Administrative expenses (credits) in the accompanying financial statements are reduced by these amounts. Excess revenue sharing credits are returned to participants on a pro rata basis based on participant account holdings.

**2. Summary of Significant Accounting Policies (continued)**

***Party-in-Interest Transactions*** – Certain Plan investments are shares of mutual funds, common collective trusts and a money market account, managed by Fidelity. Fidelity is the Trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

***Risks and Uncertainties*** – Investments are exposed to various risks, such as interest rate and market risk. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amount reported in the accompanying financial statements.

***Use of Estimates*** – The preparation of financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Accordingly, actual results could differ from those estimates.

***Subsequent Events*** – The Plan Administrator has evaluated the effects of all subsequent events, for recognition or disclosure, through September 23, 2025, the date the accompanying financial statements were available to be issued.

On August 4, 2025, the Plan's sole participating employer, Cobham Satcom, was sold by Cobham Benefits Holding LLC to Solix Group, a Scandinavian investment firm. Following the sale, the Plan Sponsor will distribute all remaining assets and fully terminate the Plan. The Plan Sponsor expects that all assets will be distributed and the Plan will be fully terminated by the end of 2025.

**3. Information Certified by the Trustee (Unaudited)**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity has certified that the investments and participant loans included in the accompanying financial statements and related supplementary information is complete and accurate at December 31, 2024 and 2023, respectively. Fidelity also certified interest and dividend income totaling \$14,951,150 and \$14,697,289, interest on notes receivable from participants of \$380,273 and \$330,887 and net appreciation in fair value of investments of \$117,777,883 and \$124,692,801 for the years ended December 31, 2024 and 2023, respectively.

## CAES 401(k) Plan

### *Notes to Financial Statements (continued)*

#### 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure the fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- **Level 1** – Unadjusted quoted prices in active markets for identical, unrestricted assets or liabilities that are accessible at the measurement date.
- **Level 2** – Quoted prices for similar assets or liabilities in active markets or quoted prices for identical or similar assets or liabilities in markets that are not active. This level also includes inputs other than quoted prices that are observable, either directly or indirectly, for substantially the full term through corroboration with observable, independent market data. This includes investments valued at quoted prices adjusted for legal or contractual restrictions specific to the security. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- **Level 3** – Pricing inputs are unobservable for the asset or liability. That is, inputs that reflect the reporting entity's own assumptions about the assumptions that market participants would use in pricing the asset or liability. There were no assets of the Plan that were valued using Level 3 inputs at December 31, 2024 and 2023.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Money Market Funds:* Shares of money market funds are valued at amortized cost, which approximates fair value. The amortized cost of an instrument is determined by valuing it at its original cost and thereafter amortizing any discount or premium from its face value at a constant rate until maturity.

*Self-Directed Brokerage Accounts:* Accounts primarily consist of cash, common stock and mutual funds that are valued on the basis of readily determined market prices.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**4. Fair Value Measurements (continued)**

*Common and Collective Trusts (“CCTs”)*: CCTs are valued daily at net asset value based on the market value of the underlying assets. The underlying securities are listed on national securities exchanges and valued on the basis of year-end closing prices. The Plan has concluded that the net asset value as adjusted (for mutual fund dividends, mutual fund splits and administrative maintenance charges and other items) and reported by the insurance companies approximates fair value of the investments.

The investments are redeemable at the adjusted net asset value under agreements with the insurance companies. It is possible that the redemption rights may be restricted or eliminated in the future. Due to the nature of the investments, changes in market conditions, liquidity requirements and the economic environment may significantly affect the net asset value of the pooled separate accounts and, consequently, the fair value of the Plan investments.

We have audited the financial statements of CAES 401(k) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”) for the years ended December 31, 2024 and 2023, and have issued our report thereon dated September 23, 2025. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by Fidelity Management Trust Company, the trustee, which is a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, that prepared and certified the statements of information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements and ERISA-required supplemental schedule, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of generally accepted accounting principles (“U.S. GAAP”). Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP. Professional standards require that we provide you with information about our responsibilities under generally accepted auditing standards, as well as certain information related to the planned scope and timing of our audit. We have communicated such information in our engagement letter to you dated July 8, 2025. Professional standards also require that we communicate to you the following information related to our audit.

### **Significant Audit Matters**

#### ***Qualitative Aspects of Accounting Practices***

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Plan are described in Note 2 to the financial statements. No new accounting policies were adopted, and the application of existing policies was not changed during 2024. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. The financial statement disclosures are neutral, consistent and clear.

The financial statements include disclosure of a subsequent event related to the Plan sponsor's 2025 decision to terminate the Plan. We discussed with management the nature and timing of this event and evaluated the adequacy of the related disclosure in the 2024 financial statements.

### ***Form 5500 Procedures***

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

### ***Difficulties Encountered in Performing the Audit***

We encountered no significant difficulties in dealing with management in performing and completing our audits.

### ***Corrected and Uncorrected Misstatements***

Professional standards require us to accumulate all known and likely misstatements identified during the audit, other than those that are trivial, and communicate them to the appropriate level of management. The preparation of the Plan's financial statements was based on third-party recordkeeping statements and is deemed adequate for this Plan. There were no misstatements detected as a result of audit procedures that were material, either individually or in the aggregate, to the financial statements taken as a whole.

### ***Disagreements with Management***

For purposes of this letter, a disagreement with management is a financial accounting, reporting or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

### ***Management Representations***

We have requested certain representations from management that are included in the management representation letter dated September 23, 2025.

### ***Management Consultations with Other Independent Accountants***

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a “second opinion” on certain situations. If a consultation involves application of an accounting principle to the Plan’s financial statements or a determination of the type of auditor’s opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

### ***Other Audit Findings or Issues***

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan’s auditors. However, these discussions occurred in the normal course of our professional relationship, and our responses were not a condition to our retention.

### ***Other Matters***

Our responsibility for the ERISA-required supplemental schedule accompanying the financial statements is to perform adequate procedures to evaluate whether the form and content of the ERISA-required supplemental schedule, other than that agreed to or derived from the certified investment information, is presented in compliance with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA, and whether the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

This information is intended solely for the use of the Plan Administrator and management of the CAES 401(k) Plan and is not intended to be, and should not be, used by anyone other than these specified parties.
